Following my graduation from the Nashville School of Law in 2010, I returned to Jefferson County and began practicing law at Rainwater, Drinnon & Churchwell, PLLC in Dandridge, Tennessee where I continue to practice today. Rainwater, Drinnon & Churchwell, PLLC is successor to Rainwater & Rainwater, established and founded by the late Chester S. Rainwater, Sr. in 1933. I have been practicing at this firm with my brother, Larry R. Churchwell, II and S. Douglas Drinnon since becoming licensed in April 2011.

While living in Nashville, I worked full time and attended law school in the evenings. I was employed as a law clerk/court officer for the Fourth Circuit Court for Davidson County,

Tennessee from March 2008 – September 2009. I clerked for the Hon. Murial Robinson from March 2008 until March 2009 when she retired. Following the Governor's appointment of the late Hon. Phillip E. Smith, I continued in that clerkship for Judge Smith until September 2009. I was able to participate in and observe multiple bench trials and weekly motion hearings during those clerkships and observe those matters from the perspectives of the litigants, attorneys as well as the Court. I gained invaluable experience during my time there.

Prior to working for the Fourth Circuit Court, I was employed as an administrative assistant with the Comptroller of Treasury, State Board of Equalization in Nashville from March 2008 – March 2009. There, I assisted in reviewing statewide economic development contracts between local Industrial Development Boards and private entities and uploaded annual reporting data into a tracking database.

I worked for the Jefferson County Zoning Office from July 2004 – December 2006 as an Assistant Zoning Compliance Officer before moving to Nashville to attend law school. In that position, I worked with the public regarding the Jefferson County zoning resolution and subdivision development regulations. I assisted in reviewing subdivision plats, issued and maintained building permits, participated in regular monthly planning and county commission meetings and maintained monthly and quarterly financial reports for the office. I attended classes during the evenings and obtained my bachelor's degree from Tusculum University in December 2006 at the same time.

Immediately prior to that, I was employed as a Deputy Assessor with the Jefferson County Property Assessor's Office from July 2003 – July 2004 where I participated in the reappraisal of property valuation for Jefferson County, Tennessee. I conducted field reviews and measured new construction for tax records. I also assisted in performing sales analysis and determining values for residential and commercial properties and improvements and worked with taxpayers on a regular basis regarding property records and appraisal information. During this time, I also obtained a Tennessee Real Estate License in 2003 but did not end up pursuing that profession. I maintained that license in a retired status until I decided to attend law school and ultimately allowed it to expire.

From the time I graduated high school in 2000 through 2003, I worked in a manufacturing plant, Challenger, Inc. in Dandridge, Tennessee, while attending classes at Walters State Community College where I obtained my associates degree in 2003. While attending high school, I worked at Food City in White Pine, Tennessee in the evenings. I also worked for Joe Samples Well Drilling, Inc. during the summers and school breaks, and there was at least one summer that I worked for a local marina as well.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I would estimate approximately 35% of my current practice consists of domestic and family law matters, such as divorce, post-divorce, orders of protection, paternity, child support, grandparent visitation, conservatorship, and dependency and neglect issues. I would attribute another 35% of my current practice to general civil litigation. Approximately 20% of my practice consists of criminal defense work, and 10% to business and transactional matters, and probate and estate matters.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My experience consists of a diverse general practice ranging from business and transactional matters to litigation on behalf of entities and individuals in civil and criminal matters before the Circuit, Chancery, General Sessions, Juvenile and Probate Courts throughout East Tennessee, but primarily within the Fourth Judicial District. I have represented hundreds of clients in a range of legal matters over the last thirteen years, but my primary practice areas of litigation have included family law and related matters, orders of protection, juvenile dependency and neglect, grandparent visitation, real estate and land use disputes, landlord/tenant issues, criminal defense, probate and estate, guardianship/conservatorship, personal injury and general civil litigation.

Early in my career, I represented many indigent clients through court appointment, charged with misdemeanor and felony criminal offenses in the General Sessions and/or Circuit Court, as well as many others facing the loss of custody of their children through Juvenile Court proceedings. I represented several others by appointment against criminal and/or civil contempt actions brought against them in the Circuit and Chancery Courts. I have served as Guardian Ad Litem for multiple children in various Juvenile Court actions, as well as minors in Guardianship matters and alleged disabled individuals in Conservatorship matters during my practice.

Over the years of my practice, I have represented clients in bench trials before each of the four Circuit Court Judges in the 4<sup>th</sup> Judicial District, as well as before the Chancery Court. I have represented numerous other clients in hearings before the General Sessions and Juvenile Courts throughout the 4<sup>th</sup> Judicial District and have participated in countless mediations achieving settlements for clients over the course of my practice.

I have prepared, briefed and argued before the Tennessee Court of Appeals. I have also been engaged by other members of the local bar to assist in the preparation of legal memorandums and appellant briefs, as well as to prepare numerous Qualified Domestic Relations Orders relative to the division of retirement plans in divorce actions over the years. I am currently representing two clients in matters before the Department of Children's Services Due Process Procedures appellant process. I have also represented clients regarding matters before the Tennessee Department of Safety and Homeland Security regarding drivers license reinstatement

and vehicle seizure.

Additionally, Rainwater, Drinnon & Churchwell, PLLC serves as general counsel for Jefferson County, Tennessee, the City of New Market, Tennessee, the Town of Bean Station, Tennessee, the Town of White Pine, Tennessee, and the City of Baneberry, Tennessee. The firm further serves as general counsel for Appalachian Electric Cooperative, Witt Utility District, Shady Grove Utility District and Tiger Haven, Inc. My experience includes assisting in the representation of those governmental entities and municipalities over the years of my practice. I have attended multiple city council meetings and county planning commission/board of zoning appeals meetings as counsel. I have represented Jefferson County in lawsuits before the Circuit Court relative to zoning and land use violations and have dealt with various department heads regarding legal issues throughout my practice. I also routinely represent clients in business and transactional matters as well as estate planning issues, and the preparation of contracts, leases, liens, deeds and prenuptial agreements.

During my thirteen years of practicing law, I have responded to two complaints from the Board of Professional Responsibility. Both complaints were filed by former domestic relations clients. One was filed in 2014 and the other was filed in early 2022, well over a year following the entry of an Order permitting my withdrawal in the matter. Both complaints were dismissed following my response and investigation by the Board of Professional Responsibility.

Yes, I participated in a legal proceeding filed on December 19, 2019 styled: *Katheryn Lamb v. Jeremy Churchwell*; Jefferson County Circuit Court, No. 26210-I. This was a civil action filed against me regarding an automobile accident I was involved in on December 28, 2018 in Jefferson County, Tennessee. Liability and damages were contested from the outset. My insurance company and assigned defense counsel elected to file a counter-complaint against the Plaintiff for damages relative to the loss of my vehicle. Following the presiding judge's recusal and the reassignment to a new judge, the matter was scheduled for trial by jury to occur on February 15, 2023. Approximately three weeks prior to the scheduled trial date, the matter was voluntarily dismissed with prejudice.

I am seeking this position because I enjoy working with the public and know that I have the intellectual and professional ability, integrity, work ethic and temperament to faithfully fulfill the duties of the position in an impartial manner. I was born and raised in Jefferson County and am raising my own four children here with no intention of ever leaving. I have been blessed by the support and trust of many residents in the Fourth Judicial District throughout my career and have a deep sense of duty to my community and commitment to justice. If selected, I will ensure that all litigants coming before the court receive a fair shake and equal unbiased access to justice under the law.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking appointment to the new judicial position of Fourth Judicial District Circuit Judge, Part V as created by Public Chapter No. 977. The Fourth Judicial District includes Cocke, Grainger, Jefferson and Sevier Counties and has historically been served by one Chancellor and four Circuit Court Judges prior to the creation of this position. Our Circuit Judges hear non-jury and jury civil and criminal causes of action, including appeals from General Sessions and Juvenile actions. It is my understanding that the presiding Circuit Court Judges in the Fourth Judicial District have entered an Order designating this new position to hear civil matters only. I believe I am equipped with the experience and abilities to transition into this position smoothly. If selected, I will ensure that all parties before the court receive equal and impartial access to justice and are treated with respect and dignity.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law. The role of a Circuit Judge is to hear the facts and apply the law as written and intended by the General Assembly with guidance by interpretations set forth by the Appellant Courts. I imagine most litigators have faced scenarios during their practice where they have represented a client pursuant to the law even though it did not conform to their personal beliefs or sense of justice. I personally disagree that individuals who have been wronged in property tort actions are unable to recover their legal expenses. For example, I have had many clients who have sustained damages relative to real or personal property where the liability of the tortfeasor is clear. Sure, they can file a lawsuit and recover for their proven compensatory damages, but they cannot be made whole under the law. Those individuals, through no fault of their own, are forced to incur attorney's fees and expenses to litigate their claim but are unable to recover those expenses under the law, resulting in additional financial loss to them. This is particularly difficult in situations where indigent individuals lack financial resources to engage counsel to pursue their claims, which results in compromised or abandoned claims when liability is clear. Despite my personal disagreement in this regard, if selected, I would certainly uphold and enforce the provisions of the law as written.
