Title IV-D attorney for the Knox County Child support Office. I worked as the state attorney of the Child Support Office in Knox County. This required case management and managing the case dockets for the court.

#### October 2013 to July 2022

In May of 2013, I graduated from Duncan School of Law, Lincoln Memorial University with my Juris Doctorate. I successfully completed the bar exam in July of 2013. I have been self-employed the majority of that time. Shortly before my graduation my husband and I purchased a small house on the main highway in Blaine where we live, and we remodeled it for my office. My first experience as an attorney was in the criminal law area of the 4<sup>th</sup> 6<sup>th</sup> and 8<sup>th</sup> Districts. During the past ten years, my practice has expanded from the criminal court into the civil court arena. Currently, I have many criminal cases as well as several civil cases. My civil practice includes divorces, contract disputes, and personal injury, wills, and probate issues. I thoroughly enjoy the wide variety of cases that I am able to participate in as a self-employed practitioner. For a short time, from July 2022 to April 2023, I worked as a State of Tennessee Title IV-D attorney in the Knox County Child Support Office.

In addition my husband and I owned and operated a private trucking business from 2013 to 2023. The business was R&R Transfer Services, Inc. We owned and operated two trucks and two trailers. We closed this business in July of 2023.

Upon graduation, I began working as a court reporter and continued this work until I entered law school in 2010. While court reporting, for approximately 17 years, I worked in many different courts in the east Tennessee area. As a court reporter, you are exposed to a wide variety of law topics ranging from family law, civil litigation, and criminal law. During this time, I also worked in Monroe County Florida for approximately three years.

This covers the previous 25 years. Prior to this, I worked in several small jobs as office assistant, receptionist, or waitress. I cannot recall the details of these different employments at this time.

My practice consists of various types of cases. Currently, the majority of my cases are in the area of criminal law, approximately 75%. I have family law cases, including divorce, adoption, wills, and probate matters, approximately 15%. The remaining 10% of my cases would be personal injury, social security filings, and general civil litigation.

At this point, the majority of my experience as a licensed attorney is in the trial court arena. In the State Court of Knox County I have conducted jury trials defendants in rape cases, drug conspiracy cases, attempted murder cases and many other types of criminal cases. I have been admitted to the Federal District Court of the Eastern District of Tennessee as well.

I would highlight as a special note, that I love all areas of my practice. In particular, in my criminal law cases, I devote a lot of time to helping and assisting my criminal clients with rehabilitation services, such as employment, treatment programs, and counselling for becoming a productive member of society.

I support the Drug Court Programs 100% and work very hard to assist my clients with substance abuse issues.

Further, I work with the district attorneys and many governmental / medical programs to assist my clients who have mental health issues to get them an established support system and accepted into treatment programs.

With regard to my civil cases, I would highlight the fact that I work hard to achieve an outcome for their cases which is fair under the law and that is satisfying to them.

My legal experience began in 1992 when I began working as a court reporter. I knew then that I would one day become an attorney. Shortly after beginning work as an attorney, I knew I would one day be a judge. I know this is what I am meant to do.

For seventeen years, my experience as a court reporter exposed me to many different areas of law. Listening to the many arguments of counsel and rulings of judges was a very valuable education. Now working as an attorney, I utilized the knowledge I have gained over the past twenty years to make my practice of law a successful career.

For example, the 2014 law which made it a crime to expose unborn children to drugs is not something I necessarily agree with because I believe this law causes mothers to fear punishment and disregard the welfare of their unborn child. However, it is the current state of the law and must be followed unless and until it is changed.

I do agree with the recent change in the theft statute. Increasing the misdemeanor theft limit from \$500.00 to \$1,000.00 brings the theft statute in line with the value of goods available in the market place. It reduces the number of felony charges in the court system which will decrease jail and prison populations, and reduce the impact on judicial and court resources.

These areas of law are huge social issues. The drug law for expectant mothers dramatically affected the innocent lives of the babies. The increase in the misdemeanor theft amount will decrease the burden on tax payer funds used to prosecute felony thefts. The extra funds could be distributed to other areas of society, such as infrastructure and education.

As a judge, I would not punish a person with anything more than the law allows. A judge should not overstep their authority, and they must be fair and impartial.
