I have been exclusively employed at Johnson, Murrell & Associates, P.C. the entirety of my legal career. Previously, I was employed for two summers by the Boy Scouts of America at Philmont Scout Ranch in Cimarron, New Mexico as a seasonal backpacking guide and later as a program counselor at the Kit Carson Museum. I was also employed by Oak Haven Resort in Sevierville, Tennessee for several summers. While there, I worked in maintenance, grounds keeping, front desk reception, and assisted in the installation of gas, sewer, water, and fiber network lines. I also worked one summer at Johnston & Murphy shoe store in Sevierville, Tennessee.

I maintain a general law practice in a small firm of four attorneys. My practice consists of the following primary areas of law:

Civil Litigation 30%, Probate / Estate Administration 38%, Estate Planning 17%, Business / Corporate Law 5%, Real Estate / Other 10%

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I primarily practice in sessions, circuit, and chancery courts across the Fourth Judicial District since I began practicing law in 2007. I have argued cases before the Court of Appeals (Eastern Section). I have experience appearing in the U.S. District Court for the Eastern District of Tennessee and the U.S. Bankruptcy Court for the Eastern District of Tennessee.

My civil litigation background includes a wide array of cases, including but not limited to, business litigation, contract dispute, divorce, real estate litigation, i.e. boundary line disputes and adverse possession cases, as well as cases involving damages, tort, evictions, and will contests.

In my 17 years of practice I believe I have earned a reputation as a fair, transparent, persistent, attorney that deals with clients and other attorneys with honesty and integrity. I have trial experience in sessions, circuit, and chancery courts in various areas of law. I pride myself on my preparation and knowing the facts of my case and the applicable law. This requires dedication, focus, and, most importantly, the willingness to work long hours.

I also have a background in business and real estate transactional work. I have enjoyed facilitating the purchase of a new home, opening of a new business, and the establishment of non-profits and applications for 501(c)3 designations, among other areas.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Several years ago the Sevier County Bar Association hosted a CLE on order of protections and requested volunteers due to the large number of pro se filings and the statutory requirement that order of protection hearings be held within 15 days. Our Courts were overwhelmed. As a result, over the past several years I have volunteered multiple times on order of protection day and represented petitioners and respondents in these actions. I had never represented a client in an order of protection prior to volunteering.

Unfortunately, for many people experiencing trauma such as is often involved in an order of

protection, appearing in Court pro se adds to their anxiety and fear. Their lack of understanding of the process can leave them disillusioned if they are not granted the relief they are seeking whether they be the petitioner or the respondent. Listening to these parties and advising them of their rights and their options (even when telling them they do not meet the requirements to obtain an order of protection) and seeing the anxiety dissipate when we are able to reach a resolution that is tailored to their needs, has been one of the most rewarding experiences in my practice of law.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

Another recent case of note for me personally began as a divorce with children with no unique circumstances. Unfortunately, tensions escalated resulting in the unilateral removal of the children out of state by the mother and criminal charges against my client when he attempted to see his children. Consequently, my representation involved coordination with an out of state criminal attorney and joint hearings between the local Circuit Court judge and the out of state judge whom had granted emergency custody to the mother. Both parents were focusing on "winning" to the detriment of their children. Both parties wanted a trial as soon as possible.

Fortunately, the trial court entered a temporary parenting plan and ordered the parties to mediation before a full trial. Through that process my client was reunited with his young children. He recently updated me and said the turmoil has subsided, he has a new job, a new church, and his children are enjoying school.

This case is not reported. Had this case gone to trial, the Court would not have been able to formulate the parenting plan the parties agreed to in mediation. However, to me, this is an example of our judicial system at its best in dealing with life-changing issues for these parties, but most importantly, for their children.

A formal complaint was filed circa. 2009 by an opposing party in litigation involving an easement for a septic line. She alleged that my representation was an effort to hide that my law firm failed to discover the septic line easement when conducting a title search. My law firm had not done the title work on the property. The Board of Professional Responsibility dismissed the complaint.

A formal complaint was filed in 2023 by an opposing party involved in three separate cases against my client. The opposing party had also brought criminal indictments against my client before the grand jury. At some points in the civil litigation the opposing party was represented, at other points he was appearing pro se. I never received a copy of the complaint filed against me and I do not know what was alleged. Therefore, I never made a formal response. Rather, I learned about the complaint when I received a letter from the Board of Professional Responsibility stating that the complaint was dismissed.

Initiated an eviction proceeding in Sevier County General Sessions Court, Alex Johnson v Jesse Mowls and Autumn Flanigan, Case 19-C-96711, in 2019 against a tenant and obtained possession and a judgment.

In 2015 a lawsuit was filed in the Circuit Court for Sevier County, Tennessee, Case No. 15-CV-813-III, Walter F. Benson Properties v McCarter Auction, Inc., R. Alexander Johnson, and Johnson, Murrell & Associates, P.C. The plaintiff sold property at auction and my firm handled the closing of the sale. A holder of an option to purchase said property sued the sellers who in turn sued the auction company, myself, and my firm. Prior to a hearing on a motion to dismiss filed on my behalf the plaintiffs voluntarily dismissed their case. There was no settlement and no re-filing of the matter.

In 2021 my divorce was filed and finalized in Knox County Chancery Court Case No. 210720-2, Richard Alexander Johnson v Sheena Renee Johnson.

28. What are your reasons for seeking this position? (150 words or less)

I am seeking this position because I believe I have the unique qualifications, experience, and character required to serve as a Circuit Court judge. A capable, consistent, and efficient application of the rule of law is the foundation for preserving the rule of law. My parents instilled in me the lesson that one cannot take things for granted in life. They taught me that we all must do our part and get involved and help where you can help. Practicing law has always been an opportunity to help others through difficult and/or confusing times in their lives. Serving as a Circuit Court judge will allow me to continue to serve my community and it is my desire to maintain trust and confidence in the judiciary.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

The 4th Judicial District has 4 Circuit judges serving Sevier, Cocke, Jefferson, and Grainger Counties. Approximately 3000 civil cases and 7000 criminal cases are filed each year. Circuit judges hear both criminal and civil cases; however, I understand the new seat will only handle civil cases. I estimate I have handled over a thousand civil cases in a variety of legal areas. I have trial experience in several courts before a number of different judges. This has provided me a wealth of experience and positioned me to begin the work on day one. Specifically, Orders of Protection make up approximately 25% of all civil cases in the 4th district and approximately 75% of all trials. I have been a pro bono volunteer at the order of protection docket days for a number of years representing petitioners and respondents and I am uniquely prepared in this area as a result.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. *(250 words or less)*

Yes, I will uphold the law even when I disagree with the substance of the law. The law often requires me to tell a client that while I sympathize with their problem, the law does not give them the relief they seek. For example, in order of protection of court, when serving as a volunteer I often represent persons who are truly fearful of the other party, but they do not qualify under the order of protection statutes for the relief they seek. In those situations you try to guide the client to other options. In probate matters it is a common misconception that when a spouse dies their assets all pass the surviving spouse; however, if the decedent had children and there is no Will, the children also are entitled to a share. This can cause family acrimony especially when an estranged family member or step-children are entitled to a share of the family home and want to sell it. I do not like the effect of the law in these instances, but you do your client no favors ignoring or trying to subvert the law or filing a frivolous lawsuit. Rather, you must be forthright and have that difficult conversation with your client. This, in my opinion, is a hallmark of a good lawyer.
