SEAL


COMES NOW, the State of Tennessee, and Petitioner Zachary Rye Adams ("Petitioner

subject to the Tennessee Public Records Act, T.C.A. 10-7-501, et. seq.


4. Nothing herein shall create prejudice or presumption to either party on any issue beyond which is contained in this Joint Motion.


