PLAINTIFF-APPELLANT'S EMERGENCY MOTION FOR A STAY OF EXECUTION

Plaintiff-Appellant, Cecil C. Johnson, Jr., hereby moves the Court under Rules 8, 21, and 27, Fed. R. App. P., Sixth Circuit Rule 27, and the All Writs Act, 28 U.S.C. § 1651(a), to enter an Order staying his execution, which is currently scheduled to take place at 1:00 a.m. CST on December 2, 2009. He also seeks an Order transferring this case back to the District Court under 28 U.S.C. § 1631. A copy of the District Court filings required by Sixth Circuit Rule 27(c) is attached. A Memorandum of Law in support of the Motion will be forthcoming shortly. Briefly stated, Plaintiff-Appellant submits that the Court should grant a stay so that it can consider in an orderly fashion whether the District Court erred in its determination that Plaintiff-Appellant's claim should be characterized as a "second or successive" habeas corpus petition rather than a claim under 42 U.S.C. § 1983 (or alternatively, as a habeas petition that is simply not "second or successive" within the meaning of 28 U.S.C. § 2244(b)(2)). Should this Court determine that Mr. Johnson has not submitted a "second or successive" application, it should transfer the case back to the District Court, but the point will become moot if Mr. Johnson's execution is allowed to go forward.
