1. I am an adult resident citizen of Davidson County, Tennessee. I make the following affirmations based on personal knowledge.

2. On or around November 8, 1999, I traveled to the office of Pam Hobbins, Public Affairs Officer for the Tennessee Department of Correction. Ms. Hobbins showed me a Log Book which records events surrounding the disposition of death sentences during the period 1916 to 1979. Ms. Hobbins said that because of the age of the Log Book and its resulting frailty, I could not make photocopies of entries made in it. As a result, I dictated the contents of the Log Book into a tape recorder that I took with me.

3. A review of my dictation reflects that during the period 1935 to 1958, Tennessee's Governor commuted twenty death sentences. Nine of these commutations occurred on recommendation of the Tennessee Supreme Court.

4. A review of my dictation reflects that on June 24, 1950, the Governor commuted the death sentence of Arthur L. Bass.




Affiant Jefferson Dorsey affirms as follows:
