Mrs. Owen is a 33 year old white female seen for consulting and insanity evaluation. She was oriented with good memory at the time of the evaluation. She was cooperative with the evaluation. There was no evidence of thought disorder, suicidal, homicidal or paranoid ideation. Mrs. Owen had appeared distressed and depressed during the evaluation. She cried during the evaluation and was sobbing and wiping her hands.

Mrs. Owen stated that she has had two years of college and previously worked in a doctor's office. She reported that she saw a psychiatrist about eight years ago for only one visit. She denies any alcohol or drug abuse.

Mrs. Owen is charged with accessory before the fact in the murder of her husband. On Motory Intent

Advised her verbally, had appeared
and humiliated her severely.

Mrs. Brown was reluctant to
develop further information before
confering with her lawyer. Therefore
further information concerning her
mental state was not obtained
and an opinion ^{as to} the current
defence cannot be given at this
time.
