MOTION TO SET EXECUTION DATE

Gaile K. Owens was convicted in 1986 by a Shelby County Criminal Court jury of accessory before the fact to first-degree murder and sentenced to death.¹ Owens has completed the standard three-tier appeals process described in Tenn. Sup. Ct. R. 12.4(A) by "pursu[ing] at least one unsuccessful challenge to [her] conviction and sentence through direct appeal, state post-conviction, and federal habeas corpus proceedings": *State v. Porterfield*, 746 S.W.2d 441 (Tenn. 1988) (direct appeal); *Owens v. State*, 13 S.W.3d 742 (Tenn. Crim. App. 1999), *app. denied* (Tenn. Feb. 28, 2000), *cert. denied*, 531 U.S. 846 (2000) (post-conviction appeal); *Owens v. Guida*, 549 F.3d 399 (6th Cir. 2008), *cert. denied*, _____ U.S. ____, 130 S. Ct. 281 (2009), *reh'g denied*, _____ U.S. ____, 2009 WL 4111116 (U.S. Nov. 30, 2009) (see attached) (federal habeas corpus).

¹ Owens was jointly tried with Sidney Porterfield, who was convicted of first-degree murder and also sentenced to death.

Because Owens has completed the standard three-tier appeals process, it is now the duty of the state attorney general to file a motion requesting this Court to set an execution date. Tenn. Sup. Ct. R. 12.4(A). Therefore, the State of Tennessee, by and through the Attorney General and Reporter, hereby requests this Court to set an execution date for Gaile K. Owens, which date shall be, in accordance with Tenn. Sup. Ct. R. 12.4(E), no less than thirty (30) days from the date of the order granting this motion.
