I completed my legal education in 1998 at the Nashville School of Law.

During my first through third year of law school I worked at the Metro Legal Department in Nashville. While my general job assignment was as a runner for the department, I would, on occasion, be called upon to do some legal research. The research included issues involving one or more of the departments within the Metropolitan Nashville government and was performed under the supervision of one of the staff attorneys. The experience I gained was invaluable and touched on a wide array of areas of the law including civil rights violations, contract negotiations, back property tax enforcement, and issues with bills before the metropolitan counsel.

In May of 1997, at the end of my third year of law school, I was hired by the Honorable Cheryl Blackburn, Criminal Court Judge of Division III, 20th Judicial District, as her law clerk. Prior to this my experience with the legal system included the issues mentioned above at the Metro Legal Department. During the three and one half years with Judge Blackburn my legal experience was solely in the area of criminal procedure and substantive criminal law.

As Judge Blackburn's law clerk I assisted her in drafting memoranda of law, performing legal research, compiling jury charges, taking notes during motion hearings and trials, and any number of other related tasks. My primary areas including assisting in the drafting of memoranda of law in the areas of post-conviction relief, writs of *habeas corpus*, and motions to suppress evidence.

The experience of being closely involved in the day-to-day operation of a judicial office was very rewarding. Likewise, the opportunity to watch up close the process that Judge Blackburn took in deciding important issues, many of which affected lives for years to come, gave me an insight into the importance of preparation, discretion, and following the law.

On September 1, 2000, I opened a solo law practice in the Washington Square office building in Nashville in a suite that was known to local lawyers as the "incubator." The start of my private practice began by taking appointed cases in the Davidson County General Sessions Courts and in the Davidson County Criminal Court. I also was appointed as guardian ad litem on various conservatorship cases out of the Davidson County Probate Court. My practice evolved into a general practice where I took cases involving domestic relations, criminal defense, estate planning, and personal injury.

In April of 2003 I took on a partner, Eric Cartee, and we opened an office in Nashville doing business under the firm name Tidwell Cartee. We practiced as a true partnership where I focused on criminal defense and he focused on personal injury. It was during the years of 2003 and 2004 that two events occurred that changed my practice.

 I was admitted to the Criminal Justice Act (CJA) panel of lawyers for the Middle District of Tennessee. This "panel" of lawyers is limited to lawyers who have second chaired a number of federal criminal defense cases and then placed on the first-chair panel of lawyers allowed to accept appointed cases in the Middle District of Tennessee Federal Court. Since 2003 I have either been appointed to, or been retained to represent, forty-eight (48) clients in the United States District Court for the Middle District of Tennessee. I have additionally represented several clients in the Eastern District of Tennessee. 2. In 2003 I took on a client that had been civilly sued by DirecTV, Inc. for the alleged surreptitious interception of DirecTV satellite signals. One client led to another and within a few years I had represented well over one-hundred (100) individuals who had either been sued in the Western, Middle, or Eastern District of Tennessee or who had been threatened with a lawsuit by counsel for DirecTV.

The volume of these lawsuits required focused organization in that at any given time the cases would be in different stages of litigation. The experience I gained in the area of civil litigation was invaluable. The issues presented in these lawsuits were complex and at one point resulted in my assisting other attorneys in the Eleventh Circuit with researching and preparing for an appeal that ultimately was argued in the Eleventh Circuit Court of Appeals sitting in Miami, Florida. The appeal was decided in our favor. I did not argue the case but was present for the argument and provided support for the lawyers who argued.

In April of 2006 I moved my office from Nashville to Murfreesboro and joined John Price in creating my current firm, Price & Tidwell. My practice since 2006 has included criminal cases in both federal and state courts, personal injury cases, domestic relation cases, and general civil matters.

I have appeared in every court in the 16th judicial district and the Western, Middle and Eastern District Courts of Tennessee at one time or another and have taken a wide variety of cases. I have also appeared via pleadings in the Sixth Circuit Court of Appeals and the Tennessee Court of Criminal Appeals.

I have been continuously employed since the completion of my legal education.

My current practice consists primarily of criminal defense work in both state and federal court. I estimate that these areas of practice make up 70% of my practice. The remaining 30% is split between domestic relations, personal injury cases, and other general civil cases. Because I am in a small firm I am faced regularly with new cases in all areas of practice. Those cases that I cannot personally take due to my caseload I refer to an associate within my office, D. Lyn Graves, or to my partner, John Price.

Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters. I have enjoyed a diversified career to date that has touched upon a variety of areas of practice. During much of my law school days I was employed by the Metro Legal Department. Although much of my work was as a runner, I gained insight into the workings of the Metro Nashville government and the legal issues that faced the Metro departments. On several occasions I was called upon to do legal research and I often had discussion with the staff attorneys concerning issues they were facing. I also observed court appearances from time to time, as cases would go to trial.

My exposure to criminal law began with my clerkship with Judge Cheryl Blackburn in Davidson County. As a law clerk I observed approximately ninety-(90) trials and many motions to suppress and post-conviction petition hearings in the three and one half years I was Judge Blackburn's law clerk. I also helped the Court put together the jury charge on many occasions. Along with the court officers I assisted with the jury during trials and interacted with the lawyers who practiced in her court. I also was fortunate enough to be able to interact with the court clerks, and the court officers and law clerks of the other judges in the 20th Judicial District.

During my years in private practice I have represented many clients charged with criminal

offenses. These matters have included charges from misdemeanors to Capital Murder. I have tried approximately thirty cases in state and federal courts including five (5) first-degree murder cases. The last murder trial I tried was in Rutherford County in 2010 and involved the State of Tennessee giving notice of the intent to seek death as a punishment. I have also been involved in the appeal of multiple cases in the state and federal system.

My civil practice began in earnest with the DirecTV litigation in 2003. The three (3) years of this litigation I was personally responsible for the 100 plus cases, all in various stages of litigation. I prepared discovery, took depositions, and prepared my client for discovery related issues and depositions. I have also represented numerous clients in divorce/child custody cases as well as numerous clients who have been injured either due to a car accident or slip and fall.

Early in my private practice I was appointed as *guardian ad litem* in multiple conservatorship cases by the Davidson County Probate Court. I have, likewise, represented proposed conservators later in my practice.

9. Also separately describe any matters of special note in trial courts, appellate courts, and administrative bodies.

In *State of Tennessee v. Eric D. White*, CCA No. M2001-02731-CCA-R3-CD I received a reversal of a conviction based upon sufficiency of evidence after a jury trial that I tried for Mr. White. Based upon the Appellate Court's findings the case was reversed and dismissed.

I was a law clerk for Judge Blackburn during two separate capital murder trials in involving Paul Dennis Reid. (See Davidson County Case Nos. 97-C-1834 and 97-C-1836) Although Judge Blackburn was assisted by a capital case attorney from the Administrative Office of the Court during these cases, I was involved in most discussions concerning rulings in the case and became very well versed in the case law concerning evidentiary issues that arose during the two death penalty trials.

DirecTV v. multiple clients. As stated above, over a three year period (2003-2006) I represented well over 100 clients who had either been sued by DirecTV for unauthorized interception of DirecTV's satellite signals or who had received letters threatening a lawsuit for the same activities.

State of Tennessee v. Antonio Alexander, Rutherford County Case No. F-64676. I was lead counsel in this death penalty case tried in July of 2010. Among the convictions the jury returned a verdict of Second Degree Murder and Felony Murder and sentenced Mr. Alexander to Life in Prison Without Parole.

I have not previously served as a mediator, an arbitrator, or a judicial officer.

When I began private practice I regularly took appointments from the Davidson County Probate Court to act as *guardian ad litem* in conservatorship cases. Most of these were uncontested, however on one occasion, the contested conservatorship resulted in a three (3) day trial.

12. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

As a result of having worked in the office of a judge as well appearing before all of the federal courts in Tennessee and many of the state courts in the counties surrounding Rutherford County, I believe that I know what it takes to be good Trial Judge. Treating lawyers, clerks, staff, and witnesses with respect is paramount; listening before making a decision is key; and following the law despite personal feelings for either side is demanded. Based upon my experiences I believe that these qualities make a good judge.

35. What are your reasons for seeking this position? (150 words or less)

I have been very blessed during my legal career. I have been taught by some of the best lawyers during law school, worked for great lawyers at the Metro Legal Department, and clerked for a great judge in Judge Blackburn. Lawyers who have mentored me over the years and been subject to countless questions from me have also helped shape my practice of law. Based upon all the help that I have received from lawyers and judges alike nothing would mean more to me than an opportunity to use that knowledge of the law and courtroom experience to serve the community. Sitting as a public servant and impartially hearing cases would be an honor and being able to apply the law to a case to determine the appropriate outcome is the ultimate responsibility of a judge and I believe that I have the ability to do that.

36. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your pro bono service throughout your time as a licensed attorney. *(150 words or less)*

I have in the past been involved in the Christian Legal Clinic in Rutherford County. As a part of this group I would go from time to time to the Salvation Army building, and later to a local lawyers office, to give legal advise to those who may otherwise not be able to seek legal counsel due to lack of finances.

I have also made a presentation to the Stones River Manor Nursing home residents on estate planning issues at no cost to the residents.

37. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

The judgeship I seek is for Part 3 of the Circuit Court of the 16th Judicial District. The 16th Judicial District is comprised of four Circuit Judges, a Chancellor, and three General Sessions Judges. Part 3 of the Circuit Court, along with Part 2 of the Circuit Court, has for many years handled the bulk of the criminal cases in Rutherford and Cannon Counties with the two remaining Circuit Courts and the Chancery Court handling the bulk of civil cases.

Considering the extremely large size of the criminal dockets in this judicial district, the attorney

selected for this position must be able to step in and immediately be able to handle a criminal docket and preside over criminal cases and trials.

My selection would impact the court in that I have the background to do this.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? (250 words or less)

I have been honored to serve in the past on the board of the Rutherford County Habitat for Humanity. Habitat's efforts in Rutherford County have transformed areas of the city and county that otherwise have traditionally been known for drug use, prostitution, and dilapidated housing. Seeing first hand the way the very outlook of a neighborhood can change with the improvement of housing is phenomenal.

I currently serve on the board of directors for the Raiders for Christ Christian student center serving Middle Tennessee State University. For the past three (3) years I have served as the chair of this board. The ability to set policy and help administer this campus ministry that influences young people's lives that are starting, and attending, college has been a blessing.

To the extent allowed by the Code of Judicial Conduct I would continue to be involved in church activities and continue to serve on the board of the Christian student center.

 Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. (250 words or less)

I was raised in a home where I was taught conservative values by two great parents, grandparents, and a host of aunts and uncles who all helped shape who I am today. I saw first hand that hard work and dedication to the task (whether school, athletics, or work) was the path to success. I was raised in a Christian home and take pride in my Christian values. My proudest achievements all involve my family and my wife and children mean the world to me. Anything I have accomplished or will accomplish in my professional career can be traced to the support of my family. This upbringing will assist me in making difficult decisions that will impact not only the litigants, but also, in applicable cases, victims and the community.

My wife and I served as foster parents early in our marriage. This service resulted in the adoption of my two oldest children in 2000. To the extent that I would hear domestic relations cases, adoptions, and custody matters, my life experiences in this area will aid me in making decisions related to these types of cases.

From a professional perspective, I feel that my varied experiences from the Metro Legal Department, then clerking for Judge Blackburn, then transitioning into private practice has prepared me for the opportunity of serving as a judge. The variety of cases that I have handled

has provided me a basis of knowledge that will serve me well in the role of a sitting judge.

Yes, I would uphold the law even if I disagree with the substance. Without divulging specific information that could be considered work product and potentially privileged, I would state that in a very recent case approximately 5000 documents were delivered to my co-counsel's office pursuant to a Rule 17(c) subpoena. After a very short review by my co-counsel of several of the documents it became clear that the documents delivered contained email correspondence that could be considered work product of opposing counsel, and thus non-discoverable.

In this particular case it certainly could have been productive to my client to read the emails in that they could have given insight into the strategy and mindset of my opposition. While I certainly would have liked to read the emails, the ethical and legal response to this dilemma, I believe, resulted in a different outcome.
