I have also served as counsel of record for various intellectual property disputes, contract disputes and estate disputes that have been resolved via negotiated settlement prior to any lawsuit being filed.

With respect to DOE security matters, I was DOE counsel for twenty-four (24) administrative hearings regarding security matters, including two classified matters. These administrative hearings are conducted so as to conform as closely as reasonably possible to open court litigation while safeguarding the national security. The hearings include opening and closing statements, sworn testimony including direct and cross-examination, submission of evidence, and authorized transcripts via the presence of a court reporter with the appropriate security clearance; the federal rules of evidence are waived.

The cases covering non-classified matters included use of illegal substances, bankruptcy, falsification, misrepresentation, mental illness, incapacity, alcohol use, alcohol dependence and/or abuse, substance dependence and/or abuse, pornography viewing in the workplace, vehicular homicide and fraud.

The classified matters fell under 10 CFR 710.8(g): "[Failure] to protect classified matter, or safeguard special nuclear material; or violated or disregarded security or

safeguards regulations to a degree which would be inconsistent with the national security; or disclosed classified information to a person unauthorized to receive such information; or violated or disregarded regulations, procedures, or guidelines pertaining to classified or sensitive information technology systems."

One of the classified matters involved DOE's Office of General Counsel (OGC). Due to this factor, all OGC staff were conflicted out of the matter and an attorney from the field was required to serve as DOE counsel. Based upon knowledge of my prior performance, the Office of Hearings and Appeals (OHA) requested my assignment to this case. OHA noted particularly in making the request: my integrity with respect to the national security and appropriate handling of classified matters, my insightful yet respectful examination and cross-examination skills, my capacity for producing exemplary work within constricted time and budget parameters, my discretion with regard to political sensitivities, and my overall capabilities as an attorney. DOE prevailed in the case.

In all of the above-referenced cases, DOE Security provided records and evidence sufficient to support prosecution of the relevant case. Upon receipt of these records and evidence, I conducted all additional research, witness interviews, evidence gathering, and related trial preparation, including appropriate correspondence and interaction with opposing counsel, when relevant. I conducted direct and cross-examination, as appropriate, of all persons providing testimony. In the uncommon instance of appeal, I reviewed the case, determined DOE's position relative to the appeal response, and prepared the appellate response.

government the costs of prosecuting the matter; however, in accord with the relevant statutes, I recommended the matter be elevated to the administrative hearing phase.

At the hearing, the employee presented a substantial record of timely payments on each account covered by the bankruptcy, thus her security clearance was reinstated. While DOE "lost" this case for statistical purposes, from a practical perspective both DOE and the employee prevailed, as DOE was able to continue benefitting from this employee's specialized training, experience and corporate knowledge.
