I have practiced law in various local, state and federal courts. My experiences include juvenile courts, sessions courts, state civil and state criminal courts, appellate courts and in the federal courts, as well as before administrative judges in Tennessee. I have represented individual citizens, businesses, partnerships, LLCs, as a plaintiff, a defendant, a third-party, as guardian ad litem, and/or as appointed coursel.

Operating a law practice in a small town essentially means representing clients in practically all types of legal matters. My practice was primarily in the civil side of law, approximately 75% of the time. The remaining 25% of time was in criminal, juvenile and administrative matters. My practice was with a firm of four attorneys. We were partners in the law firm and each of us covered for the other frequently on an as needed basis. My practice ranged from office matters to litigation. The office matters included wills, adoptions, estates, real estate, banking issues, incorporations, business entities, not for profits, to advising and counseling with clients regarding their legal issues. The litigation practice ranged from termination of parental rights, criminal matters, accidents, business matters, as well as domestic and family law. My practice also provided opportunities to appear before governmental agencies and administrative bodies. Examples included local zoning boards, auto seizure cases, licensing agencies, Tennessee boards

and commissions, etc.

My federal court experience was in federal bankruptcy court representing businesses and/or individuals and civil trials which were removed from state court to federal court.

Since 2010, I have served as a judge over issues between our citizens and state agencies, and most recently as a Circuit Court Magistrate for the Tenth Judicial District. During this time period I conducted many contested trials ranging from one hour hearings in length to trials that lasted two or more days. Many of these cases required research into the issues at hand at trial. Issues raised included constitutional issues, issues pertaining to search and seizure, issues of notice and due process, evidence rulings, contractual issues, etc.

Ensuring the rights of the citizens to a fair hearing, complying with the rule of law and the due process issues are the keys to our citizens maintaining faith in our judicial system. These are the things I have focused upon during these past two years.

My experiences in the trial courts, appellate courts, and administrative agencies continue to demonstrate that being able to properly treat our citizens, as best as they permit themselves to be treated, remains an important goal for me in my current service as a judge.

It is important to be able to effectively work with and communicate with attorneys, clerks, parties, witnesses, court reporters, as well as other judges. Effectively working together ensures that our judicial system is respected and operates in a manner that serves our society very well.

In summary, it remains my goal to treat all parties, lawyers, clerks, and others in our court system with respect while maintaining proper decorum in the courtroom.

Letting attorneys fully present their arguments on the issues at hand is important to everyone, as well as to our system of justice. Drafting timely orders that address the issues in a concise and straightforward manner is equally important. I strive to let the citizens fully experience their opportunity to be heard, to address their issues in a timely manner and then to enter an order that is timely and one that our citizens can understand how and why the decision was reached.

Mediation of cases involving our citizens and governmental agencies have been conducted over the past two years. The cases I have mediated were noteworthy to the citizens and the agencies involved. The cases all involved school districts and parents. The issues were the appropriate educational opportunity of the students and their requirements upon the local school systems.

I have served many times as a guardian ad litem and an appointed attorney. I served in almost all of these cases on a pro bono basis. I have also served as a conservator on numerous occasions when appointed by the court. My service in the juvenile and circuit courts in guardian ad litem cases is lengthy and continued during my time of public service in the state legislature.

I have served as a Juvenile Court Referee, three days per month, for six years, as well as special judge in the Bradley County General Sessions Court on numerous occasions.

35. What are your reasons for seeking this position? (150 words or less)

The rule of law is a major component of our civilized society. It is essential that our system have seasoned, experienced, legally trained public servants in the role of judge. A background of

legal experiences, legislative experience, judicial service and proper temperament, provides the necessary mixture of traits for an appellate court judge.

My service as an attorney and in the legislature is one that required a research of authority, compromise, and application of the rule of law. Judicial service is a search for facts, legal authority and the application of law to the facts for each case. A proper temperament serves one well in each of these endeavors.

In summary, my experience as an attorney, a legislator and a judge, as well as my temperament make me well qualified to serve on the Appellate Court.

My service as an attorney includes numerous pro bono appointments and service as a guardian ad litem and service as an appointed attorney in both criminal and civil matters. I further served as a juvenile court referee for six years. I have served as an attorney advising numerous moot court high school teams.

I was also honored with an award by the East Tennessee Legal Aid community for my work on drafting and passing a law that helped low income and senior citizens. I have served on numerous committees that deal with the issues of representation in court systems and other equal justice provisions of the law. I served on a committee to rewrite the jury service laws to ensure that all citizens have a right and obligation to serve. I sponsored this legislation into law.

I am seeking to serve on the Court of Appeals, Eastern Division for the State of Tennessee. The Court has four Judges who serve the Eastern Grand Division of our state. My selection for service upon the Court would be one of which I would be the only rural or non-urban person to serve on the Court (along with two Judges from Knoxville and one from Chattanooga). My goal would be to follow the honored and worthy service of Judge Herschel Franks. It would remain my goal to ensure professional decorum in the Court, to ensure that the attorneys and their clients are fully heard, to work with the fellow members of the Court in reaching a decision that is timely issued and which is concise and as straightforward as possible so that our citizens will have greater understanding of the orders of this court.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? (250 words or less)

During my time as an attorney and while serving as a legislator and a judge, I have remained deeply involved in the service to my community, my church, my region and my state. I have served with several community, state, and national organizations. My service has ranged from civic organizations, issue oriented organizations, public welfare organization, educational activities, as well as personal and family related service in our church, our schools and related fields.

Serving as a judge for the past two years has been somewhat limiting and does restrict ones involvement in certain activities. However, within this constraint, I have continued to serve in various capacities within my community, in my church, my region, as well as my state. Additionally, I continue to speak and teach about public service, our government, and the judiciary, to students, schools and civic and community organizations. I believe that education is the key to people successfully understanding the role of judiciary in our government and in our daily lives.

39. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. (250 words or less)

This body has many worthy candidates to consider for nomination to the Governor for selection of service on the Court of Appeals. The combination of my service as a lawyer, a legislator, and a judge provide a unique skill set that have served me well in my role as judge. My role as a legislator provided a deeper understanding of the legislative process, of legislative intent and of the complicated process of law making. I have served on committees addressing judicial issues, including the Victims Rights Committee, Ethics Task Force, Judicial Council, Committee to Review the Death Penalty, Committee to Review the Court of Judiciary and Judicial Recusal, and the committee that conducted the Workmans' Compensation overhaul. I drafted and/or sponsored the Grandparents' Rights Legislation, Uniform Court Clerk's Fee Legislation, Shared Income Model for Child Support, Notice Revisions in the Administrative Modification of Child Support, the drafting of the new Judicial Nominating Committee, and the Judicial Evaluation Committee. Sponsored and served on committee rewriting the lien laws, and the rewriting of Jury Service Provisions and served on the Impeachment Panel v. District Attorney General.

The experiences of my work as an attorney provide a necessary courtroom experience of over twenty years, as well as my experiences as a Juvenile Court Referee, and the past two years service as a judge in Tennessee provide me with the well rounded experience that few applicants possess in their submission to this distinguished committee. 40. Yes. Our civilized society is based upon the "Rule of Law". Most attorneys support the concept of the rule of law by proper counseling of clients of the law and how it pertains to their case. By performing this service in their office, most attorneys then keep cases off the court docket which really have no merit being filed. Further, we uphold the rule of law by following the order of the court.

I have heard many cases as a judge when I have had a philosophical disagreement with the existing law. Regardless, I have advised the parties of the law and requested the lawyers to address the law. Thereafter, I advised the parties that I am obligated to follow the law. Accordingly, as the orders in my court have shown I have followed the rule of law.
