7. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I serve in the capacity as general counsel for the court. I am responsible for ensuring compliance with applicable federal, state and local laws, regulations, court rules and policies. I represent the court with respect to federal, state and local government agencies and serve as legal and legislative liaison with the U. S. Department of Justice, county government, the General Assembly, and departments of state government under the Governor's administration. These functions require about half my time.

The other half is devoted to serving as chief administrative officer of the court. In this capacity I have overall responsibility for court operations, including probation, detention, foster care review, child support coordination, clinical evaluations, oversight of a staff of 255, and budgetary, personnel, maintenance and support functions.

My law practice has included civil litigation, contract review and drafting, and representing private clients and governmental entities relative to construction contract issues and disputes, and

municipal matters. I have handled personal injury, corporate, real estate, and probate matters. I have defended financial institution bond claims and contractors' performance and payment bond claims.

I have handled a substantial amount of insurance defense litigation and have tried many cases involving automobile, premises and product liability, workers compensation and coverage issues. I defended manufacturers in many of the asbestos litigation cases in Tennessee. I have represented plaintiffs in wrongful death and personal injury cases in vehicular and industrial site accidents.

For 16 years I represented Shelby County in property tax litigation. I have represented clients in arbitration and mediation proceedings. I have handled some criminal matters in state and federal court. Most of my experience in this area was acquired while serving as a municipal judge with General Sessions Court criminal jurisdiction. In my present position I have become very familiar with delinquency, dependency and neglect, foster care, and child custody, visitation and support issues.

Currently I maintain regular contact and communication with the U.S. Department of Justice, Civil Rights Division, and the Office of Juvenile Justice and Delinquency Prevention. On behalf of juvenile court I helped negotiate a memorandum of agreement with DOJ in 2012 that avoided federal litigation against county government. I endeavor to ensure the court's compliance with the agreement.

In 1971 I was admitted to practice in the Tennessee Supreme Court, the Court of Appeals, the Chancery and Circuit Courts in Shelby County, and the U. S. District Court for the Western District of Tennessee. Other admissions to practice followed in the U.S. Supreme Court (1981), and the U.S. Courts of Appeal for the Eighth (1982) and Sixth (1989) Circuits.

By permission I have handled litigation in the Chancery Courts of Madison, Tipton, Fayette and Williamson Counties; in the Circuit Courts of Crockett, Overton and Dyer Counties; in the U.S. District Courts for the Eastern District of Tennessee, the Southern District of Mississippi, the Northern District of Georgia, the Western District of Arkansas, and the Eastern District of Texas.

I have represented clients before the State Civil Service Commission, the U.S. Equal Employment Opportunity Commission and the Social Security Administration.

My legislative service (1996-2002) was particularly beneficial in the areas of legislative drafting, history and interpretation. My work on the House Judiciary Committee and its subcommittees on Civil Practice and Judicial Administration and on the Children and Family Affairs Committee and its subcommittee on Family Justice enhanced my knowledge and understanding of many areas of the law. Working with legislative, executive and judicial officers and staff increased my understanding of the processes and functions of state government and of the relationships of the three branches.

In the legislature I developed and sponsored civil remedies for the prevention of abuse and exploitation of the elderly, penalty enhancements for custodial interference, most of the legislation to implement the Victims' Rights Amendment and many other measures for the improvement of the civil, criminal and juvenile justice systems. I received the Legislator of the Year award for 1999 from the Tennessee District Attorneys General Conference for my work on law enforcement legislation. I served as minority floor leader in the 101st General Assembly.

I was a member of the Tennessee Supreme Court Permanency Planning Commission that developed new guidelines for guardians ad litem. In the 1998 session I was House sponsor of legislation to improve foster care and permanency planning for children in state custody. I was a member of the House ad hoc committee on foster care that analyzed compliance efforts and progress by the Department of Children's Services in implementing the settlement of the "Brian A" federal litigation.

Airline Construction, Inc. v. William M. Barr, 807 S.W.2d 247 (Tenn. Ct. App. 1990), app. den. I was trial and appellate counsel for the original plaintiff/counter-defendant, Airline, a general contractor. Airline sued the owner for substantial sums due on a hotel construction project. Owner counterclaimed, alleging workmanship deficiencies and loss of profit delays. A judgment in the Chancery Court in Madison County largely favored the owner. On appeal it was reversed in substantial part in favor of the contractor. The Supreme Court denied the owner's appeal. The case has been cited frequently because of issues concerning expert proof and the analysis of construction damages claims.

Stanford Bennett, et al. v. Shirley Perkins, et al., 19 TAM 50-8 (Tenn. Ct. App. 1994), app. den. I was trial and appellate counsel for codefendants Patsy Rush and Paul Turner Century 21 Realtors. Purchasers of residential real property sued the real estate agents and brokers involved with the sale, contending they were not informed of the potential for flooding on the property. A defendants' verdict in Circuit Court (Shelby) was affirmed on appeal. The Supreme Court denied an appeal. The analysis of the respective duties of the parties under the factual circumstances is significant.

James A. Drake, Jr. v. JPS Elastomerics Corp., W2003-015799-COA-R3CV (Tenn. Ct. App. 2004). I was trial and appellate counsel for plaintiff James Drake, who sued his former employer for breach of a sales commission agreement, contending he was entitled to a higher commission rate because he had exceeded his quota. A judgment for plaintiff in the Chancery Court was affirmed on appeal. The case's significance involves the analysis of the contract language.

William L. Elliott, et al. v. E. I. DuPont de Nemours and Co., et al. (Removed to U. S. District Court, W.D. TN, Memphis, 1996; tried August-September, 1998.) I was trial and appellate counsel for plaintiff in this industrial site premises liability case. The case involved significant expert proof issues and OSHA regulations. Extensive medical proof was required to show the extent and permanency of plaintiff's injuries. Multiple defendants contested every liability and damages theory through their experts. A substantial jury verdict for plaintiff was resolved while the case was pending on appeal. (No. 99-5533, 6th Cir.) The case was significant because of the nature and extent of the damages, the complexity of the medical and engineering proof, and the challenge of overcoming multiple pretrial and trial obstacles in order to effectively and persuasively present the evidence to the jury.

In Re: Adoption of A.M.H., W2004-01225-SC-RII-PT (Tenn.2004). As counsel for the Juvenile Court of Memphis and Shelby County I helped guide implementation of the January 23, 2007 mandate of the Tennessee Supreme Court to reunite a minor child with her biological parents following seven years of litigation over custody and efforts by foster parents to terminate parental rights and to adopt the child. I represented the juvenile court in defending a writ of habeas corpus brought in the U.S. District Court, MD, TN at Nashville (transferred to the U.S. District Court, WD, TN at Memphis), In Re: AMH b/n/f Jerry L. Baker et al., v. Robert Cooper, et al. (07-CV-2394). The habeas petition was the foster parents' final attempt to stop the reunification process by seeking to invoke federal jurisdiction. The case drew international attention in view of the significant issues resolved by the Tennessee Supreme Court and the fact that the biological parents were citizens of China who were in the U.S on education visas when the child was born.

I served as an appointed municipal judge in Germantown from 1980-1986. This was a part time position and court sessions were conducted in evening hours. The court hears municipal ordinance violations and exercises General Sessions Court criminal jurisdiction. I held arraignments and preliminary hearings in state felony matters, bench trials on state misdemeanors and municipal ordinance violations. During that period of time the court handled about 10,000 cases per year, including traffic ordinance violations.

I have served as the administrator of a probate estate.

As a naval officer I served as defense counsel and as a panel member on several courts

martial (1965-67) by appointment of my commanding officers.

35. What are your reasons for seeking this position? (150 words or less)

The position of Judge of the Supreme Court of Tennessee affords unique opportunities and challenges. It requires the highest quality of public service in the areas of law and government to which I have devoted my professional life. The Court is the ultimate protector in our state of the right of the citizens to live within a free, orderly, safe and civilized society.

A depth of experience in the practice of law and a demonstrated commitment to public service have prepared me to continue the important work of the Court and maintain the traditions of honor, integrity and diligence characterizing the jurists serving now and those who served previously. The public's respect and appreciation for the judicial system is largely earned by the leadership, performance and example of judges. I welcome the opportunity to be a part of this continuing effort.

36. State any achievements or activities in which you have been involved that demonstrate your commitment to equal justice under the law; include here a discussion of your probono service throughout your time as a licensed attorney. (150 words or less)

I served five years as an election inspector, tasked to establish and maintain fair procedures on election days. I worked almost exclusively in inner city precincts. I helped maintain the integrity of the voting process despite interference and disruption by persons not authorized to be in the polling places.

In the federal criminal indigent defense program I represented a black man facing postal service related charges. I discovered my client was mentally impaired, HIV positive, and easily manipulated toward criminal activity by others. I obtained a departure from sentencing guidelines, permitting him to serve a probationary sentence with controlled medical treatment.

For several years I rendered pro bono service working with a charitable agency to represent abused and neglected children in contested hearings and custody disputes. I have assisted individuals facing court proceedings involving domestic and probate and estate matters.

Judge of the Supreme Court - The five members of the Court exercise appellate jurisdiction as

the court of last resort in the state judicial system. The Court guides lower courts and all Tennessee lawyers through its leadership, opinions and rule-making authority.

The Court hears oral arguments in Knoxville, Nashville, and Jackson. It assigns, drafts, and issues opinions on the issues presented. The Court extends its influence and guidance by holding sessions in law schools and other venues in the state.

My selection would be viewed positively by those familiar with my approach to the practice of law, respect for the courts, work ethic, and relationships with fellow lawyers and judges. These characteristics would contribute to a collegial working relationship with the other members of the Court and staff. I am fair and impartial in the exercise of judicial duties, and knowledgeable, competent and diligent in the practice of law.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? (250 words or less)

I plan to continue community involvement to stay in touch with citizens and groups working toward positive goals, especially in the areas of child safety, health, educational opportunity, juvenile justice, and moral guidance.

Selection to this position would enhance my ability to help improve the juvenile justice system and strengthen foster care and adoption efforts with both private and state agencies. I participate in efforts to support the Child Advocacy Center in Memphis. I have a lead role in implementing the Annie E. Casey Foundation's Juvenile Detention Alternatives Initiative (JDAI) in Memphis and Shelby County. I serve on the Memphis/Shelby Juvenile Justice Board and work closely with the Countywide Juvenile Justice Consortium (CJJC).

I also work extensively with Shelby County Schools to develop, implement and maintain productive initiatives such as Youth Court, Hope Academy, the SHAPE program, and the new School-based Probation Liaison project. These important programs must be sustained over several years to achieve the desired outcomes. These activities are designed to divert youths from the juvenile justice system and to prevent them from deeper involvement in the system. If selected I could be more influential in maintaining and building upon these efforts.

39. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. (250 words or less)

My military service and combat experience in areas lacking order and minimum standards for civilized behavior dramatically illustrated the need for a government and legal system that can be respected by the people. First hand observations of the Civil Rights Movement in Memphis and later involvement in the election process reaffirmed the necessity of a fair and effective judicial system.

A multifaceted law practice of many years, representing people from all segments of society, and experience in public office have provided much perspective, insight and understanding of

both the positive and negative relationships that can develop or exist between the people and institutions of government and law.

I have the ability to develop and analyze factual data with applicable legal principles, to organize and convey facts and law in clear language, and to reach appropriate conclusions. I am able to teach, relate to, and work well with people of all ages, backgrounds, and viewpoints, and to handle several projects within the same timeframe. I consider public service an honor, a responsibility, and a high calling. I sincerely desire to serve in this role.

40. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law to the best of my ability, fairly and impartially. Like most lawyers who have tried cases there have been instances where rulings by a trial judge on admissibility of evidence or legal theories, which I knew at the time to be incorrect, changed the probable outcome of trials to my clients' detriment. When this occurred during a trial I resolved to continue to show proper deference to the court to help preserve the authority of the judge before the jury, other counsel and all parties.

A judge once refused to reassign a case when there were compelling legitimate reasons for his recusal. The court's refusal to recuse was the beginning of a series of adverse rulings against my clients. During the trial the judge displayed hostility towards my clients and disregarded case law supporting their position relative to a key evidentiary issue. I spent much time advising and counseling my clients about their alternatives and explaining that no matter the result of the trial the court as an institution must be respected.
