2/12/07 Received summons in estate matter for which I had been appointed by the court as Administrator Ad Litem. Case was filed in the Circuit Court for Sullivan County, case number 37240(c). The plaintiff, an heir to the estate, sued her attorney, accountant and myself as Administrator Ad Litem. The heirs had entered into mediation and resolved all issues, but some time later this heir filed the complaint. The Court granted Summary Judgement on several of the issues and the Plaintiff filed a voluntary non-suit with prejudice 3 days later. This is also the subject of the Board of Professional responsibility complaint referenced above in Question 19, which was dismissed.

#### 28. What are your reasons for seeking this position? (*150 words or less*)

I have practiced law in Sullivan County since 1986, the year of my graduation from the University of Tennessee College of Law. After beginning my legal career in a small firm, I have successfully and happily operated as a solo practitioner for the last 25 years, with a fulfilling practice covering every aspect of the law. In 2011 I was appointed by former Kingsport mayor Dennis Phillips to serve as Municipal Judge of Kingsport, a part-time position which ignited in me a new-found legal passion. I seek the privilege of serving the citizens of Sullivan County by providing a calm and thoughtful ear for all matters brought before my court, both civil and criminal. My time as a municipal judge has brought me much feedback, both personally and from others, that leads me to desire a judicial role on a full-time basis.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (*150 words or less*)

I have had the pleasure of being a life-long Sullivan county resident and providing calm and competent legal services in the Second Judicial District all my adult years. The recently vacated Circuit Court Judgeship incorporates both Civil and Criminal actions. The Second District includes one Criminal Court, two Circuit Court Judges and a Chancellor, all who I know and respect and who can each attest to my work-ethic and professionalism. They would find in me a compatriot who does what he's supposed to do, in a most timely and thorough manner. While

serving as Municipal Judge of Kingsport, the clerk, bailiffs, police officers, City Attorney and others involved in Municipal Court proceedings seem to have valued my contributions to a well-run operation. In turn, I have valued their efforts and the opportunity to be a part of a larger team, an aspect of the law often lost as a solo practitioner.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I recognize the role of this court is to up-hold the laws as written, not to interpret them as suits my preference. As a sitting judge I routinely experience this conundrum. Often I have been unable to grant leniency such as driving school to commercial drivers, even when they are prosecuted for traffic offenses while driving their personal vehicles. The infractions, however small, often result in commercial drivers losing their jobs; but they are, and should be, held to a higher standard.

Several years ago I represented the Defendant in a criminal case before a jury in the same court room in which I will serve if appointed. My client worked for a small construction business and the owner experienced a medical emergency taking him out of the state for several months of treatment. My client finished up on-going jobs and lined-up and completed several new jobs while the boss was away. My client kept the monies he had earned during the boss's absence and was charged with felony criminal theft. I presented the best possible defense but lost the case. It was a bitter pill to swallow at the time, but a strict interpretation of the law justified the jury's decision. On a side note, I'm happy to report that this client now runs a successful business of his own and remains a friend and client of mine to this day.
