6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am the primary legal officer for the Bureau of Alcohol, Tobacco, Firearms and Explosives, and am responsible for overseeing the agency's legal matters in Tennessee and Alabama. I represent the agency's interests in civil and criminal proceedings, as well as in licensing actions in administrative hearings before Administrative Law Judges and informal, hearing officers. I also provide day-to-day legal counsel to agency leadership and staff on a variety of matters, including negotiating and drafting contracts and general agreements applicable to the office, compliance with statutory and regulatory requirements at the state and federal level, and employee-employer relations. I write briefs and memoranda of law in response to administrative or civil actions in federal courts. I sit, as directed, as a legal representative in federal civil and criminal litigation. I conduct a legal review of all requests for orders to conduct electronic surveillance.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I began my legal career as a criminal justice instructor for a community college. Thereafter, I became employed as an attorney for a pharmaceutical manufacturer and distributor, where I negotiated, drafted, and interpreted contracts, assisted with mergers and acquisitions, managed the corporate's intellectual property portfolio, and assisted with employer-employee relations, to include addressing allegations of employee misconduct. In 2000, I became an Assistant District Attorney General (ADA) for Sullivan County, Tennessee. As an ADA, I handled a variety of felony offenses from the point of investigation through trial and sentencing. The cases included homicides and other violent offenses, property and financial crimes, narcotics offenses, and crimes against children. I also handled related civil litigation, including Habitual Traffic Offender adjudications and forfeitures. In September of 2000 through November of 2004, I served as a U.S. Army Judge Advocate, which included a one-year activation in support of Operation Enduring Freedom. In 2006 I accepted a position as a Staff Attorney within the Firearms, Explosives, and Arson Division (FEA) in the Office of Chief Counsel at the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) in the U.S. Department of Justice. In 2007, ATF temporarily assigned me to a Violent Crime Impact Team (VCIT) at the U.S. Attorney's Office for the District of Puerto Rico, where I lived during the assignment. As a part of the VCIT, I served as a Special Assistant U.S. Attorney (SAUSA) and prosecuted violent firearm offenses within the District. Upon my return to ATF, I assumed my role as Staff Attorney and was then promoted to Senior Attorney in FEA. As a Senior Attorney in FEA, I assisted in the

classification of regulated devices and materials, drafted memoranda of law, and responded to Executive and Legislative Branch requests for assistance on technical/legal matters.

In 2010, to assist in the investigation and prosecution of a complex smuggling operation, ATF assigned me to assist with the U.S. Attorney's Office for the Eastern District of Tennessee as a SAUSA. The case resulted in a felony offense for an individual operating as a business entity. I was later selected to serve as the Chair of ATF's Professional Review Board (PRB). The PRB is responsible for reviewing and addressing allegations of employee misconduct, and recommending a lawful course of action – clearance, caution, warning, suspension, or termination. After one year, as a part of a leadership program, I was assigned to serve as the Deputy Assistant Director of the Training Division at the headquarters of the U.S. Marshals Service. While there, I addressed the creation and delivery of a comprehensive training program across the entire agency.

I returned to ATF and resumed my position as Senior Attorney within FEA. In 2013, I was selected as the Division Counsel for the Nashville Field Division of ATF. As Division Counsel, I conduct formal and informal hearings related to administrative actions related to licensed persons and entities, represent ATF's interests in civil litigation, and provide day-to-day legal counsel to the senior leadership and staff of the Division.

I have conducted countless criminal and civil hearings before a variety of tribunals at the state and federal level. I have litigated civil and criminal matters at bench trials and before a jury. I have conducted administrative hearings before informal hearing officers, as well as Administrative Law Judges. I write responsive briefs for matters pending before federal courts.

I received the following awards: Army Service Ribbon, Armed Forces Reserve Medal (with "M" device), for being mobilized, the National Defense Service Medal, the Global War on Terrorism Medal, and an Army Reserve Commendation. I receive an Honorable Discharge at the rank of Captain in November of 2004.

I was the plaintiff in Brian Martin v. Amy Martin, which was a dissolution of marriage proceeding in the Chancery Court for Sullivan County at Bristol, TN. The action was filed in January of 2002. The grounds for dissolution were irreconcilable differences. The marriage was dissolved, by agreement, on March 20, 2002. The docket number and the exact date of filing are not presently available to me.

I was the plaintiff in Brian Martin v. Meadow Branch South Property Owners Association, Inc., which was filed in the Circuit Court for the City of Winchester, VA in late 2012. The exact dates of filing and resolution are not presently available to me. The docket number is CM-12-6. The matter arose after I made a demand under Virginia law to review records of the homeowner's association (HOA) related to actions of the HOA Board and use of HOA funds. The management company and elected members of the HOA Board failed to comply with my request so I filed a demand for the records with the Circuit Court. After an initial court appearance before the court, the matter was resolved by agreement when the court ordered the release of the records and the HOA paid costs associated with my expenses.

As a judge, I would sit in balance of the legislative process and the executive's implementation of laws. I believe that a position as judge requires a person with both a sufficient depth and breadth of knowledge and experience. Absent the right balance, neither the people who are reliant upon government, or the government, will be assured of a right and just outcome. I believe that after more than twenty years, I have attained the right balance of breadth and depth. Appointment to the bench allows me to continue to serve the people.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)* 

The current vacancy is the result of an increase in caseload. As Chief Justice Bivins recognized, a properly balanced caseload in the judiciary is critical to, "the fair and efficient administration of justice." Throughout my career I have exceeded the minimum standards and, many times, I have been able to set new standards. By being experienced in a broad range of the law, I can quickly step in and lend assistance to the current bench, reducing backlogs, and allowing cases to resume a faster resolution. The 21<sup>st</sup> Judicial District is a multi-county Judicial District, and I appreciate the variety of different needs among litigants and counsel. I believe that my selection and appointment will continue the good work of the current bench in the 21<sup>st</sup> Judicial District while expediting cases.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I will uphold the Constitution and all laws that are not in violation of it, regardless of my agreement or disagreement with the statute or rule.

More than a decade ago, the Tennessee General Assembly enacted a tax on those persons who possessed illegal narcotics. While the law had a beneficial intent, it struck me as possibly in violation of the 5<sup>th</sup> Amendment's right against self-incrimination; however, neither the Court of Criminal Appeals nor the Supreme Court had struck it down on those grounds. Despite my reservations, where cases came before me, I made sufficient inquiry into their validity and, if they met the statutory requirements, proceeded with the case and assisted the Department of Revenue in their tax collecting efforts. Later, the Supreme Court struck down the law as applied, but not on 5<sup>th</sup> Amendment grounds, but on strict statutory interpretation, as applied to the identified defendants.
