Personally and professionally, this position represents the culmination of a lifetime as a professional lawyer, spent being asked if I planned to be a Judge "...when I grew up ...", and having the opportunity to reach out for the brass ring. I believe that in our state, the general populace views trial judges as "honorable men and women", and that my efforts as I've grown in the profession of law, will aid and strengthen me as such an honorable man, and allow me to demonstrate that to me fellow 21st Jucicial District citizens.

The 21st Judicial District is spread out over Williamson, Hickman, Lewis and Perry Counties, encompassing the "semi-urban" to the open and beautiful rural country of our state. It is a great virtue of our state that those of us who practice law from day to day in it, have nearly as much opportunity to represent rural residents as urban ones in our practices, and that opportunity contributes to the overall wisdom of our State bar. Unfortunately the overall urban or rural feel of a community has very little to do with the types (and feel) of crime that goes on in such a community, and on the civil side of the law, the issues are also the same from "Mountain City to Memphis". Because of this background, I believe that my background as an East Tennessean is as much an asset to my judicial search, as would have been a background as a cotton farmer.

Yes, absolutely. Legislatures are designed for the purpose of creating the laws within which our society must live, although it is the judges of our land who must review and interpret those laws, once enacted, to give them meaning. However, while there is much joking among those living in our state about how much "room for interpretation" there seems to be in the body of laws that governs us as a people, I am confident that the "strict constructionists" among us (as applicants for judicial vacancies in the 21st Judicial District) hold the majority of opinion that the role of judges is to rather strictly interpret legislative language, largely because during our time in representing the private citizens of our state, we have been called upon to argue our own interpretations of the language of statutes created and passed by our legislature, and even the

most creative among us have a good bit of difficulty in influencing others that well-written legislation means anything altogether OTHER that what a group of pragmatists decides that it does mean, despite the overall political and emotional view that each such person may take.
