My legal career has primarily been in service to families and children. I presently represent individual clients in all types of family law cases such as divorce, custody, and adoptions. This comprises approximately 80% of my work. I am also a Rule 31 Family Mediator and Mediation Trainer which comprises approximately 10% of my work. In addition, I handle other cases such as Civil Litigation, Juvenile matters, and Personal Injury cases which comprise approximately the remaining 10% of my cases. On top of my private cases, I am responsible for all of the management of The Fleming Law Firm & Mediation Center including attorneys, staff, and interns. I presently serve as the Assistant City Judge for Springfield, TN.

I have extensive experience in civil litigation matters. For the first 5 years of my practice I was an associate attorney at Boult, Cummings, Conners & Berry in Nashville, TN. As part of their litigation team I consistently represented individuals, corporations such as Gaylord, Inc., and banking institutions including Nashville City Bank. I tried cases in General Sessions Court, Circuit and Chancery Court and the Tennessee Court of Appeals. Since 1991, I have had a robust full-time domestic relations litigation practice. I have represented from start to finish over 4,000 individuals in divorce and other domestic matters. I have practiced primarily in State level Courts in Robertson, Montgomery, Sumner, Cheatham, and Davidson County.

In my earlier years of practice, several of my trial Court cases have been appealed to the Tennessee Court of Appeals.

28. What are your reasons for seeking this position? (150 words or less)

I seek the position of Circuit Court Judge to serve the citizens of the 19th Judicial District where I live and work. I have spent my entire adult life representing families and children primarily in Robertson and Montgomery Counties. As an Attorney, Professor, Mediator, Judge and Mediation Trainer I am uniquely qualified for this position. I can provide both gender and geographic diversity to this Judicial District. I do not seek just any Judicial position but this specific Judicial position; The presiding Judge has determined that this Circuit will be a

domestic relations Court. As a sitting City Judge and former Juvenile Court Referee, I will hit the ground running and am familiar with the community and culture that I will serve. I am ready to serve as Circuit Judge for this Judicial District. My children are grown, and I have the time and energy to devote to this position.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I seek the newly created Circuit Court Position for the 19th Judicial District. I would become the 6th Judge in this Judicial District. I feel my selection would strongly impact the Court for three main reasons:

- 1. Experience: I have over 30 years of trial experience in civil litigation cases.
- 2. **Character and Temperament**: I have the demonstrated character and temperament to be a Circuit Court Judge. I am honest, balanced and will follow the law.
- 3. Work Ethic: I work hard and fight hard for my clients.

I am personally acquainted with and practice in front of the sitting Judges of the 19th Judicial District and I will be an asset to this team. As a Circuit Judge I will continue to work hard and will jump in to help the other Judges whenever needed.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I represented a Father in a Termination of Parental Rights Case who was attempting to pay child support and visit his child. Each time he would attempt to pay support or visit, the Mother would move and return all payments. I fought against his rights being terminated because I thought it was not fair. The Tennessee Adoption Statutes were strict and if the parent had not visited and/or paid 4 months preceding the filing of the termination petition, the rights of the Parent should be terminated. My client's rights were terminated, and I was devastated. I took the case to the Court of Appeals and lost. After the retirement of the Judge who ruled in this case, and the child's majority, I asked the Judge why she ruled this way under such circumstances, and she said despite my personal beliefs, I had to follow the law. This made a huge impression on me as a lawyer. Throughout my career, I have always followed the law to the best of my ability remembering this story. Further, as Juvenile Court Referee, I agonized about whether or not to return a child to his birth parents or continue with his 10th foster home. I reviewed the Juvenile Code and the Child's Foster Care Plan and despite my feelings, ruled exactly in accordance with the law. If I am selected as the next Circuit Court Judge, this Commission and the Governor can

be assured that I will follow the law in every instance.
