6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Currently, my practice focuses on family law, criminal defense, small business representation and work in the Probate Court. My husband and law partner practices almost exclusively criminal defense. I would estimate that, though variable from month to month, currently 60% of my cases are family law-related, 25% is criminal defense or defense-related, including representation in Title IX matters at the University or College level, 10% is small business representation and 5% is in the Probate Court in the capacity of Guardian Ad Litem work. For those criminal cases in which I am not the primary attorney, I am very involved in strategy and determining the course of action in representation.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

After spending ten months at the DA's office in the General Sessions courts, I advanced to a criminal court team where I practiced for ten years. While assigned to criminal court, I had the opportunity to gain extensive jury trial experience and handle the post-conviction cases in our court. I spent nearly every work day in the court room, negotiating cases, handling pre-trial motions, probation violations and suspended sentence motions, conducting bench trials and various other matters that appeared on the criminal court dockets. Additionally, I assisted training newer attorneys assigned to our court, which included all aspects of criminal litigation at the trial court level. While at the DA's office, I served as interim Team Leader during a colleague's extended medical leave, at which time I assumed the supervisory role and responsibilities for our team. I was later appointed Team Leader of a different criminal court team.

In my position as a *Pro Tem* prosecutor, I had the opportunity to handle cases in twenty-four of the state's thirty-one judicial districts. The majority of my cases were pending in criminal or circuit courts. As *Pro Tem* prosecutor, I collaborated with law enforcement on pre-charge investigations, made determinations about whether to present matters to grand juries for indictment, negotiated plea agreements, handled post-conviction hearings, probation violations, pre-trial motions, and conducted jury trials, including four murder trials, one being a capital case.

During my time in private practice, I have represented clients in Chancery, Circuit, Criminal, General Sessions Civil, General Sessions Criminal and Probate courts. Additionally, I have been involved in defending allegations under a major university's Title IX policy.

My experience with numerous courts across the State has given me the opportunity to observe and understand the qualities and attributes a judge should possess, such as treating every person in the courtroom with respect, being knowledgeable of the law, being prepared to provide spontaneous analysis and rulings and the ability to manage and run dockets efficiently.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

During my career as a prosecutor, I tried sixty-nine cases before a jury as lead or co-counsel. Twenty-one of those were first degree murder cases, including one capital case. Preparing dozens of cases for jury trial, I developed an affinity for presenting to juries complex scientific and technical evidence such as DNA, fingerprint evidence, forensic computer analysis, firearms analysis and medical examiner's evidence and testimony.

Several cases over the years garnered intense media attention and coverage, including the two cold case homicide trials of Jerome Barrett. In each of his trials, the cases were more than thirty years old at the time of trial. I presented serology and DNA testing results which required the ability to communicate to the juries the evolution of the scientific testing capabilities and the advancement of forensic testing over three decades, culminating in modern DNA analysis techniques and results which provided critical evidence of the defendant's guilt.

Bruce Mendenhall was an interstate truck driver arrested in Nashville for murder. At the time of his arrest, his truck contained substantial physical evidence linking him to the murder of a prostitute in Indiana from the previous evening, and DNA evidence from several other prostitutes, missing and presumed dead, from other jurisdictions. While being held in the Davidson County jail pending trial for murder, Mr. Mendenhall solicited a fellow inmate to kill several witnesses against him. Our case relied heavily on recorded phone calls, letters written by Mr. Mendenhall, testimony of a cooperating inmate, who agreed to wear a wire to capture the conversations between Mr. Mendenhall and him on video. I served as lead counsel in his Solicitation to Commit First Degree Murder trial, which resulted in convictions for several counts of Solicitation to Commit First Degree Murder.

I was also one of the prosecutors in his murder case, during which I presented, among other

evidence, the DNA evidence linking him to the local crime while having to avoid reference of significant DNA evidence related to the other suspected homicides.

In 2013, another ADA and I were appointed *Pro Tem* prosecutors in the matter of State v. Michael Dale Rimmer in Shelby County, a capital case. Prior to our involvement, a court granted relief to the defendant after an extensive post-conviction hearing, ordering a new trial. We were selected to handle the re-trial of a 1998 domestic-related homicide in a matter where the victim's body was never recovered. After our independent review of the case, we again pursued it as a capital case. Over the next two years, we handled the extensive pre-trial litigation and trial preparation. Over a two- week period in 2015, we tried the case, resulting in a conviction for first degree murder and the imposition of a death sentence.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

I developed an interest in teaching and presenting fairly early in my career. After attending courses presented by the National District Attorneys Association at the National Advocacy Center ("NAC"), I began teaching trial advocacy at the NAC. Several years later, I was selected to be on the Trial Advocacy Committee of the District Attorneys Conference. This committee developed and implemented an intensive trial training program for prosecutors in Tennessee. Students dedicated one week to the training, during which they receive instruction in the form of lectures, working discussion groups and following performances in all areas of basic trial skills. My work with the committee led to my recurring position as a faculty member at the Trial Advocacy Course. In these teaching roles, I lectured on topics in trial advocacy and taught small groups in which students applied the lessons from lectures, interacted with one another in discussion groups and performed elements of a jury trial subject to the advice and critiques of faculty members.

I had the honor of presenting at the national Combined DNA Index System ("CODIS") conference in Washington, D.C. in 2009 as a result of my role presenting decades of scientific and DNA evidence in a cold case homicide.

I began teaching both in-house Continuing Legal Education seminars at the District Attorney's Office and presenting at the annual Tennessee District Attorneys General Conferences. My teaching experiences led to my role as an Adjunct Professor at Belmont University College of Law, where I continue to participate in teaching Basic Trial Advocacy.

In 2011, a defendant named Jerome Teats whom I was prosecuting for Aggravated Robbery and Especially Aggravated Kidnapping filed a federal lawsuit against a number of individuals in the District Attorney's Office, the court system and the Department of Correction. Mr. Teats alleged civil rights violations related to a 2000 conviction and twelve- year sentence, due to pre-trial sentence credits not being awarded properly. I was named in the lawsuit in my capacity as an Assistant District Attorney. The suit, case number 3-11-0753, was filed in the United States District Court for the Middle District of Tennessee, Nashville Division. A Motion to Dismiss was granted in that matter, and the claims against me were dismissed by Order dated September 26, 2012.

In the August of 2017, the General Sessions Courts of Davidson County had an opening for the referee position for the Environmental Court, appointed by the General Sessions Court judges. I applied and interviewed for the position.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I had the opportunity to serve the community as an advocate for victims and for the State for more than thirteen years. I have reached a point in my career where I believe my experience has prepared me to serve in the role of judge, which will allow me to continue to serve the community as a whole, while allowing me the opportunity to positively impact those involved in every case. I have always navigated my cases with the goal of obtaining the best outcome, but also with the intent to do the right thing. I am seeking this position because I would have the opportunity to use my experience and my work ethic to contribute to the community and to guide the administration of justice for each person charged with a crime and each person victimized by crime.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The judgeship I am seeking is one of six criminal courts for Davidson County. It handles all types of felony offenses and misdemeanors unresolved in General Sessions.

I bring the experience of a longtime criminal trial lawyer who has a firm grasp on the process, procedure and applicable law. I have a strong work ethic and the desire to be fully prepared for every case. My common sense, logic and the desire for a just outcome under the law in every case would contribute to my effectiveness as a judge. Further, my desire for efficiency would assist me in the management of dockets and operation of the courtroom. I would respect the time and circumstances of each victim, witness, defendant, juror and attorney in my court.

I have the temperament necessary to serve as a judge, and I will treat every person in the courtroom with respect, dignity and impartiality.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I will. It is not the role of a judge to decide what laws to impose or disregard. I will apply and uphold all laws without hesitation.

As one who respects and appreciates the rule of law, it is difficult to think of a law with which I disagree. While I agree with the purpose of Rule 404(b), I have experienced situations where application of it resulted in frustration at the proof the jury was allowed to hear. Application of 404(b) can result in exclusion or sanitization of evidence, preventing a jury from learning the full circumstances of a crime, which can be frustrating when advocating for the State. Witnesses are sworn to tell the whole truth, then told they may not tell the whole truth to a jury.

I tried an aggravated robbery case in which a hotel clerk was robbed by the same defendant who robbed her several years prior, leading to her immediate recognition and identification of him. Application of 404(b) resulted in the victim only being able to tell the jury she previously had a "memorable interaction" with the defendant, leaving a void as to the context of the victim's statement and how she was affected. My concern was that her seemingly evasive answer might result in a jury discrediting her testimony.

Despite having been frustrated at times by the application of 404(b), I recognize the importance of the rule. The protections it affords the accused are paramount to the objectives of the criminal justice system.
