Unfortunately, an in-person bar exam review course was not offered where I resided so I was unable to attend such a course for the Arkansas bar exam. As a result, I did not pass this examination by less than two (2) points. After applying to retake the examination, I temporarily relocated to Little Rock, Arkansas so that I could attend an in-person bar exam review course. I successfully passed the Arkansas bar exam in February 2005. As part of this examination, my answer to the exam question in the area of Torts received the designation of a top paper by the Arkansas State Board of Law Examiners and was published in the Arkansas Supreme Court Library as a model answer from the examination.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My present law practice primarily consists of cases that are heard by the Chancery Court and Juvenile Court. The major areas of law in those cases relate to divorce, custody, child support, dependency/neglect, termination of parental rights, probate, wills/estates, property disputes, and contract disputes. My present law practice also consists of business, corporate, employment, and governmental matters as I serve as the County Attorney for Benton County and the attorney for Henry County Medical Center. A small portion of my present practice consists of handling criminal matters. Overall, by percentage, my total practice is approximately 60% family law, 15% corporate/governmental, 10% property/contract disputes, 10% probate, and 5% criminal law.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have been a practicing attorney for approximately fourteen (14) years. During the first half of that time period, I was employed in mid-sized law firms and my experience primarily focused on working on cases related to insurance defense which consisted of representing hospitals, physicians, and nurses in medical malpractice lawsuits and representing other types of professionals or companies in civil litigation. I also worked on other cases related to family law and general civil law. During the second half of that time period, I was self-employed in private practice and my experience has primarily focused on handling cases in Chancery Court, Juvenile Court, General Sessions Court, and Circuit Court related to divorce, custody, child support, dependency/neglect (both as guardian ad litem and parents' attorney), termination of parental rights (both as guardian ad litem and parents' attorney), probate, wills/estates, property disputes, contract disputes, business matters, corporate matters, labor/employment, governmental matters, personal injury, and criminal matters (trial court and post-conviction).

In addition to appearing for clients in a trial court, I have regularly handled transactional matters for clients which include the preparation of powers of attorney, wills, estate planning, contracts, and the formation of business entities.

In July 2013, I was appointed by the Weakley County Juvenile Court to represent an indigent mother in a dependency/neglect and custody case that lasted for two (2) years. During my representation of the mother, we were able to reunite her with her children and successfully defended against an attempt to modify custody by the father at trial in April 2015. In May 2015, I received a letter from the Consumer Assistance Program of the Board of Professional Responsibility wherein the father filed a complaint on the basis that he felt it was unfair that I represented mother and prevailed at the custody trial while he spent a substantial amount of money for a private attorney. I responded to the letter from the Consumer Assistance Program regarding my appointment to the case by the Weakley County Juvenile Court and provided documentation regarding same. The case was closed and dismissed thereafter.

In November 2016, I was retained to represent a client in a highly contentious post-divorce matter involving a dispute between the client and the client's ex-wife over a substantial amount of alimony in the range of \$500,000.00 to \$1,000,000.00 and other provisions from their Marital Dissolution Agreement. The ex-wife initiated the post-divorce matter seeking contempt for my client's alleged failure to pay the correct monthly amount of alimony. On behalf of the client, I filed a counter-petition requesting the trial court to clarify my client's obligations due to the agreement being ambiguous or to modify or terminate the alimony payments. I did not represent the client in the original divorce. During the proceedings, I and my client discovered that the ex-wife had intentionally destroyed evidence requested in discovery and that ex-wife and ex-wife's counsel were involved in an extra-marital affair in violation of the Rules of Professional Conduct. During the proceedings, the ex-wife would also make derogatory personal comments

about me and would send such comments to me in the form of answers to discovery. After obtaining evidence of the inappropriate relationship between the ex-wife and ex-wife's counsel, I notified the trial court. During a chamber conference with the trial court and opposing counsel, the trial court expressed that I was correct regarding the conflict of interest and urged opposing counsel to withdraw. After the chamber conference, I filed a motion to disqualify ex-wife's counsel and ex-wife's counsel was thereafter forced to withdraw from the representation based Two (2) days after ex-wife's counsel withdrew from the upon a conflict of interest. representation, the ex-wife obtained new counsel and filed a motion to disqualify me from the case based upon an allegation that I had harassed ex-wife during the discovery phase of the case by making comments to her counsel and because her employer was another client of mine. After hearing two (2) days of testimony, the trial court denied the ex-wife's motion to disqualify me and held that I had not violated any provision of the Rules of Professional Conduct or otherwise. Within three (3) weeks of the trial court's ruling that I had not violated the Rules of Professional Conduct, the ex-wife filed a complaint with the Board of Professional Responsibility on January 26, 2018. Even though the trial court had issued a ruling that I had not violated any provision of the Rules of Professional Conduct, the Board of Professional Responsibility subsequently issued a confidential private informal admonition in November 2018, on the basis that I failed to respect the rights of third persons and closed its case. In its decision, the Board noted that in mitigation, I had no history of prior discipline in thirteen (13) years of practice. Based upon the rules, a private informal admonition is the lowest level infraction and is a form of non-public discipline for situations involving an isolated incident or is minor.

In 2007, I worked as an associate attorney in which my law firm was defending a dentist and anesthesiology group in a medical malpractice lawsuit. Our firm's clients prevailed in this initial

lawsuit. After we prevailed, the individual plaintiff was upset with the trial court's decision and filed a separate lawsuit against me, my clients, and my clients' insurance carrier. The case was filed on October 26, 2007 in the Shelby County General Sessions Court, styled <u>Barbara Becton</u> v. Metro Anesthesia Alliance, ProAssurance Professional Group, Dr. Felix Stanfield, Dove Family Dentistry, and Shon Johnson. The separate case was dismissed in January 2008.

In 2008, my former employer/law firm filed a declaratory action to resolve a dispute regarding my compensation after I left to work for another law firm. The case was filed on June 12, 2008 in the Shelby County Chancery Court, styled <u>Domico Kyle, PLLC v. Shon D. Johnson</u>. I filed a counter complaint on August 14, 2008. The case was resolved by amicable settlement and dismissed in November 2018.

In February 2014, I applied for the position of County Attorney for Henry County. The position is appointed by the County Commission.

In May 2018, I applied for the position of Judge with the City of Paris after the previous Judge retired. The position is appointed by the City Commission.

In August 2018, I applied for the position of County Attorney for Benton County. The position is appointed by the Mayor.

ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

The Court serves as an institution that provides all people with an equal opportunity to be heard and their case decided by an impartial judge. The Chancellor is the bedrock to this institution and must ensure that these principles are met. I was raised in a modest home and experienced the effects of a divorce at a very young age. Although those memories kept me from practicing family law in my first few years as an attorney, the experience has provided me a basis of understanding to relate to my family law clients over the last ten (10) years. The types of cases heard in the Chancery Court primarily relate to families through divorce, custody, termination of parental rights, adoption, and probate matters. Although I am married and never divorced, my personal experience with family law both as a child with divorced parents and as a practicing attorney handling such matters for years has provided me an adequate understanding of the what these families are contending with as litigants before the Court as well as the necessary understanding of the law that applies to their case. For family law and the other types of civil cases heard by the Chancery Court, I possess a business and accounting background that also provides a unique understanding of the financial intricacies involved in such cases. Aside from possessing the experience and knowledge necessary to serve as Chancellor, I have exhibited the fortitude to pursue what is right and appropriate personally and professionally regardless of whether, at times, there are consequences for such pursuit. In fact, a large percentage of my clients have selected me as their attorney on this basis as well as me being independent and impartial in the legal community. Upon reflection and examination of my personal history, I believe that I would be well-suited to serve as Chancellor based upon my experience and proven dedication.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

Application Questionnaire for Judicial Office

The judgeship that I am applying is for the Chancellor of the 24th Judicial District, which currently comprises of five (5) counties including Benton, Carroll, Decatur, Hardin, and Henry. The 24th Judicial District consists of two (2) Circuit Court Judges, one (1) Chancellor, and one (1) Judge for each of the General Sessions Courts and Juvenile Courts in each individual county. The types of cases heard by a Chancery Court is determined by statute and typically include cases of divorce, child custody, child support, contempt, termination of parental rights, adoption, contract disputes, business disputes, injunctions, and real property disputes. My selection as the Chancellor of the 24th Judicial District would provide a positive impact on the Court because it places a candidate in the position who possesses the business/accounting background necessary to fully understand the details of these types of cases, the experience of handling these types of cases, and the requisite humility to relate to the people who appear before the Court.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law even if I disagree with the substance of the law at issue. Although there is a risk of an apparent unfair result from the strict application of the law, a judge has an obligation to apply the law to the facts of a case and render an impartial decision.

One example from my practice as an attorney involved a dependency/neglect case filed by the Department of Children's Services. I was appointed by the Juvenile Court as the guardian ad litem to represent the children's best interests. After an extended period of time, the parents substantially complied with the steps set forth by the Department of Children's Services and the Department reunited the children with their parents. Although I had personal feelings that the parents had only completed the minimum effort for the return of their children and had only ceased using illegal drugs for a limited time period, the law did not support the denial of the return of the children when the Department made its decision. I accepted the Department's decision and the return of the children. Unfortunately, I was correct in my assessment of the parents and the children were removed by the Department again about one year later after being further subjected to the treatment. I was reappointed by the Juvenile Court to serve as the guardian ad litem. In this subsequent case, custody of the children was ultimately awarded to another family member who could properly care for them.
