At that time, I began working with The Law Offices of Hugh Green in Lebanon. My wife and I had no intention of moving back to Wyoming to practice law. I let my license lapse because I was not going back to Wyoming.

No. Other than as I stated in my answer to Question 3, the State of Wyoming shows my license terminated on 2/28/1994.

I have not been employed in any other profession or business other than the law since I was licensed in October, 1986. I began the practice of law in Chattanooga, Tennessee in August, 1986 just after taking the bar exam. I was sworn in by the Supreme Court in October, 1986. I began working as an associate attorney in Chattanooga with the firm of Hall, Haynes, Lusk & Foster.

In September 1987, my wife and I moved to Powell, Wyoming. I worked with Dick Kahl law offices.

In Fall of 1989, I went to work for Bormuth, Freeman & Fuller in Cody, Wyoming.

In March 1992, we moved from Wyoming back to Lebanon, Tennessee.

On April 1, 1992, I began work with the Law Offices of Hugh Green in Lebanon, Tennessee.

In August 1994, I went into solo practice in Lebanon, Tennessee.

On August 27, 2004, I began the firm of McBrien & Kane with Brody Kane (now 15th Judicial District Criminal Court Judge), Angel Kane and myself.

On August 1, 2018 I opened McBrien Law Group which is where I currently practice.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My trial experience began the first day I started work. I have tried bench and jury trials in almost all of the counties in Middle and Southeast Tennessee and Northwest Wyoming. My trial experience has involved divorce, post-divorce, child custody and support, adoptions and termination of parental rights, personal injury, insurance defense involving personal injury and business matters, construction (for homeowners, builders and developers), boundary line disputes, adverse possession, easement and other land ownership cases, business dissolutions involving breach of operating, shareholder or partnership agreements, breach of contracts,

materialman liens, lemon law, foreclosures, collections of debts, evictions, complex business accounting and transaction litigation. Also, employee termination involving non-compete, non-disclosure agreements, and severance agreements.

I have tried cases involving breach of contract, unjust enrichment, Tennessee Consumer Protection Act (both as Plaintiff and Defendant), intentional interference with a Business Contract/Relationship, fraud, negligent and intentional misrepresentation, slander/liable of title, will contests, probate litigation involving creditor claims, Department of TennCare claims, abuse of powers of attorney, conservatorships and validity of wills.

As to criminal matters I have tried bench and jury felony and misdemeanor criminal charges (in both state and federal courts) which involved various drug related charges, assault, aggravated assault, possession of firearms, domestic assault, improper sale of secured property, theft, burglary, aggravated robbery, driving under the influence, reckless driving and driving without a license and other criminal cases.

In juvenile matters I have been appointed and privately hired to represent children and parents involving delinquent, dependent and neglect, truancy, charges involving burglary, assault, escape from a detention center, drugs and alcohol, run away, gun possession, vandalism, and shop lifting.

I have appeared and argued 12-15 cases in the Appellate Court for the Middle District of Tennessee. These appeals have involved breach of contract, property ownership involving easements, rights of way, adverse possession, interpretation of deeds, construction contracts and fraud, negligent misrepresentation, Tennessee Consumer Protection Act, real estate transactions involving damages, deeds with an automatic reverter and fee simple determinable.

Several of the appellate cases involved divorce and post-divorce issues. These cases on appeal addressed the division of marital and separate property, alimony, calculation and division of military retirements, commingling and transmutation of separate property, visitation/parenting time, termination of visitation/parenting time, contempt and the enforcement of a prenuptial agreement.

I have represented many clients in transactional matters involving purchases of business stock, limited liability company membership interests, partnership interests, commercial leases, letters of intent, co-packing contracts with national brands, employment and severance agreements for business and employees, the sale and purchase of businesses, mergers, the review and sale of technology. I have prepared independent contractor agreements, non-disclosure and non-compete agreements, incorporated sub-S corporations, limited liability companies and non-profit organizations, independent contract / 1099 agreements, and IRS sec. 1031 Like Kind exchanges. During my practice, I have prepared and or updated corporate by-laws, minutes, charters, stock powers, officer resignations, changes to registered agent and registered office, shareholder redemption, partnership and operating agreements.

I have represented clients regarding Social Security Disability claims and appeared at hearings before Administrative Law Judges and Boards of Appeal on their behalf. I have appeared on

behalf of client in front of Lebanon City Counsel, Wilson County Commissioners, Wilson County Planning Commission and the Board of Zoning Appeals. I have appeared before the Tennessee Occupational Safety and Health Administration regarding safety inspections. I was counsel for several Nashville cab drivers regarding their licenses and transferability in front of both the Board and City Council.

I have appeared before the Tennessee Department of Safety regarding forfeitures in criminal cases and suspension of driver's licenses.

At the present time, Judge Wootten hears both criminal and civil cases. I know my legal experience, and what I have learned over these 33 years, will allow me to quickly and effectively manage the Circuit Court docket.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

While in Wyoming I represented grandparents in the first grandparent visitation case in Wyoming. I was unable to argue the case in front of the Wyoming Supreme Court due to returning to Tennessee. However, my clients' grandparent visitation was upheld.

I represented a local business owner in a corporate dissolution between two equal owners of a multi-million dollar company. The case involved very complex accounting and business evaluations, allegations of fraud, breach of fiduciary duty, embezzlement and dissolution of the company. We were able to completely disprove all the allegations and were able to successfully purchase the Company. In doing so, over 40 jobs were saved and the business has continued to grow to supply its customers nationally.

McFarland v. McFarland, 2007 Tenn. App. LEXIS 509, the husband owned his farm prior to the parties' marriage. In fact, we were able to show that the husband's family had owned the farm since the original land grant from the State of North Carolina. Also, the parties were receiving or would receive a military retirement which involved complicated calculations for the division of the marital portion. After a trial, both parties appealed issues to the Court of Appeals. The Court held that there was not a transmutation of the family farm even though the wife had made contributions to the house. Due to the market driven forces in the area, neither parties contribution to the farm affected its value. The appellate court remanded the case to the trial court with directions to vacate the portion of the final divorce decree valuing and dividing the parties' interest in the wife's military pension. The appellate court affirmed the remainder of the judgment for the husband.

In <u>Raines v. Raines</u>, M2002-01952-COA-R3-CV, the Court upheld the ruling in favor of my client regarding the transmutation and commingling of separate assets which the trial court found to be marital property.

In White v. Early, 211 S.W.3d 723, which is a reported case, the plaintiffs filed the action against the defendant marina owners and my client who was a previous owner of a boat slip, alleging fraudulent misrepresentation, breach of contract, and violation of the Tennessee Consumer Protection Act. The trial court found for the plaintiffs, finding that the defendant marina owners made fraudulent misrepresentations and that the defendant slip owner transferred rights that were illusory. On appeal the Trial Court was overturned and held that valuable rights were transferred and that the damages to the plaintiffs were not caused by the allegedly fraudulent misrepresentations.

In the Estate of Ora Sloan Blankenship, the personal representative proceeded to administer the Decedent's estate submitting a holographic will. My client filed a response asserting that the decedent was not of sound mind at the time of the execution of the will, that she was unduly influenced to sign the will and the will was not property executed. During the jury trial we presented numerous witnesses, including a hand writing expert. The jury returned a verdict in favor of my clients on all issues. The administrator subsequently filed a motion for a new trial. Ruling on the motion for a new trial, the trial court found that there was insufficient evidence to support the jury's finding that the alleged will was obtained through Sloan's undue influence. However, the trial court found sufficient evidence to support the jury's conclusion that the document was not a properly executed holographic will and ordered the estate to proceed intestate. The administrator appealed. The Court of Appeals did not issue a formal ruling pursuant to Rule 10(a) of the Appellate Rules of Procedure. Rule 10(a) allows the Court, if all of the judges are in agreement, to find that the jury verdict would stand and a ruling would not further the rule of law. The Appellate Court stated that there was material evidence to support the verdict of the jury and affirmed the judgment, overruling the Trial Court.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

From August, 1994 to August 27, 2004 I managed my own practice which involved 1-2 paralegals while handling cases in Chancery, Circuit and Federal courts throughout Middle Tennessee. My cases involved civil, criminal and juvenile issues.

On August 27, 2004 I became a partner at McBrien and Kane with Brody and Angel Kane. I continued to handle cases throughout Tennessee. We had three attorneys and four paralegals.

I was asked to sit as a Special Judge for General Sessions Judge John Gwin to hear Orders of Protection.

I have been mediating cases for other attorneys for over 6 years. These cases have involved business ownership disputes, family law (asset and debt division, parenting time, alimony and child support), veterinary malpractice, personal injury, will contests, employer/employee severance and non-compete agreements, contractual interference with a business relationship, debt collection and construction. Mediations have been with attorneys and pro se. I have had several mediations last for two to three days in order to work through the issues.

Throughout my thirty-three year practice of law, I have strived to understand and incorporate the needs of the parties within the boundaries of the law. My parents raised us to listen and see

people for who they are and have compassion for them. They taught us to never look down on anyone and to strive to understand them without quick conclusions.

I am very familiar and work well with all of the judges in this district and the clerks. I know that I can work with the judges in managing the court dockets and case load without interruption.

Since I began conducting mediations, involving all types of litigation, I have truly enjoyed working through the factual issues to resolve the case. My ability to listen to the parties dealing with complex personal and legal issues, and reliance on my legal experience, helped me to determine the issues to be resolved.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking the position of Circuit Court Judge for the 15th Judicial District consisting of Wilson, Macon, Smith, Trousdale and Jackson counties. There are three circuit court judges. Judge John Wootten hears civil and criminal cases in all five counties and in the one-year period ending June 30, 2018 had heard 1,220 cases. With my 33 years of experience in both civil and criminal litigation, I know that I can handle these types of cases. Throughout my career I have spent many long nights and weekends preparing for trials, drafting documents and managing my practice. Based on my work ethic and experience, I believe there will be no impact or need to change the current system for this district. However, if a change were needed, (for example I would be needed to handle domestic cases as well), then my experience would allow me to do so without any issues.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

I believe that at the core of the judicial position the Court has to follow the law even though his personal feelings or beliefs are different. A judge is not given this position to legislate or impose his own feelings. The judge has to listen to the evidence and apply it to the law regardless of personal belief.

As an attorney, I have represented mothers and fathers regarding a parent relocating to another state with the party's children. Being a father who is very involved with his children, it has conflicted with my personal experience to argue on behalf of the mother that she should be allowed to move with the children. However, I have not allowed my personal feelings interfere with the representation of my client. The law allows for parents to move with their children and each parent has the right to have the matter heard fairly and impartially. I know that I can bring that to the litigants that would appear before the court.
