#### 1. State your present employment.

#### Solo Practitioner:

Since November 2020, I have maintained a solo civil practice serving clients in Shelby, Tipton, and surrounding counties. The practice concentrates on estate planning, family and juvenile law, business and contract matters, landlord-tenant disputes, land use and zoning regulation, and preliminary evaluation of tort claims. In addition, I am appointed as a part-time public defender in the 25th Judicial District, representing indigent respondents primarily in Juvenile Court proceedings and occasionally in General Sessions criminal matters. This work emphasizes procedural fairness, client advocacy, and fidelity to applicable law and ethical obligations.

No. There has been no denial of admission, suspension, or placement on inactive status by the Bar of any State.

Following completion of legal education in May 2017, a limited practice license was obtained under Tennessee Supreme Court Rule 7, Section 10.04, and utilized for approximately 18 months. During that time, legal work was performed under the supervision of William W. Jones IV, with a focus on estate planning, family law, and civil litigation.

After the expiration of the limited license, legal employment paused so as to focus solely on passage of the Uniform Bar Examination. From June 2019 through the July 2020 administration of the exam, part-time clerkship assistance was provided to attorney Gary Jewel, supporting litigation matters during the COVID-19 pandemic. Upon bar admission in 2020, a solo civil practice was established in Memphis, which has been maintained since that time. Additionally, appointments have also been accepted in the 25th Judicial District as a public defender, primarily in Juvenile Court.

Outside of the legal field, past roles have included service as an Assistant Site Coordinator for the Memphis in May International Festival (2007–2010; 2018–2019), working with municipal agencies, vendors, and regulatory officials to ensure public safety, logistical coordination, and regulatory compliance. Additional experience includes work with a private entity contracted to assist the City of Memphis in the liquidation of municipal assets at the impound lot, as well as prior operational support for a national event marketing firm.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

The present practice is a solo civil practice with primary concentration in estate planning (20%), business law and governance (20%), and contracts and agreements (20%). These matters involve drafting, advisory services, negotiation, and limited litigation. Family and juvenile matters, including uncontested divorces, custody agreements, and Juvenile Court representation in dependency, neglect, and contempt cases, account for approximately 20 percent of the practice. Landlord-tenant disputes and lease-related work constitute about 10 percent, while land use and zoning representation, including permitting, site plans, and environmental court proceedings, accounts for approximately 5 percent. An additional 5 percent of the practice involves preliminary evaluation of personal injury claims, including automobile accidents and premises liability, with viable cases referred out as appropriate. Across these areas, the practice emphasizes strategic analysis, document clarity, and focused advocacy.

 Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Since admission to the bar in 2020, regular experience has been developed across a range of Tennessee trial courts in both rural and urban jurisdictions. Court appearances have occurred in Shelby County Circuit, Chancery, General Sessions, Juvenile, Environmental Court, and before the Divorce Referee; Tipton County Circuit, Chancery, General Sessions, and Juvenile Courts; Fayette County General Sessions (including traffic matters) and Chancery Court; and Davidson County Probate Court. Additional appearances have been made in Bartlett, Germantown, and Collierville Municipal Courts. Most proceedings involve contested motion practice, evidentiary hearings, or bench trials, with uncontested dockets comprising a small percentage of the caseload. On average, one to two in-court matters are handled each week. More than 140 appointments have been accepted under the Administrative Office of the Courts indigent representation program, primarily in Juvenile and General Sessions Courts. In private practice, approximately 120 client matters have been handled across civil, criminal, probate, and estate categories. In total, I have handled approximately 230 cases over my legal career.

Appellate experience includes multiple cases appealed from General Sessions to Circuit Court, as well as one matter dismissed in favor of the client before the Tennessee Court of Appeals in 2025. That appeal was resolved based on written submissions without the need for oral argument, following expiration of the opposing party's procedural timeline. While direct appellate litigation comprises a smaller portion of the overall practice, it reflects familiarity with procedural preservation, briefing, and issue framing. Prior legal education included formal coursework in appellate advocacy, and recent experience has reinforced working knowledge of appellate process and strategy.

Administrative and quasi-judicial appearances have included matters before the Shelby County Land Use Control Board, the Office of Planning and Development, the Zoning Board of Adjustment, Shelby County Code Enforcement, the Shelby County Health Department, and the Tennessee Board of Nursing. Legislative and policy advocacy has included representation before the Shelby County Commission and its subcommittees in land use, zoning, and permitting disputes on behalf of local business owners and community interests.

The practice also includes a substantial transactional component, encompassing contract drafting and negotiation, entity formation, and estate planning. Transactional matters constitute a significant portion of day-to-day responsibilities and support both individual and organizational clients.

# Permit Application No. SUP 14-219 - Memphis Stone & Gravel

Shelby County Commission (2014–2019)

Although not acting in the capacity of legal counsel, I played a sustained and active role as a citizen advocate in helping defeat the long-protested special use permit sought by Memphis Stone & Gravel to operate a commercial gravel mine near the rural Rosemark community in Shelby County. Over several years, I coordinated public engagement, supported local counsel with strategy and messaging, and directly liaised with the Shelby County Commission to articulate the environmental, traffic, and public welfare concerns held by a large segment of District 1 constituents. The application was ultimately rejected by the Shelby County Commission following public hearings. This experience reflects an ability to understand and influence quasi-judicial proceedings in zoning and land use, while maintaining civically engaged leadership in matters affecting public interest.

# Case No. PD 2022-003 CO - Barret Road Planned Development

#### Shelby County Commission (2022)

In this matter, I served as legal counsel to both the property owner and the business operator of the historic Barretville General Store in a successful application for a planned development under Chapter 9.6 of the Unified Development Code. The application sought approval of an outdoor entertainment pavilion and expanded gravel parking lot. My responsibilities included drafting and presenting the application, managing all public hearing appearances, and addressing public opposition grounded in traffic, sound, and land use concerns. The application received a unanimous recommendation from the Land Use Control Board and was approved by the Shelby County Board of Commissioners in May 2022. The matter required legal precision, political coordination, and sensitivity to the historical and residential character of the community. This project showcases the ability to deliver structured advocacy and achieve successful administrative outcomes on behalf of small business clients.

# W2024-00925-COA-R3-CV - James A. Wilkins, Sr. v. Thomas Jackson

#### General Sessions – Circuit Court – Tennessee Court of Appeals (2023–2025)

This matter originated as a forcible entry and detainer action in Shelby County General Sessions Court but quickly evolved into a multi-tiered dispute over the rightful ownership and possession of a commercial property. I represented Mr. Jackson, the occupant and good-faith purchaser of the property, in contesting claims made by the plaintiff, who asserted superior title and contractual rights. Judgment was entered in my client's favor in both General Sessions and Circuit Court. The plaintiff then appealed to the Tennessee Court of Appeals, where I preserved all relevant issues for

review and prepared the appellate brief. The case was ultimately dismissed in my client's favor due to procedural expiration of the appellant's obligations. Though no oral argument occurred, the litigation required sustained legal advocacy, careful record development, and strategic framing of property and contract law issues. It reflects appellate competency, disciplined trial-level preparation, and the ability to manage civil litigation from inception through final disposition.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

Since bar passage in late 2020, I have routinely mentored individuals preparing for the Uniform Bar Examination. Each year, I have worked with one or two applicants, offering structured guidance through study planning, practice questions, and accountability meetings. Several of these candidates had experienced unsuccessful attempts, and I have focused on helping them push past discouragement and continue their pursuit of a career in the legal field. In addition, I have supervised student interns from the University of Memphis Bachelor of Paralegal Studies program, allowing them to gain practical experience in case preparation, document drafting, procedural research, and client communication as part of their academic requirements.

I also serve as a part-time public defender in the 25th Judicial District. In that role, I represent indigent respondents in Juvenile Court and, at times, in General Sessions proceedings. This work emphasizes access to justice, accountability to the court, and professional responsibility in high-volume legal environments.

My practice also reflects a strong integration of technology with traditional legal values. While I consider myself an old soul in many respects, I have always embraced evolving technology. I remember the sound of dial-up internet, but I also appreciate the efficiencies that modern tools can bring to law practice. I use legal technology platforms to enhance document drafting, case management, research, and secure client interaction. This includes the use of artificial intelligence systems to assist with background research, citation checking, and formatting, while maintaining full professional control and responsibility over all outputs.

The process of guiding others through the Uniform Bar Examination has also served to reinforce my own understanding of foundational legal doctrines. That continued exposure has helped me maintain fluency in a broad range of legal principles, in contrast to the narrowing effect that may occur when a practitioner works in a single area for an extended period. It is this breadth, combined with service and discipline, that I bring to the bench if given the opportunity.

I received my Bachelor of Arts degree from the University of Memphis in May 2010, with a concentration in History and a particular academic interest in military and political history. My undergraduate studies also included a brief period of part-time coursework at Southwest Tennessee Community College.

I initially attended Mississippi College School of Law in 2011 but returned in 2014 to complete the program, a path that strengthened my personal resilience and professional focus. I earned my Juris Doctor degree in May 2017. My legal education included international coursework in Beijing, Shanghai, Seoul, and Berlin, and encompassed a broad curriculum including Federal Appellate Advocacy, Bankruptcy, Family Law, Intellectual Property, International Law, Election Law, Sports and Entertainment Law, and Expert Witness Testimony. I was named to the Dean's List in my final year and was active in several student organizations, including the Family Law Society, Sports and Entertainment Law Society, Christian Legal Society, and Phi Alpha Delta.

The complainant alleged that I failed to complete an expungement and improperly invoiced for services. Following a full investigation, the Board determined that I had acted properly and dismissed the

complaint. The complainant then appealed that decision. After review, the Board's Chief Disciplinary Counsel affirmed the original dismissal, again finding no violation or misconduct. No sanction, reprimand, or corrective action was issued at any stage.

### 28. What are your reasons for seeking this position? (150 words or less)

I seek a position on the Circuit Court for the 30th Judicial District, where I regularly appear in matters involving torts, contract disputes, declaratory actions, and other civil litigation. My practice aligns with the court's jurisdiction both in complexity and scope, and I understand the demands of managing an active trial docket in Shelby County. In addition to my litigation experience, I mentor newer attorneys and law students, which keeps me engaged in the foundational principles of multiple practice areas and sharpens my approach to emerging legal issues. I would bring a steady temperament, strong procedural discipline, and a respect for the role of the court as a neutral arbiter. My background has prepared me to manage both the courtroom and the case flow with diligence and structure. I would serve the bench with consistency and a clear understanding of the law's function in resolving disputes.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I seek a position on the Circuit Court for the 30th Judicial District, which handles a wide array of civil matters including torts, contracts, and estate litigation. The bench is composed of respected jurists with varied experience, and I would bring a perspective shaped by broad, trial-level civil practice and regular appearances in courts throughout the district. My work spans family law, probate, and chancery, allowing me to view disputes with both technical clarity and practical insight. I also mentor younger attorneys, which reinforces my command of foundational legal principles across disciplines. I would serve with steady temperament, restraint, and a deep respect for the boundaries of judicial power. The court should reflect the diversity of experiences found in the communities it serves. My addition would help maintain that balance while bringing a consistent, methodical, and principled approach to decision-making.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. A judge must apply the law as it exists, not as they might wish it to be. Judicial integrity depends on remaining impartial, even when the law compels outcomes that are personally difficult or unpopular.

As appointed counsel in Juvenile Court, I regularly represent indigent clients in dependency and neglect matters. In these cases, I have advocated for the return of children to parents whose lifestyles or moral character I personally found troubling,


even if not legally disqualifying. In one case, I fought for a father's reunification with his child despite believing she was not someone I would entrust with my own. The law requires proof of specific harm or statutory grounds, and none were met. While I questioned her judgment and fitness in a broader sense, I recognized that my role was to apply the legal standards, not impose personal ideals.

That tension is common in courtrooms. I have also defended criminal clients where the facts were distasteful but the burden of proof was not met. In each instance, I respected the rule of law over individual sentiment.

As a judge, I would uphold that same discipline. The law must be predictable and consistently applied, even when the result does not align with my personal views. That is what protects the public, the litigants, and the reputation of the judiciary itself.
