Practice areas included: criminal defense in all state courts; civil litigation in general sessions and circuit court; divorce and domestic relations in juvenile and chancery courts; child support contempt in juvenile, chancery, and circuit court; dependency and neglect matters in juvenile court; termination of parental rights in chancery court; estate planning and probate; business formation and incorporation, contracts, individual and corporate tax preparation, audit defense, U.S. tax court petitions, and deed preparation; appellate work to court of appeals, court of criminal appeals and Tennessee Supreme Court.

Massey</u>, <u>Pulaski</u>, <u>Tennessee</u>, <u>Associate Attorney</u>: Practiced law with an attorney with 33 years of experience to gain additional training from an experienced attorney. Worked on first appellate cases, provided assistance to the senior attorney on his cases, and worked my own caseload, which I was wrapping up from my own firm, in addition to new cases from Mr. Massey's firm.

2019–Present, Self-employed, Meadow Green Hall LLC: Bought an event center and manage it hosting conferences, concerts, weddings, memorial services, birthday parties, and festivals.

<u>2019</u>—Present, Self-employed, Foxwood Properties LLC: Started my own residential real estate company and rent out homes in the Middle Tennessee area.

<u>2023</u>—Present, Assistant Public Defender 32<sup>nd</sup> Judicial District serving Hickman, Lewis, and Perry counties: Represent indigent clients in all criminal courts—general sessions, circuit court, and appellate courts.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Assistant Public Defender in 32<sup>nd</sup> Judicial District; practice area is 100 percent criminal defense. A lot of time is spent working with clients and their access to rehabilitation programs, mental health services and facilities, and other invaluable help to assist fragile individuals in the 32<sup>nd</sup> judicial district in finding resources to improve their lives.

On any given court date I represent 12 to 20 individuals and research their backgrounds; review the charges against them and the law associated with the legal matter(s); meet with the client, police officers, family, victims, witnesses, and other relevant parties; perform research of fact and law; and attempt to reach a resolution with the district attorney's office, or if we cannot reach a resolution, have a hearing or trial to resolve matters in front of a judge.

A great deal of time is spent at the jail discussing matters with clients, as they are often in custody of the sheriff's department and cannot make bond.

I will often work with clients' families to keep them informed and to try and work as a team to get the best resolution for my clients.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have represented approximately 3,500 people in private practice at my own firm and the law office of Robert D. Massey over 10 years in the areas of criminal defense, civil law (to include landlord–tenant, contract disputes, car accidents, and family law [including divorce, child custody, termination of parental rights, child support contempt and modifications], estate planning such as wills and other estate documents, and probate court, where we addressed issues such as conservatorship, property division in a will, drafted deeds, prepared individual and corporate tax returns, defended individuals in audits at the federal level, filed and argued petitions in U.S. tax court and have been admitted to U.S. tax court since 2019.

I was appointed to and resolved more than 2,200 appointed cases for judges in 13 counties and was appointed to general sessions, circuit court, appeals to the court of appeals, and court of criminal appeals, dependency and neglect cases where I represented parents or served as the guardian ad litem and represented a child's interests, and as guardian ad litem in estate cases where I represented elderly, often fragile people in navigating their estates and the probate court.

I've had 11 criminal jury trials in circuit court on criminal cases, including attempted first-degree murder, child rape, aggravated robbery, aggravated assault, felony harassment of a governmental official, aggravated burglary, theft over \$10,000, and other crimes. I've been successful in more than half my jury trials.

I've had civil trials in general sessions and circuit court.

I've had termination of parental right trials in chancery court.

I've represented people in federal audits that spanned multiple years and met with the Internal Revenue Service multiple times in Knoxville, Tennessee on behalf of clients.

I filed petitions on behalf of every single drug-free-zone-conviction client I had represented over the years that allowed them the opportunity to be resentenced under the new drug-free-zone laws and helped them reduce sentences from 100% sentencing to lower percentages and handled four clients' cases in Maury County on the same day after the law changed.

Typically, I would attend court 275 to 300 times a year (20–30 times per month) in 13 counties, often going to court in 2 to 3 places per day, 3 to 4 days per week to cover all the cases I was appointed to or hired on.

I strived to never tell a judge "no" when asked to take an appointed case, which got me appointed to everything from simple possession to first-degree murder.

I understood that the judges were under pressure to resolve their dockets and needed people to take appointed cases and that many attorneys would not be willing to assist.

Some of the busiest years, I resolved up to 335 appointed cases per year in addition to privateretained cases.

I worked typically 50 to 65 hours a week or more in private practice, where a typical day was going to 2 to 3 courts and heading back to the office in the afternoon, meeting with clients and doing paperwork, often until 8 or 9 p.m. during the week. I worked many weekends over 10 years in private practice and still work weekends occasionally, when needed, as an assistant public defender for the State of Tennessee.

Working with Bob Massey gave me insight from an attorney with 33 years of experience, which increased my education and gave me invaluable training that would have taken years to develop otherwise on my own without a mentor to work with day in and day out. Bob Massey and I would work from 7:30 a.m. to midnight often and would hardly ever leave the office before 8 or 9 p.m.

Working for Bob Massey provided invaluable experience. I will always appreciate the opportunity to learn from someone with the wealth of experience and standards of excellence that he has.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I have been successful in 6 out of 11 criminal jury trials, which is significantly higher than the national average for criminal jury trials.

I have never had a board complaint that was not quickly resolved as a cap complaint or ultimately dismissed and have never been disciplined in 12 years as an attorney.

I have never sued a client for fees or any other matter.

A client has never sued me.

I have never said "no" to a judge when asked to take an appointed case.

I resolved more than 2,200 appointed cases for the state of Tennessee over 10 years.

I would provide more than 100 hours of pro bono legal service each year to people in need who could not afford an attorney.

I held my own pro bono estate-planning clinics and did free estate plans for families of modest means in Summertown, Tennessee, and surrounding areas.

I never withdrew from a case due to the client's failure to pay and represented my clients' cases to completion regardless of their ability to pay.

I strived to be beyond fair, to a fault, to all parties in all legal matters, state or private attorneys and their clients, and do what was best for all involved within the parameters of the law and to treat the other parties and their clients with respect and integrity.

I was a member of the Middle Tennessee State University Policy Debate Team from 1999–2003 and was awarded a full scholarship to get my master's in business administration (MBA), as well as a graduate teaching assistant (G.T.A.) position for the speech department. I became the Assistant Director from 2001–2003. Many of our topics involved research, including law review articles, international treaties, and federal case law and administrative agencies.

Most of the topics in policy debate involved situations where international laws and treaties were in review, and conflicts of different types (such as political or economic) existed between nations and had to be resolved.

This is where I learned to analyze different countries' laws and policies regarding working through fundamental problems and gained an appreciation for how different countries and regions dealt with fundamental issues we live through regularly such as education, natural

resource management, economy, food scarcity, and other topics relevant to co-existing as an international community.

I seek a judgeship in the 32<sup>nd</sup> District of Tennessee where the docket comprises primarily felony criminal cases and domestic relations cases (divorce, child custody, and child support contempt), but also Probate and Estates, boundary line disputes, civil litigation, Appeals out of Juvenile Court and General Sessions, Orders of Protection, Emergency Restraining Orders, and Termination of Parental Rights cases..

As Judge, I could offer broad, extensive local experience—representing more than 3,200 people in Court in all areas of the law that the Judgeship would cover.

I would improve the quality of our District by continuing the work that Judge Spitzer has done with TN ROCS and Mental Health Court, creating a Drug Court, and working with my team to secure funding for as many new projects and positions possible to benefit the District and its citizens.
