I have only been licensed in Tennessee. I was licensed in Tennessee on November 10, 2004, BPR #023966 and my license is "active."

No, I have not been denied admission, suspended or placed on inactive status by any Bar.

After graduating from Univ. of Tennessee School of Law in May, 2004 and successfully taking the July 2004 Bar Exam, I accepted a position as an associated attorney at Harvill & Associates, PC in Centerville, Tennessee. While working at Harvill & Assoc., I was mentored and gained invaluable knowledge about the practice of law not only from the attorneys I worked with but the attorneys in our community. Harvill & Assoc. was a general practice law firm and as an associate I handled general session, juvenile, chancery and circuit cases primarily in Hickman, Lewis and Perry counties as then part of the 21st Judicial District. I also handled real estate transactions such as cash purchases, lender funded transactions, and refinances. I also started handling indigent representation - representing parents in dependency and neglect proceedings, termination of parental rights cases, court of appeals regarding termination cases, served as the

guardian ad litem in dependency and neglect and termination cases, represents child support contempt defendants, represented criminal defendants in sessions and circuit court, and as guardian ad litem for the ward in conservatorship cases. I also became a licensed title insurance agent through the State of Tennessee and wrote title insurance for Old Republic which I continue to do to date. I worked at Harvill & Associates through September, 2022 and then I opened my own law practice of Holder Law & Title, LLC. After starting Holder Law & Title in September, 2022, my practice shifted into more real estate transactions and probate, will, estate matters while still handling family law and juvenile court cases.

In between my first and second year of law school, I worked for attorney Rick Wood's law office in Parsons, Tennessee assisting in legal research, preparing deeds, general law office work, and scheduling client meetings. During my 2L and 3L years, I was a teaching lab assistant in Excel/Accounting for Introduction to Business Transactions and Legal Research courses.

During breaks from school, I worked for Johnson Controls (now NYX) in Linden as a general assembly line worker for automotive car parts, I interned at Perry Community Hospital in Linden in the physical therapy department, worked at Univ. of Tennessee at Martin as computer lab assistant and tutor for college students, and worked ad hoc in the Perry County Register of Deeds office all in between my Junior year in High School and 1L year in law school.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Currently, my areas of practice focus on real estate transactions with regular transactions precipitated from lenders/banks, realtors, prior clients, probate cases, preparation of wills, deeds, family law cases such as divorce, paternity, child support, termination of parental rights and adoption, and juvenile court dependency and neglect practice.

My practice is roughly real estate transactions about 50%, family law 15%, probate 25%, and juvenile court practice 10% at this time.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

In general, I have been a general practice attorney in Hickman, Perry and Lewis Counties. I am generally in the Circuit/Chancery motion court days in Hickman and Perry and some Lewis County dates and have been my entire 20-year practice. I have tried multiple divorce cases regarding grounds, division of assets and liabilities, parenting plan and other issues. I have tried many dependency and neglect cases, including several appeals to Circuit Court. I have tried multiple termination of parental rights cases and appealed some of those cases. Earlier in my career, I was more frequently in General Sessions Criminal and some Circuit Criminal courts for all three counties regularly. I have represented clients from cases such as detainer warrants,

disputes regarding personal property. I have represented defendants in preliminary hearings and bond hearings. I have done appellate work regarding termination of parental rights cases on approximately four cases.

As a Board of Professional Responsibility Hearing Committee member, I have primarily reviewed request for dismissals.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

During my practice, I have had the experience of representing difference "sides" of a contested termination of parental rights cases that ultimately resulted in a reported case and I successfully overturned a trial court ruling in another case.

My first appeal as a licensed attorney was *In re Giorgianna H., 205 S.W.3d 508 (Tenn. Ct. App. 2006)*. I was not trial counsel for this case but was asked to take the appointment for the Father in this termination appeal. To my knowledge, I had not tried a termination of parental rights case at that time. Also, during the time of this appeal, an appeal of the underlying dependency and neglect finding was on appeal as well. It provided an opportunity for immersion in an area of law that I was not totally familiar with, nor did I expect to enjoy practicing. Despite not overturning the trial court on all issues, it cemented to me the importance of procedurally having a case tried in the proper manner and it continues to be cited to date.

On the other side of this type of litigation, I appealed a denial of a termination of parental rights case and successfully overturned the trial court's best interest analysis in the case *In re Autumn L., No. M2018-01184-COA-R3-PT, 2019 Tenn. App. LEXIS 73 (Ct. App. Feb. 8, 2019)* 

Throughout the years, I have handled many terminations of parental rights cases from being the Petitioners' attorney or representing the Respondent and have been successful in both capacities. Being appointed to the case that ended up being In re: Giorgianna H. while not sought out, turned out to be an invaluable experience in the beginning of my legal career.

After my first year in law school, I worked for Wood Law Offices, Hon. Ricky Wood, in their Parsons, Tennessee office. At that time, I had not worked in a law office before and did not really have any experience with an attorney's office. I was able to be involved in a general practice, rural law office and was impressed by the ability to being able to help persons in different areas in the law in a small community.

I was a candidate for the elective position of Perry County General Sessions Judge in August, 2014 and August, 2022.

## ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

The position of Circuit Court Judge was not a position I considered until Fall, 2022. Until that time, Perry County was in the 21<sup>st</sup> Judicial District which was comprised of Williamson, Hickman, Lewis and Perry Counties and the population disparity would not favor someone from Perry County running for that position. In practicing in Court on a frequent basis, I have learned the value of having a Judge with integrity, discernment, judicial temperament, and legal knowledge/experience. I believe I possess those characteristics. Our judicial district requires someone that will travel the district and that can manage the Court Dockets as a single-judge district. I want the 32<sup>nd</sup> Judicial District to be successful and believe I can benefit the 32<sup>nd</sup> District if appointed. With our recent division from Williamson County and those resources, I would like to further the programs and resources available to these counties.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

This judgeship is for the recently created 32nd Judicial District which serves Hickman, Lewis and Perry Counties. It is a single Judge district. Although the population size of the district is relatively smaller, the caseload is healthy and travel to each county is required. The 2023-2024 Tennessee Judiciary Annual Statistical Report of the Tennessee Judiciary shows that 614 new cases were filed civilly (probate, divorce, child support largest categories) and 80 Circuit Civil were filed (majority general civil litigation) and 1,719 criminal cases were filed (largest categories being drug and motor vehicle related).

I grew up in this District and worked my entire 20-year legal career in this District. I travel

these counties daily and am in this District's Courts routinely. If selected, I will successfully meet the geographic and motion/trial docket requirements for the position while being able to relate to the parties and attorneys before the Court.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, I will uphold the law even if I disagree with the substance of the law at issue. I believe this is a fundamental requirement for any judicial applicant.

An example from my experience with a law that I have personally disagreed with comes from termination of parental rights grounds and the willfulness component that was part of the statutory definition of abandonment found in T.C.A. §36-1-102. It has been a longstanding struggle in termination of parental rights cases to prove willfulness of biological parent's conduct required for abandonment especially if the parent is absent, will not comply with discovery requests, and/or does not testify in a forthcoming manner. Recently, there was a change to the definition section stating that "The parent or guardian shall bear the burden of proof that the failure to visit or support was not willful. Such defense must be established by a preponderance of evidence. The absence of willfulness is an affirmative defense pursuant to Rule 8.03 of the Tennessee Rules of Civil Procedure" T.C.A. § 36-1-102(1)(I). I personally always felt that a burden shift made sense in this statute. I have complied with the law as written depending on which party I represented and believe this recent change by legislation is appropriate.
