In March of 2025 I received permission to practice in Alabama pro hac vice. Alabama does not issue a bar identification number for PHV admission per se. ALAFILE (Alabama electronic filing system) tracks PHV attorneys through the associated local counsel's bar number which is LAN91. I began my legal career immediately upon being sworn into the practice of law in October of 1992. I associated with two other attorneys in a shared office environment, each having responsibility for their respective practice. I have been in solo practice since that time. I started in Davidson County then moving my practice to Williamson County and now with an office in Williamson County and Hickman County.

I am currently admitted on a pro hac vice basis in Alabama Circuit Court Northern District regarding a breach of contract allegation. This has afforded me the opportunity to understand and experience other jurisdiction processes and procedures. In doing so, various aspects of the

lawsuit provide me with an expanded knowledge base that enhances my overall practice of law.

While in law school and prior thereto, I worked as a senior design engineer with Nissan Motor Manufacturing located in Smyrna, Tennessee. In my capacity I was responsible for overseeing five other engineers and had responsibility for the interior design and build out of the interior of various vehicles being produced at the Smyrna facility. As part of my responsibilities, I reviewed pricing contracts, build timing schedules and agreements related to the cost and expense of design, prototyping, tooling and production of interior parts. An example would be that the budget for the interior seats of the first Nissan Altima built in Smyrna, the last project I worked on in 1991, was in the millions of dollars. As another part of my work, I was very involved with the relocation and production set-up of various manufacturing facilities from Japan to the United States. These facilities were located throughout the mid-west and southeast. The interworking of automotive manufacturing on an international scale was an incredible opportunity and provided a fundamental work ethic at an early age.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

The primary focus of my current practice is civil litigation in nature. I have, however, been involved in various criminal proceedings over my 32 years of being an attorney. Currently my focus is on various issues related to real estate such as easements, boundary disputes, title disputes and related contract work which comprises approximately 40% of my workload. The balance of 60%, is comprised of probate and estate matters which is about 30%, domestic law being 20% and the remining 10% being misdemeanor criminal in nature.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My time as a licensed attorney began in the basement of the old Howard School in Davidson County Juvenile Court with Judge Andy Shookhoff. I took appointments in D&N cases from Judge Shookoff. As time progressed, I began doing estate and probate work. Over the past thirty-two years I have tried cases in General Sessions Court, Juvenile Court, Circuit and Chancery Courts throughout Tennessee but primarily throughout Middle Tennessee. I have also appeared in front of the Tennessee Claims Commission as well as the Tennessee Court of Appeals for the Middle District of Tennessee.

I have appeared in the Tennessee Federal Courts for the Middle District of Tennessee as well as the Federal Bankruptcy Court for the Middle and Western Districts of Tennessee. In 1993 I was fortunate to become outside counsel responsible for easement acquisitions for United Cities Gas Company which, at the time was based in Brentwood, Tennessee. I survived the buyout of United Cities by ATMOS Energy and continued to do easement acquisitions and other related work throughout Tennessee until 2024. This allowed me to practice in multiple circuit

courtrooms throughout Middle and East Tennessee as well as numerous jury trials.

My client base represents a varied practice in a wide range of subject matters involving, probate, juvenile, domestic, personal injury, worker's compensation, landlord tenant, contracts, boundary disputes, title closings, LLC / Corporation formation, products liability. I have also initiated and filed a lawsuit related to a products liability action involving the Hague Convention.

My career has entailed courtroom representation in numerous settings regarding various aspects of the law. I have represented clients in Juvenile Court related to dependency neglect proceedings, paternity actions, delinquency and unruly charges both as an appointed attorney and as a retained attorney. In my civil practice I have been involved with courtroom litigation related to family law involving all aspects of divorce and custody from cases based upon irreconcilable differences to highly contentious divorce cases. I have handled contract disputes involving real estate purchases and leases, both commercial and residential. Along with the probating of wills and related matters. In the related area of trusts I have represented clients in contested matters such as undue influence and breach of fiduciary duties.

In the criminal realm, I have been involved in hundreds of misdemeanor cases and several felony cases. My representation has commanded I have a thorough understanding of criminal procedure as well as a knowledge of the rules of evidence. Thanks to Judge Jim Todd, Judge Jim Martin and Don Paine over the years, my understanding of rules of evidence has helped me be successful in the courtroom when I am asked "what's your rule?"

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

While working for United Cities Gas Company as outside counsel, one project in particular I was involved with was the construction of a natural gas pipeline from Interstate I-65 along Highway 412 into the City of Columbia. I was charged with negotiating the acquisition of easements across ninety-two parcels of property of which forty-six parcels were ultimately acquired through eminent domain proceedings filed in Maury County, Tennessee. This work led me to an opportunity to implement an easement acquisition program at Kinder Morgan Energy located in Houston, Texas. I credit the work with United Cities, ATMOS and Kinder Morgan as establishing my career in the mid 1990s.

Perhaps the most significant criminal case that I was involved with was in 2000 with a judgement date of October 2001. The case was out of Sumner County Tennessee in which I represented a Defendant who was charged with aggravated sexual battery by an authority figure. The case presented a twenty-two count indictment involving twelve different victims, all under the age of twelve. After multiple appearances and heavy motion filings the State agreed to reduce the charges to misdemeanor assault with probation.

In 2022 my career as a domestic litigator led me to an eight-day trial which was a highly contentious divorce involving an eighteen-month marriage that produced a minor child who was less than twelve months old on the date of separation. I represented the mother in this

Williamson County proceeding adjudicated by the Honorable James G. Martin, III. I was able to secure not only custody of the child but due to the facts, was able to limit visitation with the father to eighty days per year. The primary issue on appeal involved the failure of the trial court to maximize the father's time with the minor child. While my representation was limited to the trial court level, the trial court was affirmed in all aspects presented on appeal. (*Hunter v. Cooper*, No. M2022-01050-COA-R3-CV).

I was heavily involved Multi District Litigation involving the DOW Corning breast implants, representing twenty-six different claimants here in Tennessee. The representation which occurred over several years ending in 2021, ended with favorable results for all twenty-six clients at various levels of compensation. My involvement with the DOW Corning MDL representation resulted in my participation in a fairly recent ruling through associating with Alabama attorneys to secure a trial court reversal and favorable appellate ruling regarding when the State's Attorney General could get involved under a deceptive trade practices theory versus a private claimant. (Lisk v. Lumber One Wood Preserving, LLC, 792 F.3d. 1331 (2015)).

Perhaps one of the more humorous cases involved my being contacted by a case searcher for the TV show "Judge Judy" which I respectfully declined.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

While not in an attorney/client representative capacity, my experience on the Planning Commission for Hickman County, Tennessee has provided me with an understanding of the effect of growth and expansion in a rural county setting when you have one of the wealthiest counties in the United States next door. The understanding and enforcement of zoning ordinances and restrictions has given me opportunities to "vote" yes or no on issues that may not be so favorable to the applicant but need to be enforced according to what the ordinance states and seeks to accomplish.

The involvement I had with the early development and start-up of The Nashville Food Project, a Tennessee non-profit, allowed me to go through the process of just what it takes to establish a successful non-profit here in Tennessee. The understanding of the consideration given to cost and budgeting are some that I have carried over to my solo practice, primarily, client relationships and cash flow.

Being on the Staff Parish Committee of a large Methodist Church for several years while an attorney allowed me the opportunity to incorporate into my practice a deep understanding of what makes people click. Taking that understanding has assisted me when dealing with difficult clients and situations where there is no real good answer when it comes to telling people what they don't want to hear in a legal setting.

28. What are your reasons for seeking this position? (150 words or less)

Believing firmly in the people of the 32nd Judicial District, I believe I am qualified to be a Judge who understands, listens, discerns and rules on issues folks face on a daily basis. After seventeen years of living in Hickman County, I have seen many issues and can relate to the concerns facing the 32nd District that come with a growing community. The experience I have had over the 32 years of practice has provided a knowledge base that would allow me to effectively rule while maintaining an empathetic demeanor towards those affected. This is the community in which I live. I want the best for everyone through my service and commitment to the individual needs of the community as a whole. My broad experience involving real-life circumstances in rural courts throughout the State will allow me to do so and I feel this would be a benefit the community.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking to be the appointed Judge in both the Circuit and Chancery Courts for the 32nd Judicial District. The appointment is a result of the retirement of the Honorable Michael E. Spitzer as of June 30th 2025. There is only one Judge who rotates between Hickman, Perry and Lewis Counties and is charged with hearing both civil and criminal proceeding in both a jury and non-jury setting. As with many Districts within Tennessee that are comprised of multiple counties, the position would require a level of flexibility to travel between the three counties on a regular schedule that at times would require modification to meet the time frame of multi-day trials. Providing accessibility to the Court is a factor which is paramount when serving the District. The population of the 32nd District needs to know "their judge" is available and approachable.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Taking an Oath is a covenant to be bound by the terms and conditions expressed in the Oath. We are afforded the opportunity to implement law and justice, and I would do just that. Exclusive of personal opinions and outside influences, the law nonetheless would have to be applied such that the law would prevail. It would be my job to ensure the application is implemented on an unbiased and consistent basis. The case previously referenced in Sumner County represents my work when it comes to a matter that, personally, found the facts to be disturbing, yet required my representation in order provide for the rights of my client.

One area of the law which is currently undergoing change relates to "reliable hearsay" when making a determination as to pretrial release and the setting of bail for a potential criminal offender. I feel there exists enough factors upon which to determine an appropriate remedy based upon the facts that existence. Terms within $T.C.A. \ \ 40-11-115$ such as "least restrictive" and "reasonably ensure" pose a level of subjectivity that is open to broad interpretation. This is where it is imperative to have the experience to make a justiciable determination as to what is "least restrictive."

Given the workload of the 32nd District and taking an attitude of "I only work from nine to five" is not something that, as a practicing lawyer I agree with. I have not made a nine to five mentality part of my practice and never will.
