Since being admitted to the bar, I have worked only as an attorney and mediator. Prior to becoming an attorney, I had numerous retail and restaurant jobs during school. When I was in college in Columbia, South Carolina, I coached a local high school dance team and color guard, and I have also worked as a dance instructor and in a retail dancewear store.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I am not presently engaged in the practice of law. I currently serve as the appointed Special Master for the Third Circuit Court for Davidson County, Tennessee pursuant to Tenn. Code Ann. § 17-2-123. The Third Circuit Court is a dedicated domestic court in Davidson County and so 100% of my present work is related to domestic or family law and includes research and writing for Judge Phillip Robinson, conducting judicial settlement conferences and discovery conferences, managing all pro se divorce cases in Third Circuit Court, hearing child support dockets and assisting with hearing order of protection dockets when Special Master Ballinger, the dedicated order of protection special master, is unavailable.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

Following my admission to the bar I was employed as an administrative hearing officer for the Tennessee Department of Human Services, a quasi-judicial role. The hearing officers were tasked with hearing the first level of administrative appeals for various benefits programs administered by the department, which at that time included TennCare, TANF/Families First, SNAP/Food Stamps, and daycare licensing. The administrative hearing officers would hear the cases and then issue orders on each case. The Nashville hearing officers heard cases from all of middle Tennessee. Some hearings were conducted by telephone but we also conducted in-person hearings throughout middle Tennessee.

After leaving DHS I entered private practice and began to focus primarily on family law cases. I have tried various domestic cases including divorces, post-divorce petitions, custody cases, child support cases, contempt matters, adoptions, and dependent and neglect matters. I handled all types of domestic cases from start to finish including motions, pretrial matters, and trial in multiple counties in middle Tennessee circuit, chancery, and juvenile courts. The majority of my work was in courts in Davidson, Williamson, Rutherford, and Wilson Counties although I

had matters in Cheatham, Sumner, Robertson, Montgomery, and Marshall county as well.

My appellate work was limited to drafting briefs for my own cases and as a ghost writer for other local attorneys. All of the appellate matters which I handled during my career were decided on briefs only and all were domestic/civil matters heard in the Tennessee Court of Appeals.

As the Third Circuit Court Special Master I have heard the Court's child support and order of protection dockets, sat special for Judge Robinson on his irreconcilable differences divorce dockets when he was called for jury duty, and conducted all judicial settlement conferences and discovery conferences for matters pending in Third Circuit Court.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

Michael Daniel Fry v Yuriko Shinoda Fry, Tennessee Court of Appeals Case Number M2012-01541-COA-R3-CV – I represented the Wife in a Rule 60 Motion in the trial court and in the Tennessee Court of Appeals on the second appeal of this case, which was successful. The parties were divorced in 2000 and the Wife was awarded half of the Husband's military retirement vested during the marriage. Following the Husband's retirement from the Navy the wife attempted to collect her portion of his retirement directly from the Defense Finance and Accounting Service ("DFAS") but was unable to do so because of faults with the final decree of divorce. She filed an initial motion with the trial court to amend the decree, which the court granted, and the husband appealed. The court of appeals reversed the trial court. Then in 2012 the wife, with my assistance, filed another motion under Tenn. R. Civ. P. 60.02 in the trial court to amend the final decree of divorce. The trial court denied the motion based on the law of the case doctrine. We appealed and were successful on appeal. My client, the wife, was ultimately able to get her awarded portion of her former husband's military retirement directly from DFAS.

I also represented a wife in a divorce matter in Davidson County where there were issues of domestic violence and coercive control. I obtained an ex parte temporary restraining order for my client and her small child and the restraining order was extended after the hearing, keeping the Husband away from the wife and child and the marital home during the pendency of the divorce. The Husband's parents attempted to intervene by filing a petition for grandparent visitation, for which we did not believe they had legal standing. I filed a motion to dismiss and a lengthy brief and ultimately their petition was dismissed and my client was awarded attorneys' fees.

During my time as the Special Master I settled numerous high profile and high asset divorce cases, including several that were set for seven to ten day trials and had complicated financial issues or parenting issues.

While I was a law student I had two interesting internships. My first summer, between 1L and 2L year, I worked as an intern at the Tennessee Department of Commerce and Insurance in the Insurance and Securities Division. During my second summer between my 2L and 3L year I interned at the Nashville Public Defenders Office. At the Public Defender's Office, I was able to be approved for supervised practice and I was able to handle matters in Davidson County Criminal Court under the supervision of my supervisor, Laura Dykes. I also was able to assist another local criminal defense attorney with a felony murder trial during my internship.

My husband is a Colonel in the Tennessee Army National Guard and over the sixteen years of our marriage I have developed a niche in military divorce and military family matters. I have represented multiple military members and military spouses in divorces and other matters. I have also handled multiple cases under the Uniformed Services Former Spouses' Protection Act and the Deployed Parents Custody and Visitation Act. I have assisted the Tennessee Army National Guard's J9/Yellow Ribbon Program with advising soldiers and units in preparation for deployment to educate deploying parents regarding their rights and the logistics of their parenting plans and visitation during their deployments.

Davidson County General Sessions Court, Docket No. 19GC16129

Disposition: Dismissed by Plaintiff

This was a suit filed against me by a former client wherein he alleged that I 'failed to produce the legal agreements or perform the legal services for which they were contracted and received payment', asking the court to order me to return the fees paid for my legal services and seemingly asking that I be responsible for the payment of his child support arrearages. This is the same client who lodged the only Board of Professional Responsibility Complaint that I have ever received, as described above. His claims were without any basis, but, through counsel, I filed a Motion for Removal to Circuit Court based on the allegations of malpractice and the amount he was seeking to be awarded. On the date of the Motion, the Plaintiff emailed the Clerk's office and dismissed his Complaint with no notice to me or my counsel. The Complaint was dismissed without prejudice.

Disposition: Conservator Appointed then Conservatorship Terminated

This was a petition for conservatorship filed by me for conservatorship of my mother due to some physical and mental illnesses she suffered. I was named as the temporary conservator before the Greater Nashville Regional Council, Public Guardianship Program for the Elderly was ultimately appointed as the conservator in 2019. The conservatorship was terminated in April 2022, following my mother's death in October 2021.

#### ESSAYS/PERSONAL STATEMENTS

28. What are your reasons for seeking this position? (150 words or less)

I am seeking the appointment to the Third Circuit Court because I believe that the families of Nashville need domestic judges who can relate to their needs and experiences and who will both follow the law and listen with empathy. Access to justice is tremendously important and all litigants, no matter their socio-economic status, should feel that they have had access to the court and that they have been heard and understood and have received a fair ruling, even if it was not the ruling they desired. I also believe that efficiency and economy in the court process benefits litigants and attorneys. I understand that, for most people, having to be in court on a domestic matter is likely one of the worst times of their lives and I would work to make the process and transition calm and sensible and to reduce the impact on children and families.

29 Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

Davidson County/Twentieth Judicial District Third Circuit Court. This court is one of two dedicated domestic courts in Davidson County and one of the eight civil circuit courts. The Court hears domestic matters such as divorces, child support and child custody matters, dependent and neglect appeals, and other domestic petitions.

My selection would help to provide a smooth transition and would both ensure continuity of court services and to modernize the court's processes. I have unique experience in this particular court, having served as the Court's Special Master. I have learned a great deal about the needs and logistics of the court, the relationship with the clerk's offices, and working under Judge Robinson has taught me how to be efficient while also being sensitive to the needs of attorneys and litigants in the court. I would bring new perspectives and vision to the court to help the families of Nashville.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes, as a Judge I would uphold the law as written even if I were to disagree with the substance of that law.

As an example, under prior versions of the child support statutes in Tennessee, there was no limit on retroactive child support, assuming a petition was filed timely. As a hearing officer at the Department of Human Services, I awarded retroactive child support to a mother who petitioned for child support just prior to her child's twenty-first birthday when she knew the identity of the father but had never previously petitioned for support and the father did not know about the child.

Another example, on a recent order of protection docket there was a case before me where the

respondent was in another county and there were some delays getting the respondent served by the sheriff's office with the ex parte order of protection. However, the respondent was aware of the ex parte order against him. The respondent was contacting the petitioner, after becoming aware of the order but before being actually served. Because the statute requires actual service, the respondent was not in violation of the ex parte order and that could not be used as a ground to issue the order of protection.
