- 6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

I currently serve as a trial attorney practicing in various areas of law. I formed my practice in Davidson County, primarily handling complex litigation matters. I have a vast amount of experience as an attorney having practiced in approximately (19) nineteen counties, before no less than (50) fifty judges, across middle Tennessee in all state trial courts, the court of appeals and some federal courts. Those courts include the Circuit Courts, Chancery Courts, Criminal Courts, General Sessions Courts, Juvenile Courts and Federal court.

I have focused on family law, domestic relations, child custody, orders of protection, multijurisdictional U.C.C.J.E.A cases and other related matters. It is estimated that approximately (60) sixty percent of my practice has been focused on domestic relations matters.

I have handled many domestic cases, including complex divorce, child custody, orders of protection, modification of child support and post-divorce matters from intake, through resolution and trial. This experience includes conducting countless depositions, extensive written discovery, representing clients at countless mediations, judicial settlement conferences, order of protection hearings, contempt hearings, motion hearings and other such litigation. Through the nature of domestic litigation, I have gained vast experience in all areas of litigation from inception, through trial. My representation has not only been extensive, but it has also been successful. As a result, I am humbled to enjoy a favorable reputation in the local legal community through honest, diligent and effective client representation in the area of domestic law.

I also practice in the areas of construction, contract, consumer protection, business law and personal injury, focusing primarily as a plaintiff's attorney regarding defective construction matters. I have handled these complex litigation matters from intake through trial and on appeal. Once again, my clients have enjoyed a very high percentage of successful resolution at trial in all matters where I served as the Plaintiff's trial attorney. This includes matters dealing with violations of the *Tennessee Consumer Protection Act*, which were triggered due to unfair or deceptive acts by persons acting as contractors. I take these matters very seriously and continue to zealously advocate for the rights of homeowners through trial and in the appellate courts. It is estimated that this area has encompassed approximately (30) thirty percent of my practice.

General civil litigation encompasses approximately (10) ten percent of my practice as well.

Early on in my legal career, I also represented clients in various criminal defense matters in Nashville, Davidson County. That included initial appearances, hearings, settlement negotiations and general criminal litigation in both the General Sessions and Criminal Court. Through those cases, I gained valuable experience as an attorney dealing with the operations of the Davidson County criminal courts.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My litigation experience is extensive, as referenced above in question (6) and includes serving as a trial attorney from intake, through trial and on appeal, when necessary. I have focused primarily in the area of complex domestic relations matters but have a wide and diverse level of experience in other areas of law. This has uniquely prepared me to have a vast understanding of Tennessee trial and appellate procedures.

During my tenure as a Tennessee trial attorney, I have worked diligently to learn and apply Tennessee law, mandatory caselaw, *Tennessee Rules of Civil Procedure*, *Tennessee Rules of Evidence*, *Local Rules of Court* and *Chamber Rules* for each court I have appeared before. I believe having the knowledge of each is the key to successful and competent representation of my clients.

Finally, my legal experience includes matters in all trial level state courts and the court of appeals. I also have experience in federal court, including United States Bankruptcy Court for the Middle District of Tennessee. I believe that my extensive litigation experience has well prepared me to serve in the position of Circuit Court Judge for the 20th Judicial District for Davidson County. If selected, I will honorably serve with patience, impartiality and fairness, in accordance with Tennessee law.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

During my practice, I have represented many clients in complex legal matters. Some of those went to trial and a vast number of those cases were settled due to diligent pretrial litigation. The following are just a few cases of note that indicate my experience while representing clients in complex litigation.

Reed vs. Reed, Docket #18CV70 – This case involved a complex divorce action which went to trial. The parties were married for approximately twelve years. On the date of marriage, the parties each owned separate property. However, the husband's estate was valued much higher than that of the wife.

During this litigation, the wife asserted a claim against the husband's separate real property farm and business. She claimed that she had preserved and appreciated the value of the farm/business during the marriage. She was seeking a large division of the husband's presumptively separately owned farm, which he had obtained through a will prior to marriage.

Although the wife's attorney very skillfully introduced proof at trial of the wife's claims, I was able to successfully defend the husband's position through tracing of his separate assets. I was also able to prove the husband's case through an assertion that the increase in value of the real property was primarily due to market value increase, rather than specific efforts to increase the value by the wife. I was successful at trial through the qualification of an expert witness on behalf of the husband and through diligent research of at least fourteen bank accounts over a twelve-year period.

Ultimately, the husband was awarded the entirety of his separate real property, farm and business in the divorce, free and clear of any claims by the wife. The husband was also awarded a larger, pro rata, division of the newly acquired marital home, based upon evidence of tracing I submitted which came from his separate retirement account. This case was very difficult, tedious and complex.

<u>Evs. E</u> (name omitted due to the nature of the case), Docket # 18X67 – This was an order of protection matter where I successfully prosecuted issues related to threats of homicide against my client. This matter went to trial twice on multiple separate instances of threat(s) of harm to my client. Through extensive introduction of evidence, testimony of the petitioner and cross examination of the respondent, I was able to prove that in fact there was an immediate and present danger of harm to my client on multiple occasions. My client prevailed in both trials. This was particularly memorable as I believe my client was afforded protection from the potential of domestic violence that could have resulted in her death. This is just one example of many orders of protection that I have litigated during my career as an attorney.

Ferguson vs. M. Brown Construction, Inc., et al.. Docket #6442— This was a case involving complex defective construction issues and violations of the Tennessee Consumer Protection Act. I was successful in obtaining a judgment at trial against an unscrupulous contractor for fraudulent misrepresentation, breach of contract, defective construction and other related claims. At trial, through the entry of more than (100) one hundred exhibits, witness testimony and cross examination, I was able to prove that the contractor had made fraudulent misrepresentations of fact, which resulted in financial harm to my client. I was also able to prove violations of the Tennessee Consumer Protection Act that entitled my client to an award of both compensatory damages and double (punitive) damages, attorney's fees, discretionary costs and court costs. My client was therefore awarded over \$434,000.00 in damages and costs by the trial court.

<u>Odziana vs. Odziana</u>, Docket #14D58 – This case involved retroactive modification of child support. My client alleged that he had overpaid child support for an extended period of time. The case involved other issues related to the parenting schedule and disagreements between the parties related to the upbringing of the children. Ultimately, the case went to trial before the Honorable Philip Smith and he agreed with my client's position in this matter. I was successful in proving that my client's child support obligation should be modified and that he had in fact

been overpaying support. My client was ultimately awarded a modification of child support, a retroactive modification of child support and his attorney's fees.

Friedman v. Beautiful Home Services, et al., Docket #2025-CV-461 – This was a case involving breach of contract, defective construction, breach of implied warranty and violations of the Tennessee Consumer Protection Act. I was able to successfully prove that the contractor had engaged in unfair or deceptive acts, which caused monetary harm to my client. At trial, through the introduction of evidence, witness testimony and cross examination, I was able to prove that the contractor was in fact not licensed at the time the work was performed, that he had made false or misleading statements to my client, which resulted in injury to my client. The trial court agreed and awarded my client the full measure of his damages, including attorney's fees, discretionary costs and court costs.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

I have a vast amount of experience in the criminal justice system, which adds to my diversity as a candidate for this judicial appointment. I previously served in various law enforcement capacities. I began my law enforcement career in 1988 and left law enforcement in 2003. During that time, I served as a state trooper, police officer, criminal investigator, narcotics investigator, tactical operations (S.W.A.T.) assistant team leader, supervisor, field training officer, trooper academy training instructor, traffic homicide investigator, traffic accident reconstructionist and other specialized capacities in law enforcement.

While serving in these various positions, I gained first-hand experience dealing with the day-to-day impact of domestic violence, child abuse, drug and alcohol abuse and the victim impact that results from each. This is knowledge that only comes with actual, hands-on experience. I believe this will assist me in identifying credible threats to victims, warning signs of inappropriate behavior and other such issues, which unfortunately is exhibited in matters the domestic courts all too often encounter. Those issues are commonly raised during order of protection hearings, divorce, child abuse and domestic relations matters, all of which the Third Circuit Court for Davidson County commonly encounters.

Further, while serving as a district attorney's criminal investigator, I was tasked with preparation of all major felony cases going to trial within two judicial districts. That included cases of severe child abuse, capital murder, murder, aggravated assault, robbery, burglary, sexual assaults, drug offenses and other felony cases. Once again, this translates into actual, hands-on experience that cannot be replicated in an academic or theoretical environment. I believe this experience is key, as I spent countless hours organizing a heavy caseload, preparing witnesses, including police officers, experts and others for trial. I also spent countless hours in court on each case I participated in preparing.

Finally, my law enforcement experience included a heavy emphasis over several assignments as a personnel supervisor. This began in 1991 when I was tasked with creating, organizing and forming a multi-jurisdictional drug taskforce. I was tasked with the selection of (7) seven agents

from various police agencies in the region and (1) one support staff member. My duties included the overall supervision and management of the taskforce. Since the taskforce was partially federally funded, I was also responsible for all compliance with audits, organization and operations, within the federal guidelines. I believe this experience has prepared me to efficiently manage the office for which I am seeking appointment. My supervision and training of personnel in other law enforcement capacities and in private business has been ongoing from 1991 to the present date.

Rushton v. Rodriquez, et al., Docket #9296, Justice Court, Jones County, Mississippi, 2023 – I own rental property in Mississippi. This was an eviction action I filed against persons that had unlawfully occupied a home I own. The Court entered an eviction order in my favor against the Defendants.

Rushton v. Couch Realty, et. al., Docket #CV-2014-000043, Lauderdale County, Alabama, 2014. I entered a sales agreement to sell my home. The buyer went into the home without my knowledge before closing and caused extensive damage, then failed to close on the home. The case was settled at mediation.

Rushton v. Rushton, Docket #14-085 -Maury County Chancery Court, Tennessee, 2014. This was a single divorce action, which spanned three counties. It was transferred to Maury County on 02/12/2014 from Marshall County, Tennessee. I was the Plaintiff in this case, and it was settled as an uncontested matter. Note: This same divorce was initially, incorrectly filed by my ex-wife in Williamson County Chancery. Date filed: 10/04/13; Docket Number 42543 – the case was dismissed for lack of jurisdiction. I subsequently refiled the divorce in Marshall County, Tennessee. Date filed: 01/09/2014; Docket Number 16-866 – the case was later transferred to Maury County by agreement of parties and settled thereafter in Maury County.

<u>Jarrett v. Alexander, et. al.</u>, United States District Court, Middle District of Alabama, Docket #CIV A. 01-A-1519-N, 2001. This was a class action lawsuit I joined as a Plaintiff against the Director of the Department of Public Safety and State of Alabama, regarding unpaid overtime owed to state police officers. The case was ultimately dismissed under a sovereign immunity defense by the State of Alabama.

<u>Bucher v. Rushton</u>, Docket # CV2005-434 Lauderdale County, Alabama 2005. My company built a boat dock for the Plaintiff. Plaintiff's boat dock was damaged in a storm and the Plaintiff alleged my company was responsible for the damages. The trial court awarded a judgment to the Plaintiff in the amount of \$6,739.00, which was fully satisfied.

It is my goal to efficiently adjudicate domestic matters and to assist litigants in moving on with their lives, without becoming bogged down in long term domestic ligation.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The Third (division) Circuit Court for Davidson County, 20th Judicial District, is charged with handling domestic relations matters. The Court is located in downtown Nashville and serves Davidson County. The Court was created in 1913 by the General Assembly. There are currently eight Circuit Court divisions in the 20th Judicial District. The Third and Fourth Circuit Courts are exclusively charged with handling domestic relations matters, both of which have one judge.

I have practiced for many years before the Third Circuit Court. I am well acquainted with the local rules of court and procedures. My goal is to positively impact this Court through patient, diligent and consistent resolution of pending cases. I will strive to build upon the current systems to efficiently progress cases to resolution and seek available methodologies to minimalize litigation costs. It will be an honor to serve as a fair, patient and consistent trier of fact, if appointed to this position.

Yes, I will uphold the law if appointed to this position. It is of upmost importance that the law be followed, even if I disagree.

Over my years of practice, I encountered situations where litigants wished to pursue avenues that were not consistent with the law or legal precedence. In every such case, I took the position that it was my duty to educate the client regarding what the law was and how it should be properly applied. In a few of those cases, I encountered clients that were not satisfied with my position to uphold the law. In one or more of those situations, I found it to be prudent to withdraw my representation of the client. I did not take such matters lightly. But rather, I made every effort to provide the proper education regarding the issue at hand and only withdrew from the case as a last resort.

I have also encountered situations where a judge interjected their opinion, rather than applying the law. This occurred even in some circumstances where there was a bright-line rule or law that was clear and unambiguous. Those matters created extreme difficulty for one or more of the litigants. It also created chaos, controversy and confusion for all involved. In those instances, I took the appropriate action to appeal an improper ruling or to move to set aside an improper order. I then endeavored to present the proper application of the legal principle, in a respectful and professional manner.
