6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

My present practice consists of 75% domestic law and 25% in other civil litigation areas. While I have extensive experience with civil juvenile court matters and dependency and neglect matters, my primary practice area is divorce, and specifically contested divorces. Approximately 50% of my practice at present involves divorces in circuit or chancery courts. The remaining 25% of my family law cases at present consist of dependency and neglect matters, prenuptial agreements, adoptions, appeals, and custody modifications. In regard to civil litigation outside of family law, I currently have open cases in the legal areas of employment, implied partnership/partition, and defamation law.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

My experience as an attorney has been exciting and intellectually stimulating. I was incredibly lucky that my first official position as a licensed attorney was in the Hague where I had the opportunity to work with former Department of Justice attorney Peter McCloskey and his trial team at the International Tribunal for the Former Yugoslavia ("ICTY"). At the ICTY I was assigned to the office of the prosecutor and assigned to the Mr. McCloskey's team prosecuting The Prosecutor v. Popović et al, IT-05-88. I worked specifically in the subject matter area of forcible transfer. The Popović trial group (which was nicknamed "Team America" because it was heavily staffed with former U.S. Department of Justice attorneys) went on to obtain convictions on multiple counts from the ICTY in 2010, and all defendants were found guilty of forcible transfer. In addition to just being a unique and special opportunity as a new attorney, this experience really helped me gain a big picture perspective early on given the difficult subject matter and has helped me focus on what actually matters (especially with the stress of high conflict divorce litigation). After the Hague, I spent a little over a year in the District of Columbia contracting for large civil litigation firms before I decided to return to Nashville to make it my home. My first position in Tennessee was contracted with the State of Tennessee for the Daniel's reverification project which involved the large application of individual facts to strict statutory guidelines and constitutional law issues. Since leaving this position in 2010, I have practiced in general civil litigation with a high percentage of my cases in the area of family

law and employment law. I initially formed an LLP with another attorney in 2010 and I formed my solo practice in 2011. Since opening my own office in 2011, I have had extensive experience in the trial courts and I am frequently before the courts of Davidson County. I have been involved in over 100 adjudicatory hearings or trials of varying lengths, primarily as the first chair and primarily bench trials. I am a regular on the Friday dockets in Third and Fourth Circuit in Davidson County, Tennessee, and appear regularly in Williamson County, Sumner County, Wilson County, and Montgomery County courts. While I certainly never plan to be in this position I could handle a domestic motion hearing blindfolded with my hands tied behind my back due to my enormous amount of experience in family law. I have first chaired eight appeals in the Middle District of Tennessee including oral arguments on five. I also practice in federal court and I am admitted to the Middle District of Tennessee. I average 1-2 federal cases per year. My experience with administrative bodies since I became a licensed attorney is limited to appeals of substantiations with the Department of Children's Services, TennCare appeals, and Social Security appeals.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

My extensive experience appearing in front of our courts is of special note. At this point in my career, I have had my hands on almost everything domestic law. While every individual is different, it is rare for me to encounter anew legal issue in a domestic case. My experience in federal court, in different counties, in front of the Court of Appeals, and in different courts within Davidson County gives me a unique perspective that I think would be positive for the Third Circuit. Domestic practice is a taxing and stressful area in an already stressful profession, and this causes many attorneys to move into other practice areas or professions. There are not many attorneys who reside in Davidson County with my level (or greater) of domestic litigation experience. In addition to litigating, I am a Rule 31 Family Law mediator and I completed collaborative law training.

Although my preference if I am appointed would be for the Third Circuit Court to continue to hear primarily domestic matters, I do have experience in other civil areas and would be able to pivot, especially with ancillary subject matters like implied partnerships and partitions, or employment cases. Domestic judges frequently must handle business issues and financial documents, and my general practice led me to better understanding of these issues than if I solely practiced family law for the entirety of my career. I have an active practice and I am an active member of the bar practicing in Third Circuit. I am here in the trenches with the attorneys that would be appearing in front of me, and I am working with the same type clients and problem-solving through the same issues that would likely appear before me in the Third Circuit Court. I doubt I will ever forget what it's like to handle these matters and I would take that knowledge and experience and use it to the benefit of the attorneys and litigants who appear before me under enormous stress while they navigate their way through domestic litigation.

I attended the Institute for Conflict Management at Lipscomb University to become a Rule 31 Listed Mediator. I have been a Rule 31 Listed Mediator in the area of family law since 2019. I am an IACP trained collaborative professional. I previously held top secret security clearance from legal work with the Department of Alcohol Tobacco and Firearms prior to being a licensed attorney. I received specific training from the DC Bar on representing victims of domestic violence.

I have taught several CLEs both for lawyers and mediators in the areas of ethics, office administration, and reproductive law.

To ensure full disclosure, there was an additional action (Petition for Order of Protection) filed against me in Sumner County that is being expunged after a finding it was filed in bad faith by an opposing party as part of her pro se litigation strategy. The same opposing party attempted to join me in a lawsuit in the Northern District of Alabama, 6:25-cv-00979-ACA, Summer Lyons v. Joshua W. Lyons, the Circuit Court of Sumner County Tennessee, the Tennessee Court of Appeals, the State of Tennessee, and Joe H. Thompson, however, I was terminated by the federal court as a party prior to service and it is not clear if an action has actually been filed against me or if the attempt was unsuccessful.

28. What are your reasons for seeking this position? (150 words or less)

I love the law, and I feel I have the appropriate temperament and personality to be an effective judge. My experience with the members of the bar and my experience in private practice provides the scope of knowledge and familiarity needed to effectively meet the challenges facing the Third Circuit bench. Serving as judge will provide a new to give back to my community. My unconventional professional path provided insights and strengths that others may not have, and this position will allow me to use those strengths to serve individual citizens and the members of the bar that helped me on my path. The gracious attorneys that allowed me to sit second chair during trials and proceedings and ask questions afterwards, and the members of the community in which I live, deserve competent, empathetic, and hardworking judges working for them every day in our courts. I am that person.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

The Third Circuit handles domestic matters including divorces, post-divorce matters, parentage, custody disputes, child support, enforcement actions, and dependency and neglect appeals. There are eight circuit judges, with Fourth Circuit Judge Stephanie Williams also hearing domestic matters. Only the Fourth Circuit hears adoption cases. I have experience in all matters

heard by the Third Circuit, and experience with adoptions and dependency and neglect actions. I have filed and defended numerous dependency and neglect petitions from both private litigants and the DCS. The late Judge Smith heard dependency and neglect appeals. These cases are being assigned elsewhere. I am uniquely situated to hear these matters allowing the Circuit Court to again consolidate dependency and neglect cases in one judge. I also have the broadening experience of having appeared before all sitting civil judges in Williamson, Sumner, and Wilson Counties, which will positively impact the court

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. It is not a judge's job to make law, but to interpret the law and apply law to facts. I recently prevailed on an appeal relating to the lack of standing of a third party to contact with a child. There is no standing for a third party regardless of the length and strength of their relationship with the child. With the changes to how people parent, this is difficult for me because frequently that third party was a de facto parent for years, and their removal from the child's life causes trauma. Tennessee's case law and statutes provide no means for de facto parent's to have standing without marriage. I personally disagree. However, it is up to our legislature to make a mechanism for that to occur, not the court, and it is the job of judges to respect and uphold the statutes as written.
