While at Luther-Anderson, I advised clients regarding their litigation needs on a wide range of

complex matters, including products liability, construction defects, insurance defense, personal injury, and criminal defense. My primary duties included preparing and prosecuting cases through trial and appeal if needed, by conducting depositions, drafting and responding to briefs, answering and propounding discovery, interviewing witnesses, and negotiating settlements when appropriate.

Fleissner, Davis & Johnson (August 2014 – February 2017).

FDJ was my first job out of law school. While there, I assisted in the preparation and execution of cases, including drafting and answering discovery, interviewing witnesses, drafting and arguing motions, conducting depositions of lay and expert witnesses, and conducting trials. My primary areas of practice included insurance defense, workers' compensation, and personal injury.

I have had no employment other than as a legal professional since graduating law school.

Describe the nature of your present law practice, listing the major areas of law in which
you practice and the percentage each constitutes of your total practice.

Litigation and corporate. I work primarily in state and federal litigation, handling a range of matters from business/contractual disputes and trust/probate litigation, among other things. This involves both the research and briefing components of litigation, as well as presenting arguments before courts, including routinely in the circuit courts of Hamilton County. The bulk of my practice is targeted at Hamilton County, but our firm also handles cases in surrounding counties, such as Cumberland and Davidson Counties.

Percentagewise, my practice is 80% litigation and 20% transactional.

 Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I have litigated primarily in Hamilton County Circuit, Chancery, and General Sessions Courts during my career—in all parts and divisions. During that time, I have had the privilege to second chair jury trials, lead bench trials, and brief and argue in front of the court of appeals on multiple occasions. I have additionally been chiefly involved in many cases before federal courts, locally within the Sixth Circuit, as well as within the Eighth Circuit—both at district and appellate levels. Prior to my current role, I additionally routinely practiced in front of the Court of Workers' Compensation Claims between 2014 and 2020.

My experience in different areas of litigation over the years has been vast, especially during my days practicing insurance defense. I have handled cases concerning (both as plaintiff and defendant's counsel) products liability, personal injury, disputes over contract terms, shareholder disputes, will contests, trust disputes, boundary disputes, employment

discrimination or FLSA violation claims, conversion, property damage, among other things. The only area of which I have not garnered substantial experience is in the area of family law, but that is an area of law on which I am confident I can quickly get up to speed. For example, when I began my legal career the Tennessee Legislature completely revised the workers' compensation code. Despite my complete dearth of experience in the field, I was able to quickly learn the new statutory scheme and use my newfound skills to assist clients in claim defense and resolution. I additionally undertook a criminal appointment on one occasion, which resulted in dismissal of felony charges for my client.

On the transactional side, I have handled day-to-day business and employment advice for companies of all sizes, and have additionally handled business formation and sale matters, including, but not limited to, drafting corporate documents such as bylaws, preparing documents relating to asset and stock sale agreements, as well as assisting in negotiating the deal itself. This includes one particularly fun business deal, where I assisted the clients in preparing a unique dispute-resolution provision in their operating agreement that all but eliminated the need for court involvement in any dispute.

 Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I was involved in one of the first Anti-SLAPP cases in Hamilton County, where we obtained a near complete defense judgment. The plaintiff appealed, and the parties settled after briefing and oral argument had completed, but prior to the decision being handed down. (*John A. Smith v. Miranda Cooper et al.*, Docket No. 20-C-974; COA No. E2021-01456-COA-R3-CV.)

Aside from this potentially important case—which would have settled many statutory construction issues but for its settlement—all of my other cases, while all important to the particular client, were not "noteworthy" in the way that I interpret this question. But I am happy to give further examples of specific cases and their outcomes if given the opportunity to do so.

One of my strongest skills is in client control and helping my clients see "the facts of life" based on the law, the facts, and the application of the facts to the law in a given case. This skill allows me to guide my clients where they need to go in a given case. And this skill also translates strongly to how I would view cases from the bench, i.e., follow the law to the correct and right answer, despite what one party might be seeking. As part of this skillset, and what has helped me develop the same, I have been involved in more mediations (both in advising clients and in drafting agreements) than I can count, whether it be in a workers' compensation case, a multi-million-dollar trust dispute, or a "business divorce" involving business partners who have reached a crossroads in how to proceed.

And with my more than 10 years of litigation experience, I have also participated heavily in all aspects of the discovery process, including drafting and serving discovery, taking and defending depositions, and briefing and arguing discovery disputes.

Litigation is the most stressful time of a party's life, and this can at times lead attorneys to become overzealous and take a personal interest in their client's cause. And I feel my calm demeanor, regardless of the stressors that are presented to me, will be an invaluable asset if appointed to this position in handling such situations and enabling counsel (and pro se parties) to advocate their positions well, while at the same time not being adversarial on a personal level with the opposing counsel or party.

During my time with Judge Fields, I conducted research, drafted bench briefs, and assisted Judge Fields with trial preparations. Being a judge is a calling, not a job. It is something that I have strongly desired since before I graduated law school, and being afforded the opportunity to do so in my home has long been a dream of mine.

My temperament as a litigator is one that always tends toward finding the correct answer and then guiding my client to the best resolution possible rather than being the pit bull who is let off his leash. There is nothing wrong with the latter. And at times it is needed. But I have always felt that due to my temperament toward finding the solution within the bounds of the law is one that is meant for the bench. If afforded the opportunity, it would be my great honor to apply my skills for the benefit of the citizens of Hamilton County.

 Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking an appointment for the pleasure to serve as the judge for the Circuit Court, Division II, of Hamilton County, Tennessee. This would make me one of the four Circuit Court judges who serve this county who oversee civil litigation involving cases that range from disputes relating to commercial disputes to catastrophic injuries to divorce.

My role would be to enforce the law and enable the parties putting forth their position to do so

in a manner that is respectful and to the standards of Hamilton County, while also enabling them to zealously advocate for their clients. If appointed, I would aim to bring a calm to the court that will hopefully carry through the style and judicial temperament that Judge Dumitru and his predecessor Judge Hollingsworth brought to the bench. Trying to live up to their standard is something I would strive for each day.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. A trial judge's role in the justice system is to enforce the law, not make it.

Everyone has seen or had experience with judges in districts who treat locals better than outsiders. While this is far from the norm, it's a narrative for a reason. I once tried a case in a smaller county in Tennessee where the plaintiff lacked any evidence at all, and instead brought only hyperbole to the table to support his claim for damage to his property. On our side, however, we had expert testimony that our client's product could not have caused the harm, both because the chemical was not used in the region, and because the wind that day would not have allowed for it. Despite this, the court gave a ruling that it felt was "fair" to all, which resulted in a near total plaintiff verdict.

Though the claim was later settled for a much less amount, the experience exemplifies the reason to follow the law. Not only did our client expend monies to try a case, but it then had to contend with fighting a set of circumstances that were contrary to the law itself.

If appointed, my goal will be to get the law right, regardless of who I feel should win, or who I feel would benefit more from a given decision. The law is the law, and my job would be to apply it fairly and justly. Doing otherwise only serves to undermine people's faith in the system.
