 - I appealed a decision by the TSSAA, which ruled an Auburn recruit was ineligible to play his senior season at South Pittsburg High School due to the "Transfer Rule" and the TSSAA overturned their ruling allowing him to play (and catch the first touchdown of the season).
 - The arbitrator granted my summary judgment motion (rare in arbitration) on novel interpretation of Tennessee statutory law in which statute of limitations and repose were not applicable to construction disputes in arbitration despite project being completed eight (8) years prior to the action being filed.
 - Obtained full dismissal with prejudice on wage-related claims from unpaid overtime in favor of large, manufacturing client.
 - Successful trial at the General Sessions level concerning non-payment and contractor licensing issues.
 - In Circuit Court (Nashville) obtained complete dismissal of security contractor in lawsuit in which Plaintiff was murdered at a condominium complex against multiple causes of action and damages in excess of one million dollars.
 - Successful dismissal of numerous EEOC claims and investigation of claims working with the EEOC while at TVA.
 - Earned a complete dismiss of architectural firm on contractual basis in state court.

I handle construction cases, which are some of the most complex, expensive, and time-consuming matters in court. I know how these cases drag on unnecessarily, costing businesses and individuals far more than they should. As a judge, I can streamline these cases, cut through the inefficiencies, and ensure disputes are resolved fairly and without unnecessary delay.

I've been in the trenches, advocating for clients in high-stakes litigation, and I know firsthand what lawyers and litigants need from a judge—someone who is prepared, decisive, and practical. I'm ready to take that experience to the bench, apply the law with clarity and efficiency, and serve the people of Hamilton County with integrity.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

I am seeking the Division II opening of the Hamilton County Circuit Court to handle civil litigation. The 11th Judicial District has four (4) circuit judges. I am seeking a Circuit Court judgeship in Hamilton County, Tennessee, which handles civil cases, including business disputes, construction litigation, employment law, and personal injury matters. I've built my career by being hands-on, working closely with clients, colleagues, and even opposing attorneys to get cases resolved efficiently and fairly. I manage a heavy caseload and know how to prioritize, move cases forward, and reach resolutions without unnecessary delay.

Judge Dimitru leaves large shoes to fill. But my experience in litigation, combined with transactional work, clerking, and my hands-on approach to working on complex, fast-paced

issues gives me the background to handle cases practically and decisively. I've spent years in the trenches, balancing high-stakes cases, tight deadlines, and complex legal issues, all while keeping the process fair and streamlined.

If selected, I will bring that same work ethic to the bench—handling cases efficiently, dispensing justice effectively, and ensuring the court runs smoothly for those who depend on it. I am here to serve the people of Hamilton County with strength, honor, dedication, and fairness.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes—to the best of my ability es, I will uphold the law, even if I personally disagree with its substance. A judge's role is to apply the law as written, ensuring consistency and fairness, even when the result may seem impractical or unfair.

One example from my practice involved T.C.A. § 28-3-202, which (prior to its amendment) applied Tennessee's statute of repose and limitations to courts of record only (i.e. not arbitration) in construction defect claims. The owner brought an action in arbitration several years after the normal limitation and repose period ran. All parties thought it was an easy dismissal, however, the law, as written, did not bar the claim despite common sense telling us otherwise. Yet, despite how unreasonable the application seemed, the law was clear: the statute of repose applied, and the claim was not time-barred. We found relief under other contractual terms, but it shows that the law, as I have been told by a colleague and judge, is not fair or right—it is simply the law.

In addition, as mentioned above, the TSSAA's Transfer Rule, as then stated, unfairly harmed lower income students and athletes. Nonetheless, however much I disagreed with the law, the stark reality was that it would ban an other wise good and ambitious student-athlete from competing.

This experience reinforced my belief that judges must apply the law as written, not as they believe it should be. If a statute produces unintended consequences, it is up to the legislature to change it—not the courts to rewrite it. As a judge, I will uphold this principle, ensuring fair, predictable, and legally sound rulings, even when the outcome may not align with practical expectations.
