Other than the practice of law, I have dedicated most of my free time to working with children through my non-profit, No Excuse - Chattanooga, LLC d/b/a Chattanooga Lacrosse Club. I founded, own, and run the business, and receive no compensation from it. I have dedicated thousands of hours since 2018 to the organization and children involved. We field select travel teams, as well as host coach and player clinics for over 200 Hamilton Co & surrounding area kids annually. I also serve as a co-founder and co-director of Team Tennessee Lacrosse, which fields elite-level lacrosse teams for the best players across the state of TN.

In addition to my law practice, I have served as head varsity high school lacrosse coach at the following schools:

Prior to law school and while in undergraduate school, I obtained my Tennessee real estate affiliate broker license, and worked as an affiliate broker with Keller Williams Realty. Before that, I built cars on night shift at the local Volkswagen plant. I also worked as a Walmart associate/cashier.

6. Describe the nature of your present law practice, listing the major areas of law in which you practice and the percentage each constitutes of your total practice.

Although I do draft real estate contracts on the side, I primarily operate as a trial attorney in Tennessee state and federal civil courts. The majority of my practice, with regard to litigation, concerns real estate-related issues of law (property/zoning/contract disputes and landlord-tenant law - 60%), commercial and consumer debtor/creditor law (including bankruptcy) (30%) and personal injury/workers compensation (10%). In my initial practice years, I focused more heavily on personal injury & workers compensation. I manage over a thousand civil cases on average in a given year for hundreds of clients between multiple courts, often on the same day. I am more than capable of handling high workloads and high levels of stress.

7. Describe generally your experience (over your entire time as a licensed attorney) in trial courts, appellate courts, administrative bodies, legislative or regulatory bodies, other forums, and/or transactional matters.

I am, overwhelmingly, a civil trial attorney. To date, I have personally represented clients on over 8,000 civil cases in Tennessee. I have experience in General Sessions Court, Chancery Court, Circuit Court, TN Court of Appeals, U.S. Bankruptcy Court, U.S. District Court, Court of Workers' Compensation Claims, Social Security/Disability claims, and City of Chattanooga administrative hearings. I operate across several counties regularly, with most matters concentrated in Hamilton County. In addition, I have served on numerous occasions (by special appointment) as a civil trial judge in Hamilton County General Sessions Court. I have judicial campaign experience, having worked extensively on a successful campaign finance committee for Circuit Court from beginning to end.

8. Describe any matters of special note involving your practice in trial courts, appellate courts, and administrative bodies.

I believe it worth mentioning that, unlike many practitioners who deal primarily attorney-to-attorney on litigation matters, I have extensive experience in dealing with *pro se* litigants as well. The candidates you select need to have experience in this area, in my opinion, as many of the parties who appear before the court will be unrepresented. *Pro se* litigants pose a unique challenge to judges and the court system, as they often are lacking in the procedural and substantive knowledge that an attorney possesses, and thus require, at times, a bit more patience and grace on the judge's part. Respect for the judiciary is more important now than arguably ever before in our nation's history, and we need more judges on the bench that the general public feels are understanding and cognisant of their struggles and needs. We are not traditional politicians, and should not act as such, but are uniquely positioned to bolster or undermine the public's confidence in our judicial system based on how we interact with the members of the public. We need active judges, not activist judges.

9. Describe any other legal experience, not stated above, that you would like to bring to the attention of the Commission.

I've represented indigent clients on a *pro bono* basis, when possible, as well as volunteered for the local mock trial high school competitions. It is important, for me at least, to give back where and when I can. Early on in my career, I took on an indigent client on a consumer debt matter. The client was struggling with cancer and chemotherapy treatments, had gotten severely behind on his bills, and was having his credit negatively impacted in the process. I was able to help him work out a deal with his creditors, and avoid having several judgments entered against him - just to serve as an example.

Additionally, I completed the TBA Leadership Law ("TBALL") program this past year, and am a proud member of the TBALL class of 2024. Leadership Law is a program established by the Tennessee Bar Association to equip its participants with the vision, knowledge, and skills necessary to serve as leaders in the profession, and in the community as a whole. The program brought our class across the state for monthly, multi-day sessions, focused on honing leadership skills, building relationships among legal leaders across the state, and learning about the broad range of issues facing the legal profession. I, personally, felt that the program further solidified my desire to be a judge, and better equipped me with additional knowledge and tools to be a more effective jurist and leader. Many successful judicial appointment candidates, such as recently-appointed Justice Wagner, are TBALL alumni.

I was born and raised in this county, and as a result, feel a deep connection and love for this community. Since a young age, and continuing into my adult life, I have invested my time and effort into serving this community, both inside and outside of my profession. I've always harbored the strong desire to become a judge one day. That desire has continued to grow and evolve as I've progressed in my career. The courts serve as the foundation of our democracy, and I can think of no greater honor than the opportunity to support, advance, and facilitate that

continued, strong foundation via becoming a member of the judiciary. I possess the knowledge, temperament, and work ethic necessary to accomplish the very difficult work the court is faced with on a daily basis, with the mindset of "service above self."

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. (150 words or less)

Four judges sit on the trial court divisions in this judicial district, which serves Hamilton County, Tennessee. I am intimately familiar with the area, the people, and the Bar. Hamilton County is so much more than just the Chattanooga city limits. Our courts here serve a wide variety of communities and demographics, from inner-city to countryside, and everything in between. This particular court hears a broad range of civil matters, including: protective orders, domestic disputes, child custody, divorce, contract disputes, personal injury/tort litigation, and appeals from General Sessions, juvenile, and municipal courts. The judge needs to be experienced in a wide range of civil litigation, and not just in one concentrated area. I bring that wide range of experience to the bench, along with my experience sitting as special judge. I have the time, energy, patience, and dedication to "hit the ground running."

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. That is the oath you take as a judge. It is straightforward, in that regard, and I have actual, hands-on experience doing just this as a special judge. Your personal opinions, convictions, faith, prejudices, political views, etc. cannot come into play with regard to how or why you rule on a given matter. I sit, when asked, as special judge by appointment in General Sessions Court in Hamilton County. I've ruled on several matters where I, personally, may have desired to provide an outcome contrary to what the law requires (especially in eviction cases with highly sympathetic parties, such as single mothers, folks dying from cancers, disabled veterans, and so on), but nonetheless followed the letter of the law in issuing judgments, regardless of my personal feelings on a given matter. A given statute isn't always easy to interpret, and judges aren't perfect - that's just reality, and it's one of the reasons appeals courts exist. However, litigants should never, under any circumstance, be led to feel as if a presiding judge is issuing a ruling based on anything other than the substance of the law at issue, in light of the evidence presented. As a licensed attorney, I often have to represent clients on issues that I may find unappealing, extremely saddening, and so on, but I do my job, regardless, and to the best of my ability.
