Because the Notice of Appeal was not timely filed, we have no jurisdiction to consider this appeal.

### **OPINION**

### MEMORANDUM OPINION<sup>1</sup>

The Hamilton County Circuit Court ("Trial Court") entered its final judgment on

February 10, 2023. The *pro se* appellant, Judie Snipes ("Appellant"), filed a notice of appeal with this Court on March 14, 2023, more than thirty days after the final judgment was entered. The Notice of Appeal states that Appellant is appealing an order of the Trial Court filed on March 14, 2023; however, the record transmitted to this Court from the Trial Court Clerk does not include an order filed on that date. Appellant attached a document to her notice of appeal entitled, "Request to Appeal Decision to Dismiss, Order dated Feb 10, 2023." That document contains a date of February 28, 2023, but it does not contain a file stamp on the face of the document from either this Court or the Trial Court. In order to be timely, a notice of appeal must "be filed with the clerk of the appellate court within 30 days after the date of entry of the judgment appealed from." Tenn. R. App. P. 4(a). Due to the weekend, the notice of appeal should have been filed with this Court on March 13, 2023 to be timely filed. *See* Tenn. R. App. P. 21(a) ("The last day of the period so computed shall be included unless it is a Saturday, a Sunday, or a legal holiday . . . , in which event the period runs until the end of the next day which is not one of the aforementioned days.").

This Court entered an order on August 30, 2023, directing Appellant to show cause why this appeal should not be dismissed as being untimely filed. Appellant failed to file a response to this Court's show cause order. "The thirty-day time limit for filing a notice of appeal is mandatory and jurisdictional in civil cases." *Albert v. Frye*, 145 S.W.3d 526, 528 (Tenn. 2004). If a notice of appeal is not filed in a civil case in a timely fashion from the date of entry of the final judgment, we are not at liberty to waive the procedural defect and must dismiss the appeal. *See Arfken & Assocs., P.A. v. Simpson Bridge Co., Inc.*, 85 S.W.3d 789, 791 (Tenn. Ct. App. 2002); *Am. Steinwinter Investor Group v. Am. Steinwinter, Inc.*, 964 S.W.2d 569, 571 (Tenn. Ct. App. 1997); *Jefferson v. Pneumo Services Corp.*, 699 S.W.2d 181, 184 (Tenn. Ct. App. 1985).

Because the Notice of Appeal in this case was filed more than thirty (30) days after the date of entry of the final order, we lack jurisdiction to consider the appeal. This appeal is dismissed. Costs on appeal are taxed to the appellant, Judie Snipes, for which execution may issue if necessary.
