¹The U.S. District Court, Western District of TN has certified to this Court the following question: Should the doctrine of equitable tolling be applied when a plaintiff, who is reasonably ignorant of the statute of limitations, in good faith, attempts to resolve her civil rights complaint through administrative channels, and subsequently misses the filing deadline by only a few months, and where there is minimal prejudice to the defendants? In Norton v. Everhart, 895 S.W.2d 317 (Tenn. 1995), this Court expressly declined to adopt the doctrine of equitable tolling as an independent doctrine in Tennessee. Therefore, since there is controlling precedent with respect to the question certified to this Court, we respectfully decline to accept the question certified to this Court.
