GODSEY</u>: (1) Whether felony murder can be predicated upon the felony of aggravated child abuse (i.e., the doctrine of merger for assaultive offenses); (2) Whether use of the aggravating circumstance in TCA § 39-13-204(i)(1) sufficiently narrows the class of death-eligible defendants in a felony murder based on aggravated child abuse; (3) Whether the death penalty is per se unconstitutional for felony (aggravated child abuse) murder (in connection with the comparative proportionality issue in the State's application); and (4) Whether the defendant's statements to the police should have been electronically recorded.
