(3) Is the three year statute of repose for medical malpractice in Tennessee Code Annotated section 29-26-116, which contains no exception for minority, tolled during a Plaintiff's minority?

(4) Is a physician Defendant denied equal protection of the law wherein an exception to the statute of repose contained in Tennessee Code Annotated section 29-26-116 is created for minority and medical malpractice cases, while no similar exception exists in products liability and construction cases?
