Upon consideration of the Tenn. R. App. P. 11 application for permission to appeal filed by Kevin Swift and the record before us, the application is granted only with regard to Mr. Swift's first issue – whether the evidence is insufficient to justify finding the appellant guilty of aggravated robbery rather than theft and aggravated assault where the violence or intimidation occurred after the taking was complete.
