**ORDER**

Pursuant to Tennessee Supreme Court Rule 23, a certification order was filed in this Court on January 12, 2009, by the United States Bankruptcy Court for the Middle District of Tennessee, and a supplemental order was filed on July 21, 2009. Briefs have now been filed pursuant to Section 7, and upon consideration of the certification order, the supplemental order, and the briefs filed by the parties, this Court accepts certification of the following question of law:

Whether the consignment of an R.V. by a consumer (not another business) to a Tennessee R.V. dealer, for the purpose of selling that R.V. to a third person, is a transaction covered under § 47-2-326 of the Uniform Commercial Code, as adopted in Tennessee.

Pursuant to Rule 23, Section 7(B) of the Supreme Court Rules, this Court desires to have oral argument by the parties. This case shall be set for hearing at the Court's October 2009 session in Nashville.
