These appeals are before the Court upon the applications of David Criswell, et al. and Dyersburg Hospital Corporation, et al. for permission to appeal from the denial of their Rule 9 applications by the Court of Appeals. These applications were held by the Court, pending the disposition of <u>Banks v. Elks Club Pride</u> <u>of Tennessee 1102, et al.</u>, No. M2008-01894-SC-S09-CV. This Court's opinion in <u>Banks</u> was filed on January 13, 2010.

Upon due consideration, the application in <u>Reynolds v. Criswell</u> requesting review of the trial court's order granting the plaintiff's motion to strike Criswell's assertion of the comparative fault of the medical providers is granted, and this case is remanded to the trial court for consideration and for further proceedings consistent with the holding in <u>Banks</u>. The application in <u>Reynolds v. Dyersburg Hospital Corporation, et al.</u> requesting review of the trial court's denial of the medical providers' motion to dismiss is denied.

On August 6, 2009, a "Notice of Substitution" of counsel was filed by Thomas Pinckney and Susan D. Bass on behalf of applicant Alan B. Hopkins. No response has been filed by prior counsel, nor by any other party in the case. This notice will be treated as a motion to substitute counsel. The motion is granted. It is ordered that Mr. Pinckney and Ms. Bass are substituted as counsel for Alan B. Hopkins in place of Darrell G. Townsend.

Costs in No. W2009-00866-SC-S09-CV are taxed to the applicants, Dyersburg Hospital Corporation, Joseph Flagge, M.D., and Alan B. Hopkins, ARNP, and their sureties, for which execution may issue if necessary.
