Upon consideration of the application for permission to appeal of Larry Edward Moore and the record before us, this Court has determined that the videotape admitted as trial exhibit 6 and included in the record on appeal is now defective and unavailable for review. Therefore, in accordance with Tennessee Rule of Appellate Procedure 24 and this Court's decision in <u>State v. Byington</u>, 284 S.W.3d 220 (Tenn. 2009), the defendant is hereby ordered to supplement the record on appeal with a non-defective DVD version of exhibit 6. The supplemental record shall be filed no later than November 8, 2010.

Furthermore, the application for permission to appeal of Larry Edward Moore is granted, and this case is remanded to the Court of Criminal Appeals for reconsideration in light of the supplemental record. Specifically, the Court of Criminal Appeals shall review the non-defective version of exhibit 6 and re-consider on the merits Mr. Moore's argument that the trial court erred in not redacting from exhibit 6 certain portions of Mr. Moore's statement to the police.
