During the December 1, 2021 and November 30, 2022 term the following improvements were made to assist, protect, or improve the security of judicial personnel.

The digital video recorders were replaced and updated to more advanced technology.

The court security computers were replaced with the latest technology.

We are now hosting the basic court security school and we have opened the training up to other sheriff's agencies that mat need this training.

Please describe any recent court security incidents in your county or unique court security issues facing your county.

On March 24 two of our court security personnel were involved in an incident in General Sessions court where a handcuffed and leg shackled inmate being moved from the court holding cell to the courtroom attacked one of the officers and attempted to remove the officers service weapon from its holster. The officers good weapon retention technique, security holster, and the response of the second officer prevented what could have been a very tragic incident. The incident was captured on security video. The inmate was later convicted in criminal court and was sentenced to 6 years in the TDOC for the attack.

Please explain if and how security staffing issues have impacted court security in your county.

We need to increase the staffing numbers of our court security team. The level of hostile behavior in our culture has spilled over into our courtrooms. It would be very helpful if the AOC could assist with staffing grants for additional court security personnel.

What are your highest priority needs related to improving court security in your county? Increasing the number of court security personnel.

The Tennessee Law Enforcement Training Academy <u>MUST</u> return to offering the basic court security training course that is required that they stopped offering during COVID.
