New video conferencing system in Chancery Court. Due to extremely limited revenues, Henry County has been unable to provide certain needed security and video conferencing updates. Please describe any recent court security incidents in your county or unique court security issues facing your county. The Henry County Courthouse is particularly vulnerable to security breaches due to the age of the building and the physical layout of the building. Due to the layout of the Circuit Courtroom, inmates are maintained in the courtroom with the general public. Please explain if and how security staffing issues have impacted court security in your county. Based upon physical layout of the courtrooms, multiple entrances utilized by the public and the lack of magnetometers at each entrance places the general public and staff at risk of potential violence. Accordingly, additional security staff is required to be utilized to ensure safety. What are your highest priority needs related to improving court security in your county? Magnetometers at each public entrance to the courthouse staffed with law enforcement.



## The Problems:

- Complete unrestricted building access
- Numerous unsecured entrances
- No obvious checkpoint location for current building configuration
- No perimeter security during or after business hours
- Heavy dockets
- No segregation of parties
- · No weapons control program



### The Problems:

- Prisoner transport in public area with no segregated egress
- Prisoners forced to be taken through regular entrances with public
- Prisoner holding facilities accessible and visible to public




#### Recommendations Exterior


- · Perimeter alarm
- Key control, card or other restricted access system established
- Signage prohibiting weapons




## Recommendations Exterior

- Sally port






Sally Port Examples



#### Recommendations Exterior

- Close all entrances except for one
- This would require construction of a historically and architecturally appropriate disabled access ramp on the historic front entrance.
- One security checkpoint manned by two full-time officers
- Court officers stationed in each courtroom



# Recommendations--Exterior

- Sally Port for safe transport should be located at rear of courthouse (opposite entrance and between holding cells with controlled access to elevator)
- Signage on doors prohibiting weapons and other prohibited items
- Window tinting for all holding facility windows visible to public—bulletproofing or relocation ideally

# Recommendations--Interior---Main Floor

- Install perimeter alarm system—windows are vulnerable to burglary
- Establish controlled access to building through at least key control or ideally electronic access
- Back stairway to upstairs courtroom needs to be a secure exit only door
- Magnetometer checkpoint moved to main floor and manned to secure entire building

# Recommendations--Interior--Chancery Court

Winess Court · Address windows with Judge's Bench bullet resistance or tinting · Door to bench for clerk's Dey Jey side · Station court officer near Prosecutor Eclence secured courtroom door (103) during proceedings · Utilize one entrance door Sesta to room (105) Seats Install bar between See Sess gallery and well

#### Estimated costs:

- Manpower the most expensive
  - 2 dedicated full-time personnel for checkpoint at all times building is open
  - · Dedicated court officers for each courtroom
  - All court officers except one roving deputy could assume road duties when court not in session
- Historically/architecturally accurate construction of sally port and handicap access ramp would be costly but invaluable to avoid incidents
- Portal Magnetometer—\$7,000.00
  - · Current device is serviceable but outdated
- X-ray machine— \$22,000.00
  - · Sheriffs Department does have an older device available
  - Does not screen for explosives or organic substances

## Estimated costs:

- Perimeter security system installation can be very inexpensive with a monitoring contract
- Bullet resistance for windows \$1000 --\$1500 per window
- Tinting expense would be minimal
- The only true way to secure the Henry County Courthouse is with a substantial investment in remodeling or relocation to a new facility
- Robertson County recently remodeled its historic courthouse to address similar issues in order to maintain the center of the legal and business community and its traditions
