#### **ORDER**

Upon consideration of the application for permission to appeal of State of Tennessee and the record before us, the application is granted for the limited purpose of review in light of this Court's recent decision in *State v. Hassan Falah Al Mutory*, No. M2017-00346-SC-R11-CD (Tenn. Aug. 7, 2019).

The defendant died during the pendency of his case on appeal to the Court of Criminal Appeals, and the State moved to dismiss the appeal. The Court of Criminal Appeals granted the State's motion but abated the case ab initio. This Court recently abandoned the doctrine of abatement ab initio in *Al Mutory*. Because there is no evidence before this Court that any interest would benefit from allowing the deceased defendant's appeal to continue, we dismiss the defendant's appeal as of right.

Therefore, the judgment of the Court of Criminal Appeals is reversed, the appeal as of right is dismissed, and the judgment of the trial court is reinstated.

The costs of this appeal are taxed to the State of Tennessee for which execution may issue if necessary.
