Complaint #1: On December 20, 1991, one of my cousins pled guilty to misdemeanor theft before a special judge in Jefferson County, TN General Sessions Court #111768-84-56, State v. Kelly Quarles. Subsequently, Kelly wanted to go into the military and have his record expunged. I was notified by letter from the Tennessee Board of Professional Responsibility dated June 28, 1995, that a complaint had been received concerning my conduct, to which I was required to answer. The Summary of Complaint enclosed with the letter stated that I had prepared a petition for expungement dated November 22, 1993, and an order of expungement on November 23, 1993; and that I, along with Kelly, went ex parte to the private office of the attorney who had served as special judge, apparently on November 23, 1993, for his signature; and that at this time he was not authorized to act as a special judge. It also stated that I admitted I knew Kelly's record could not be expunged. It stated that the State was not given a copy of the petition for expungement nor notice of the appearance before the attorney who had served as special judge. It stated that in March of 1994, the District Attorney General's Office learned from the Circuit Court Clerk's office that an order of expungement had been filed in Kelly's case. It stated that on July 1, 1994, the State filed a motion to restore Kelly's conviction to public record; and on August 31, 1994, the General Sessions Court Judge ordered it restored on the grounds that said attorney did not have the authority to sign the order of expungement. It also stated that expungement was only available when there is a deferred plea, pretrial diversion, when the defendant is acquitted or the prosecution otherwise abandoned, such as a dismissal, and that none of these applied in Kelly's case. I answered the complaint, and the Board, with the concurrence of a Hearing Committee member in my Disciplinary District, found that my actions warranted a private informal admonition, which I accepted.

Complaint #2: I was notified by letter from the Tennessee Board of Judicial Conduct dated August 22, 2013, that an Investigative Panel of the Board had authorized a full investigation of an internal complaint which combined information from several complaints and other sources, and to which I was required to answer. The complaint alleged that on August 8, 2013, while acting in my capacity as Child Support Magistrate in Cocke County, TN, I presided over a hearing that was held, in part, to resolve a conflict between the parents concerning the child's last name. It further alleged that during that hearing I took it upon myself, without any request from the parents of the child, to order that the child's first name be changed from Messiah, which was the birth name of the child, to Martin. (Martin was the mother's last name.) It alleged that I ordered, without the request of either parent, that the birth certificate of the child be amended to reflect this first name of Martin. It also alleged that in a subsequent interview given to WBIR-TV of Knoxville, TN I stated that the reason for my decision to change the child's name was because "the word Messiah is a title and it's a title that has been earned by one person and that one person is Jesus Christ." I answered the complaint, and the Investigative Panel found that there was reasonable cause to believe that I had committed judicial offenses and filed formal

charges against me which are described in Question 22 below of this application.

Lu Ann Ballew v. Wesley Kent Ballew, Jefferson County, TN Circuit Court No. 24,222. Divorced May 11, 2015.

In Re: The Honorable Lu Ann Ballew, Child Support Magistrate, Fourth Judicial District, Cocke County, TN. In the Tennessee Board of Judicial Conduct, Docket No. M2013-02345-BJC-DIS-FC. File No. B13-5426. Formal charges were filed October 23, 2013, against me. The first charge was that I changed the first name of a child, Messiah Deshawn Martin, the subject of a paternity and support petition, without there being a request to do so. The second charge was that I manifested religious bias by changing the child's name for a reason based on religion. The third charge was that I made a public statement about the case, via a television interview, that might have reasonably been expected to affect the outcome or impair the fairness of a matter pending in the Chancery Court, that being a request for hearing file by both parents dissatisfied with my decision. The Hearing Panel found that my actions had violated the Code of Judicial Conduct and imposed a public censure. I accepted the Hearing Panel's findings and sanction.

In the Matter of the Conservatorship of Maurice J. Hatcher, Respondent; Lu Ann Ballew, Petitioner. Jefferson County, TN Probate Court No. 2013-13-033. December 20, 2013. I was appointed conservator for my Daddy who was physically disabled and had dementia.

In the Matter of Agnes Wylene Quarles Hatcher, Deceased; Lu Ann Ballew, Personal Representative. Probate Court of Jefferson County, TN No. 2021-11-227. June 23, 2010. I probated my Mother's estate. Disposition: Estate closed.

Wes & Lu Ann Ballew v. Steve & Audrie Weaver, Jefferson County, TN General Sessions Court No. 45GS1-2004-CV-894. November 1, 2004. We sued the Weavers for back-rent owed. Disposition: Judgment in favor of Ballews for back-rent owed. I have requested a copy of the civil warrant from the court clerk and am awaiting its receipt.

Volunteer Medical Clinic v. Operation Rescue, et al. U.S. District Court, Eastern District, Northern Division, Knoxville, TN No. 3-89-156. March 1, 1989. I was named as a Respondent, along with many other people who participated in Operation Rescue, a pro-life sit-in demonstration where we blocked the door to Volunteer Medical Clinic to prevent ladies from entering to obtain abortions. Volunteer Medical Clinic sued us under the RICO statute, and my case was resolved by settlement with Volunteer Medical Clinic. I have contacted the Federal Records Center for the complaint and settlement but have not received those records yet.

State of Tennessee v. Lu Ann Hatcher, Knox County Sessions Court #52509 CI 115414. I was charged with criminal trespass February 4, 1989, as a result of participating in Operation Rescue, a pro-life demonstration involving a sit-in blocking the door to an abortion clinic (Volunteer Medical Clinic) in Knoxville, TN. Disposition: Dismissed.

During my employment with the Public Defender's Office, I was recognized by the Public Defender's Conference with implementing a paper-saving practice in our Circuit Courts. We had been filing discovery motions with the court clerk and serving copies on the State in all our cases (except probation violations), which used a high volume of paper due to our high volume of clients. At my request, and with the approval of the Circuit Court Judges, we began filing and serving one discovery motion per arraignment cycle, labelled a Master Motion, which listed all our clients with their docket numbers and saved a tremendous amount of paper.

Applicant: Child Support Referee, 4th Judicial District, State of Tennessee. I applied and was appointed in 2003 by the 4th Judicial District Circuit Court Judges and Chancellor. I served in that position from January 2004 through January 2014. During that time, the legislature changed the title to Child Support Magistrate.

Candidate: Jefferson County (Tennessee) General Sessions Judge, 2014. This was an elective position, but I was not elected.

Candidate: Circuit Court Judge, 4th Judicial District, State of Tennessee, 2018. This was an elective position, but I was not elected.

<u>ESSAYS/PERSONAL STATEMENTS</u>

28. What are your reasons for seeking this position? (150 words or less)

I want to serve the people of the 4th Judicial District in a judicial capacity. I grew up in Jefferson County, where I have lived most of my life. I've hiked in the mountains of Sevier and Cocke Counties. I've swum, skied, and boated in the waters of Douglas & Cherokee Lakes, situated in Jefferson/Sevier/Cocke/Hamblen and Jefferson/Grainger/Hamblen/Hawkins Counties, respectively. I love my district and the people in it.

29. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

Circuit Court Judge, 4th Judicial District of State of Tennessee, which includes Jefferson, Grainger, Cocke, & Sevier Counties. The vacancy for this judgeship was created, sadly, by the death of Judge O. Duane Slone. There are four Circuit Court Judges, and I would join them as the fifth. This judgeship presides over various civil and criminal matters, as well as the Recovery Court and Tennessee Recovery Oriented Compliance docket. My selection would impact the Court with a familiarity of all four counties and experience from the bench and bar, having served as an advocate in non-jury hearings and jury trials, and in a judicial capacity presiding over bench trials. I'm familiar with the TN-ROCS docket and Recovery Court, having attended TN-ROCS training and having clients who are participating in these programs or have participated. I have perspective from the other side of the bench, having been a party in various legal matters.

30. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. (250 words or less)

Yes. In a sentencing hearing for a misdemeanor theft case, I argued that my client should not be incarcerated and relied on TCA 40-35-122(a) & (c)(11), which provided, in pertinent part, that the judge sentencing a defendant for a qualifying nonviolent property offense was not authorized to impose continuous confinement but could impose periodic confinement. Although I disagreed with the part of the statute that allowed the judge to sentence my client even to periodic confinement, I advised the judge of that part of the statute, along with the part that prohibited him from imposing continuous confinement. The judge did not sentence my client to any confinement but placed my client on supervised probation and ordered restitution. (That statute is now repealed but was in effect at the time of my client's offense and sentencing.)
