## INSTRUCTIONS FOR COMITY APPLICANTS TO BE ADMITTED TO THE TENNESSEE BAR

- 1. Once you have obtained your certificate for eligibility to practice law from the Board of Law Examiners, you must register with the Board of Professional Responsibility. You may do so by going to the web site for the Board of Professional Responsibility to obtain the registration form.
- 2. You must then submit the registration form with a check in the amount of \$254.00. This amount constitutes the \$100.00 license fee for the Board of Law Examiners, \$4.00 credit card payment, the \$50.00 registration fee for the Board of Professional Responsibility and the \$50.00 enrollment fee for admission by affidavit to the Tennessee Supreme Court.
- 3. After you have obtained your Board of Professional Responsibility registration number, you may then fill out the Admission by Affidavit Form and take the oath of office from a judicial official set forth in Supreme Court Rule 6. Upon taking the oath, you must then submit the Admission by Affidavit Form to one of the three addresses of the Appellate Court Clerk's office set forth in the form.
