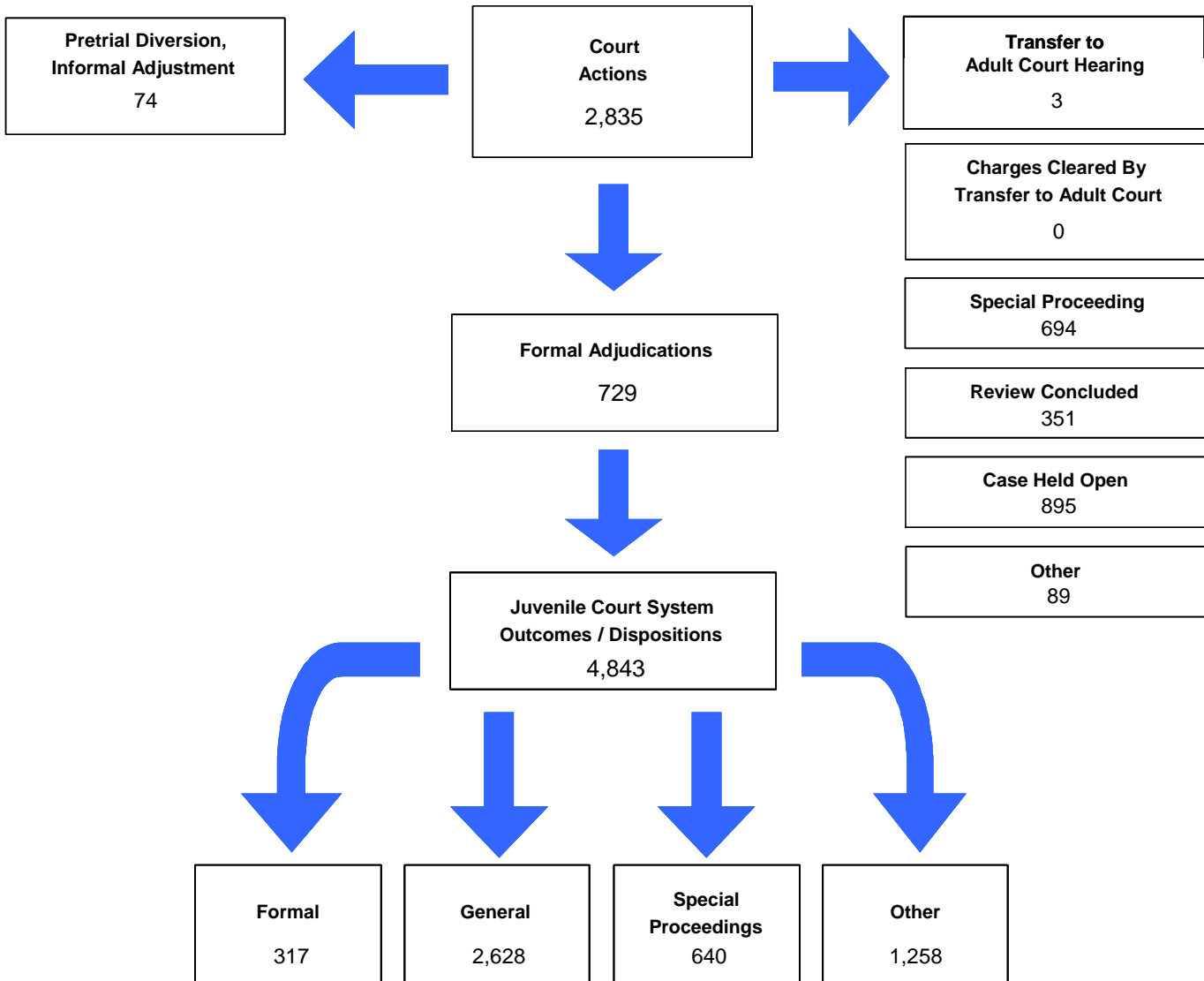

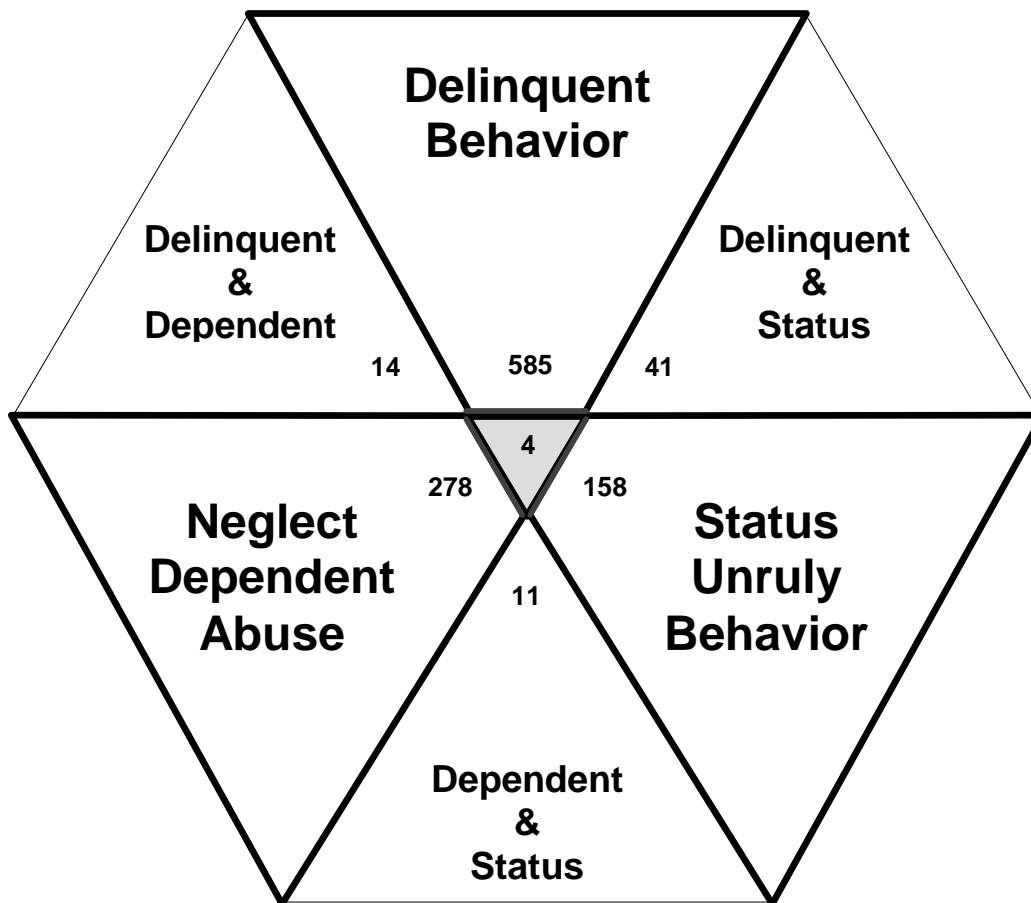

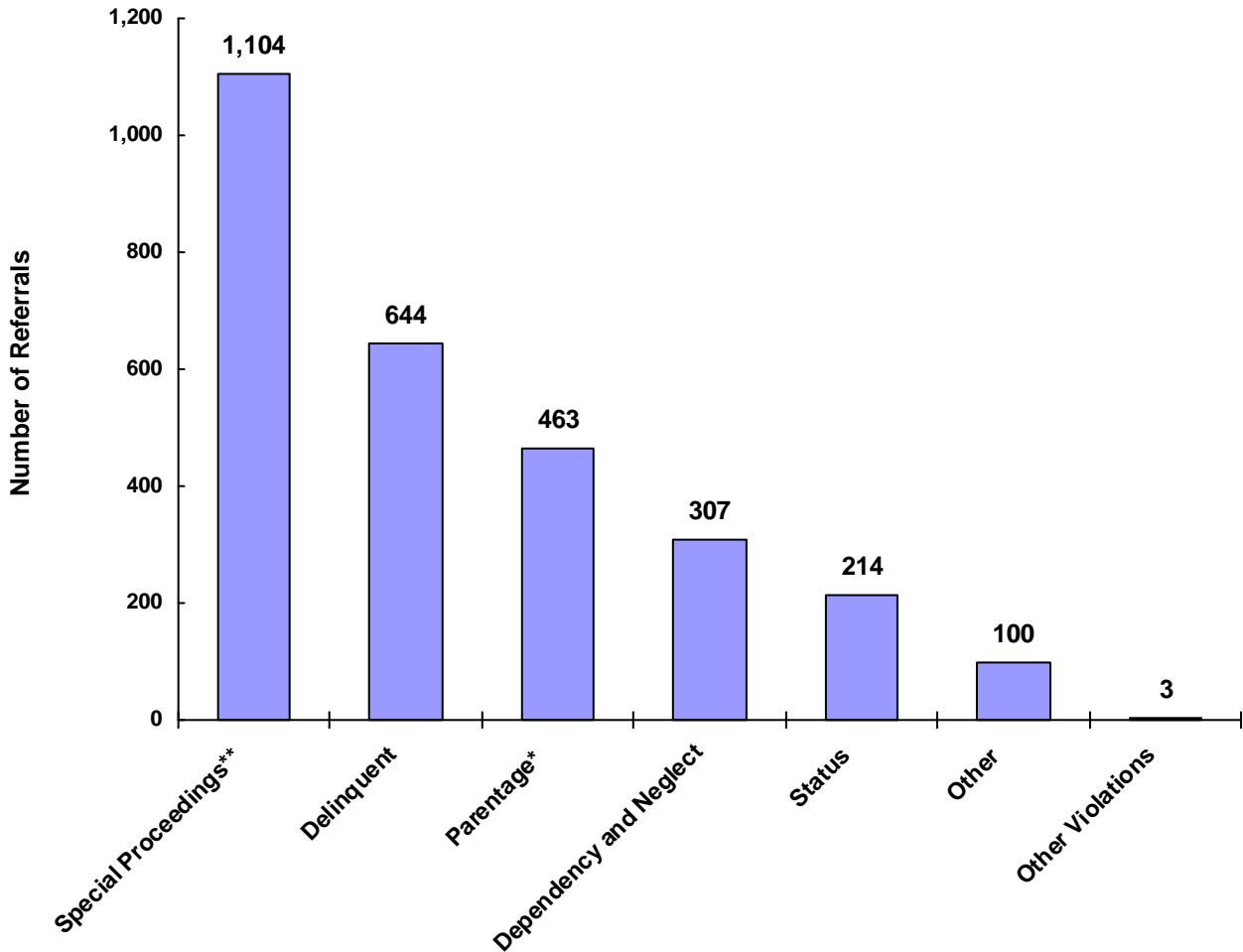

Children can have referrals in multiple categories. The drawing above shows that in the year 2008 there were 585 referrals to Jefferson County Juvenile Court for children with only delinquent offenses, 158 for those with only status/unruly behavior, and 278 for children with neglect, dependent or abuse referrals during the calendar year. There were 41 referrals for children that had a delinquent AND a status/unruly referral. There were 14 referrals for children with both delinquent behavior AND a neglect, dependent or abuse allegation. There were 11 referrals for children that had both a status/unruly referral AND a neglect, dependent or abuse allegation. Also, there were 4 referrals for children that had a delinquent referral, a status/unruly referral AND a neglect, dependent or abuse allegation.

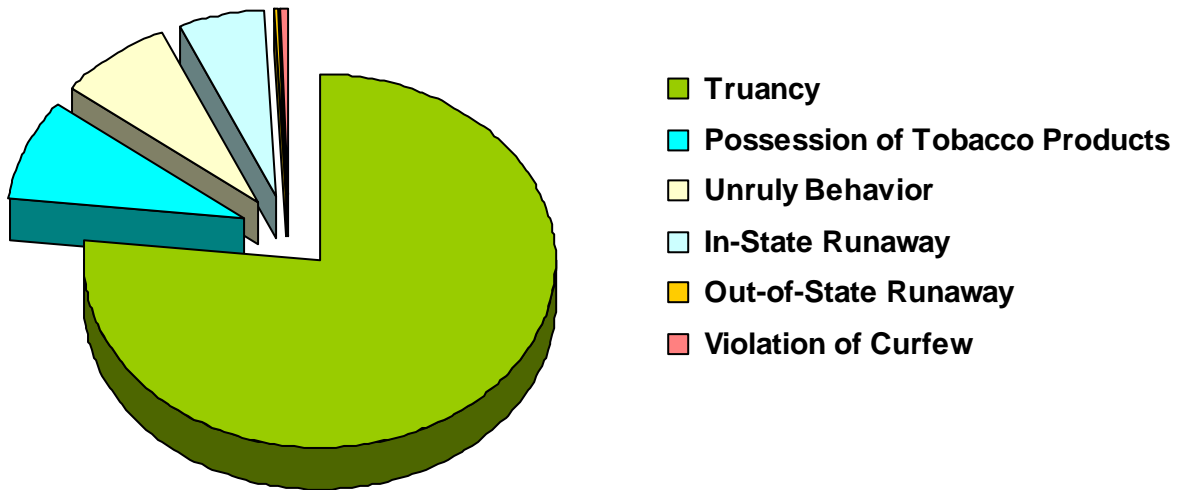

A Status offense is an offense committed by a child that if committed by an adult, would not be considered an offense or unlawful act. An example of this is smoking when not legally an adult.

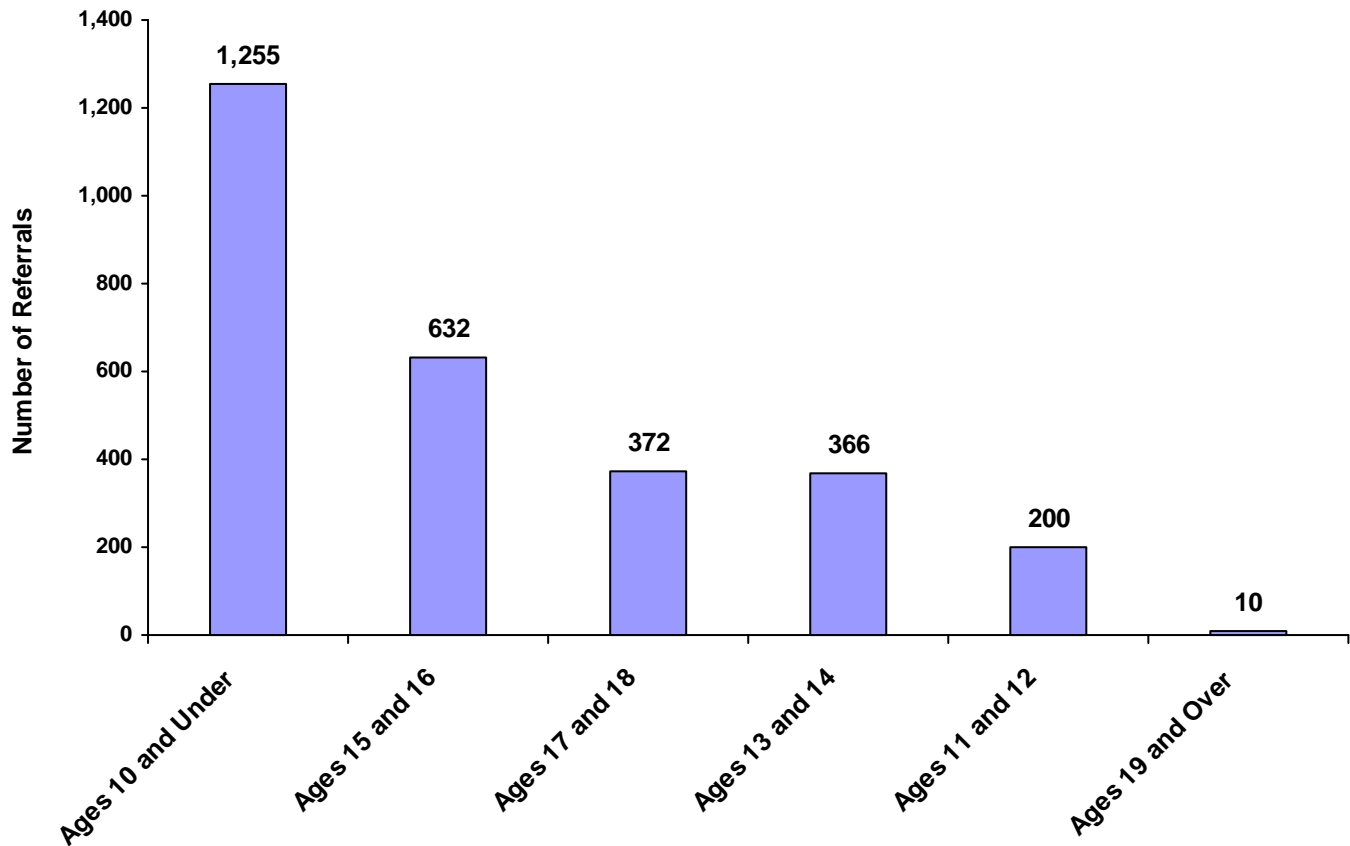

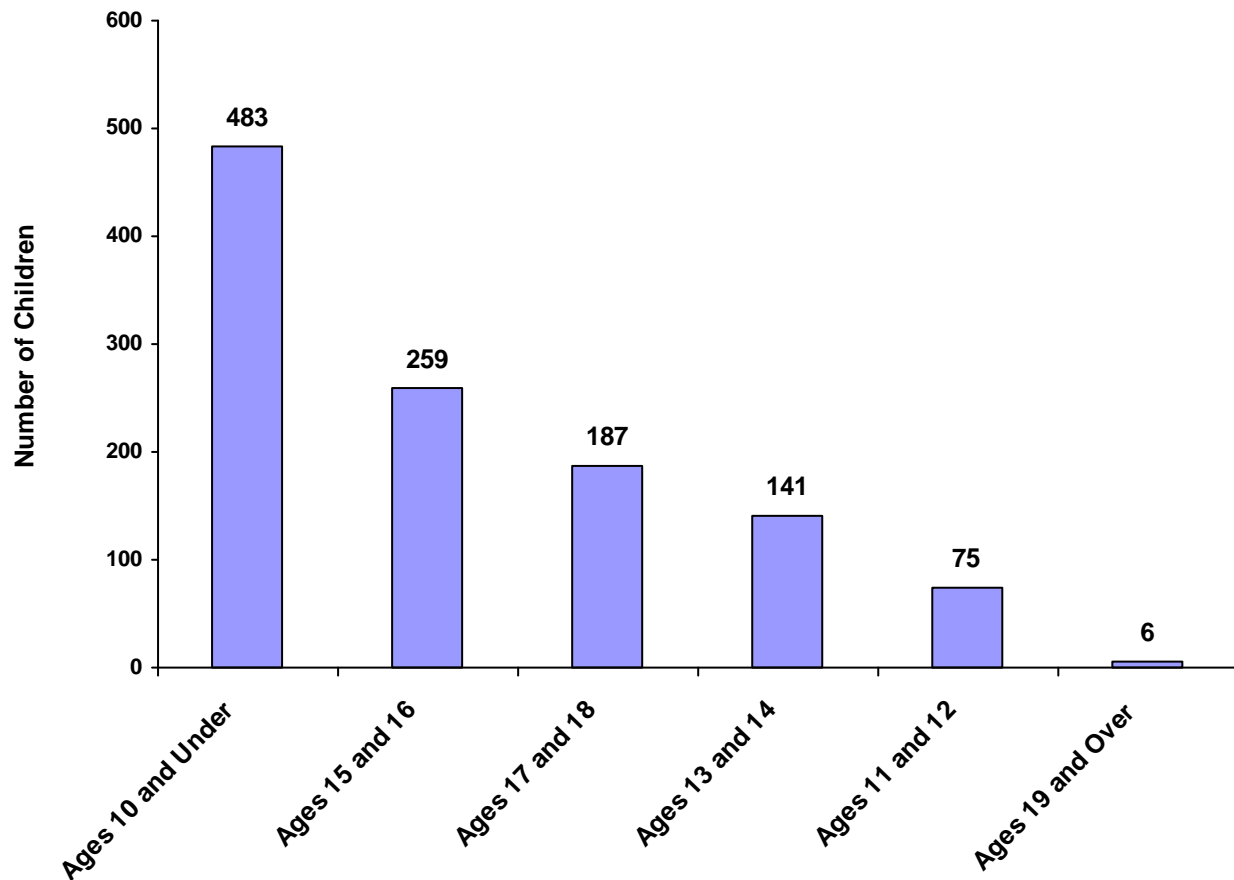

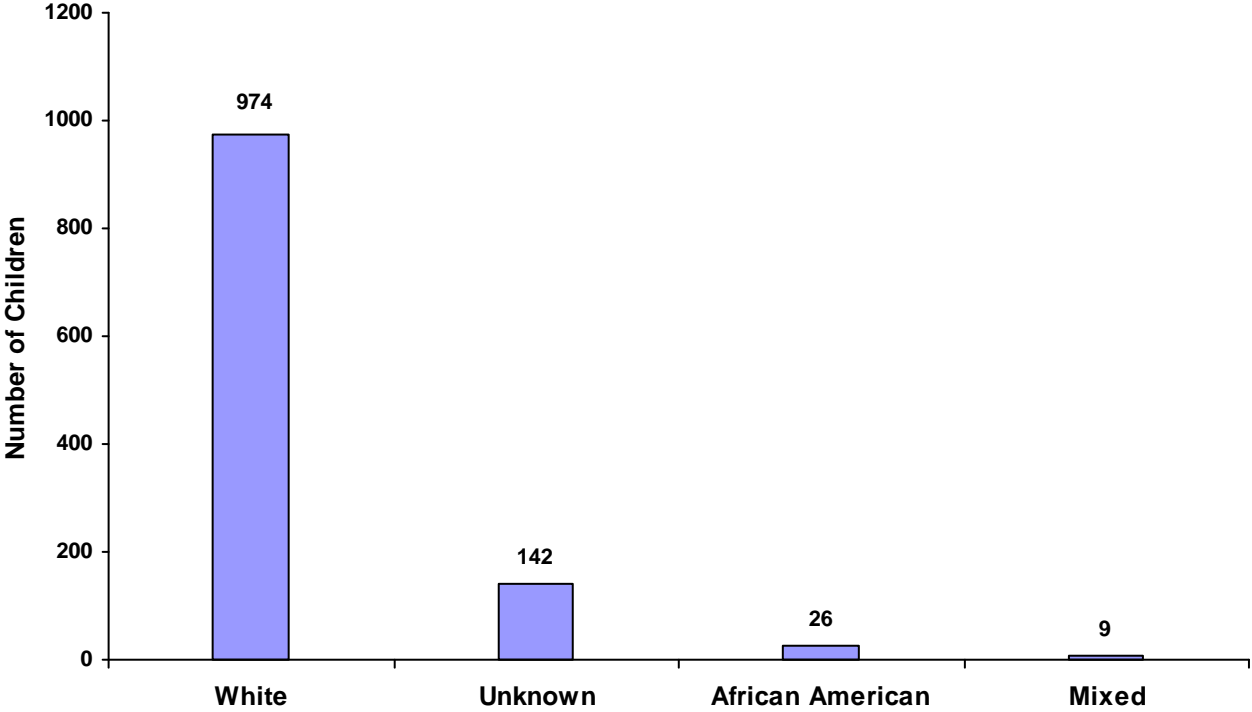

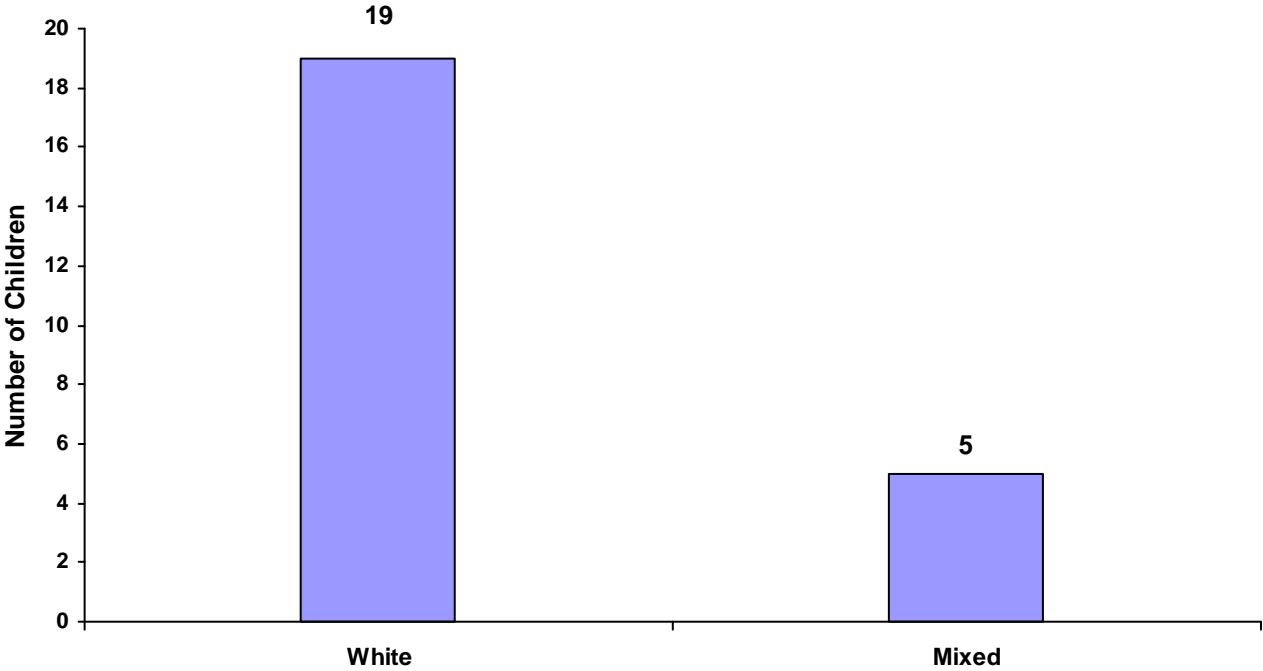

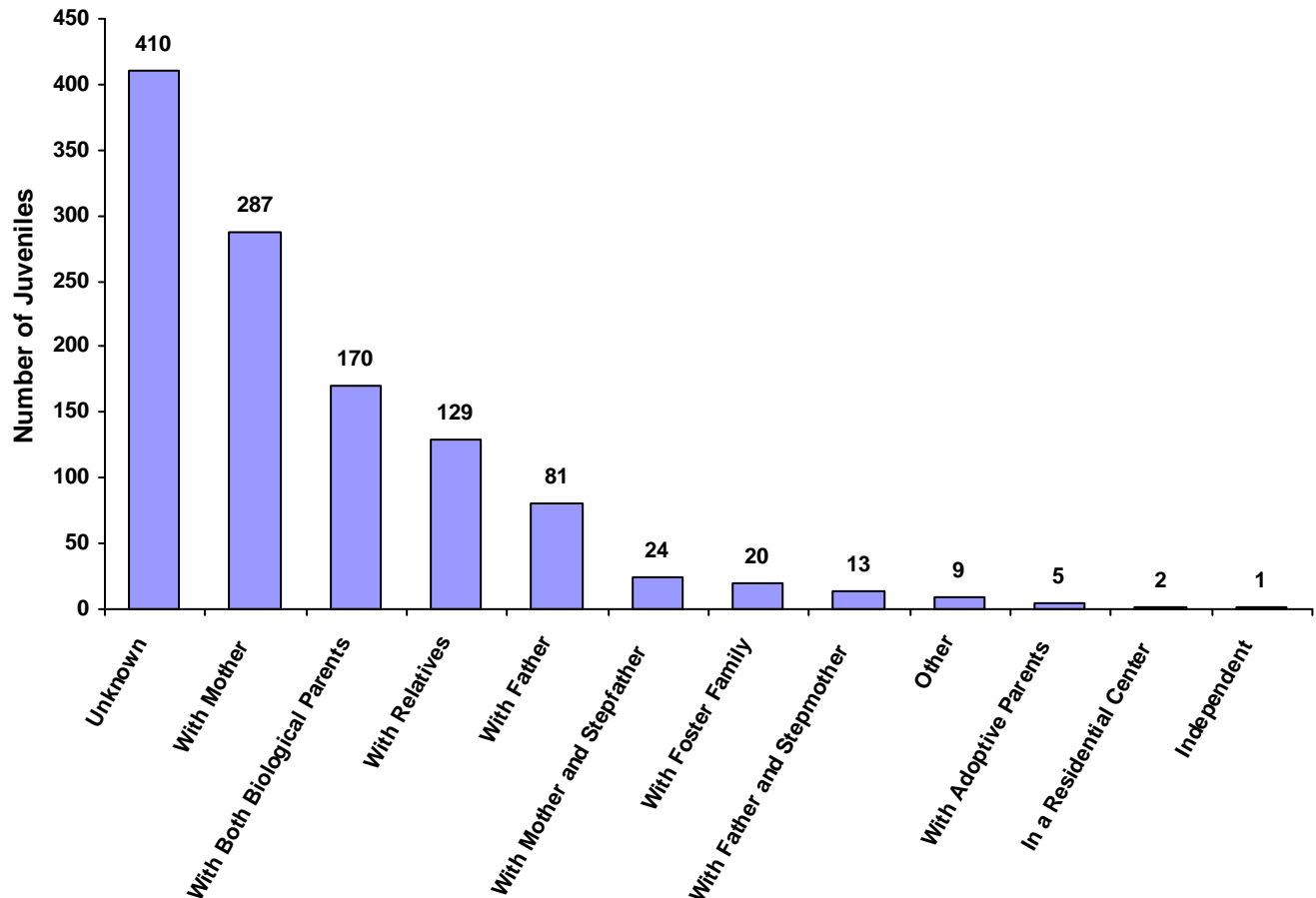

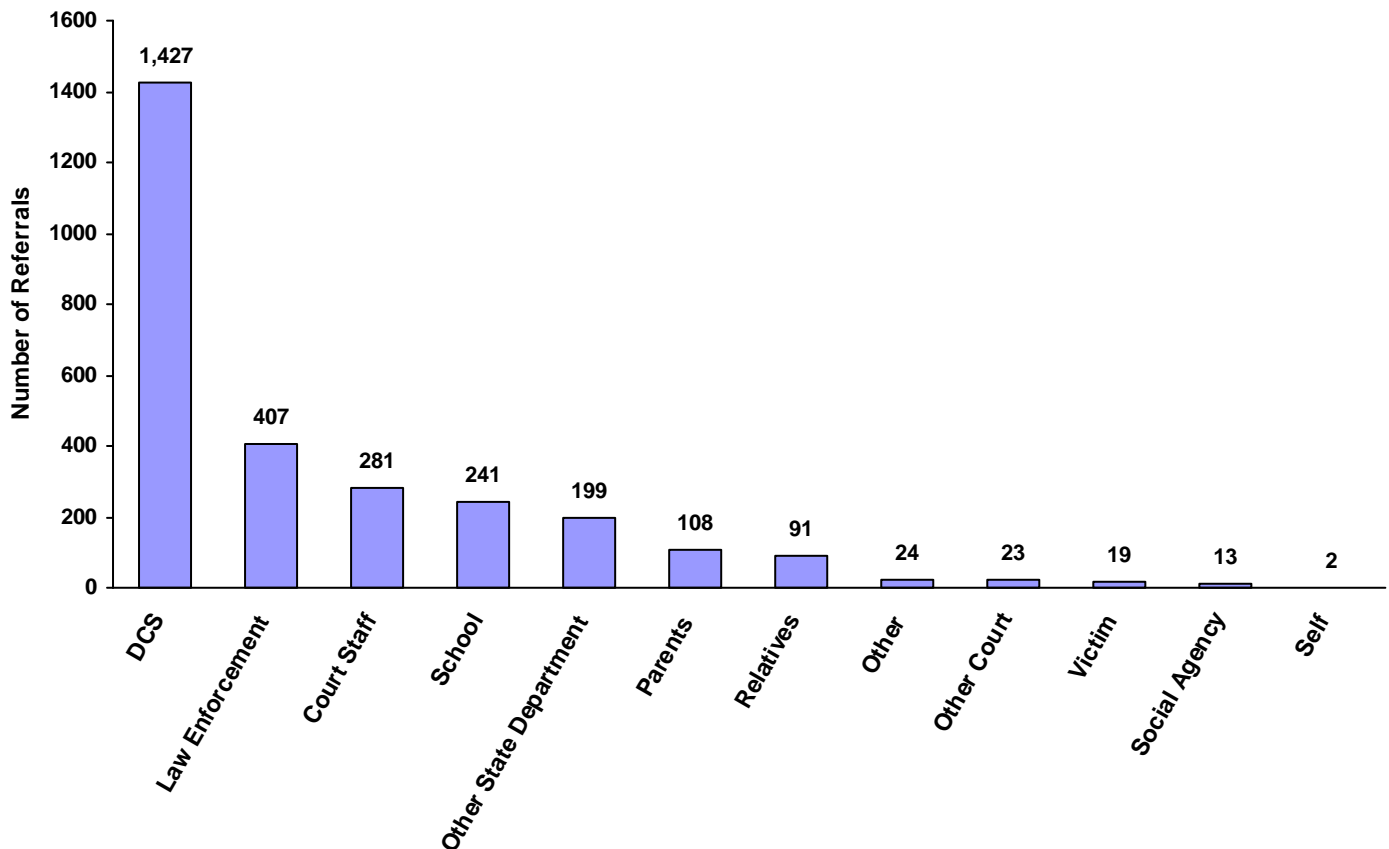

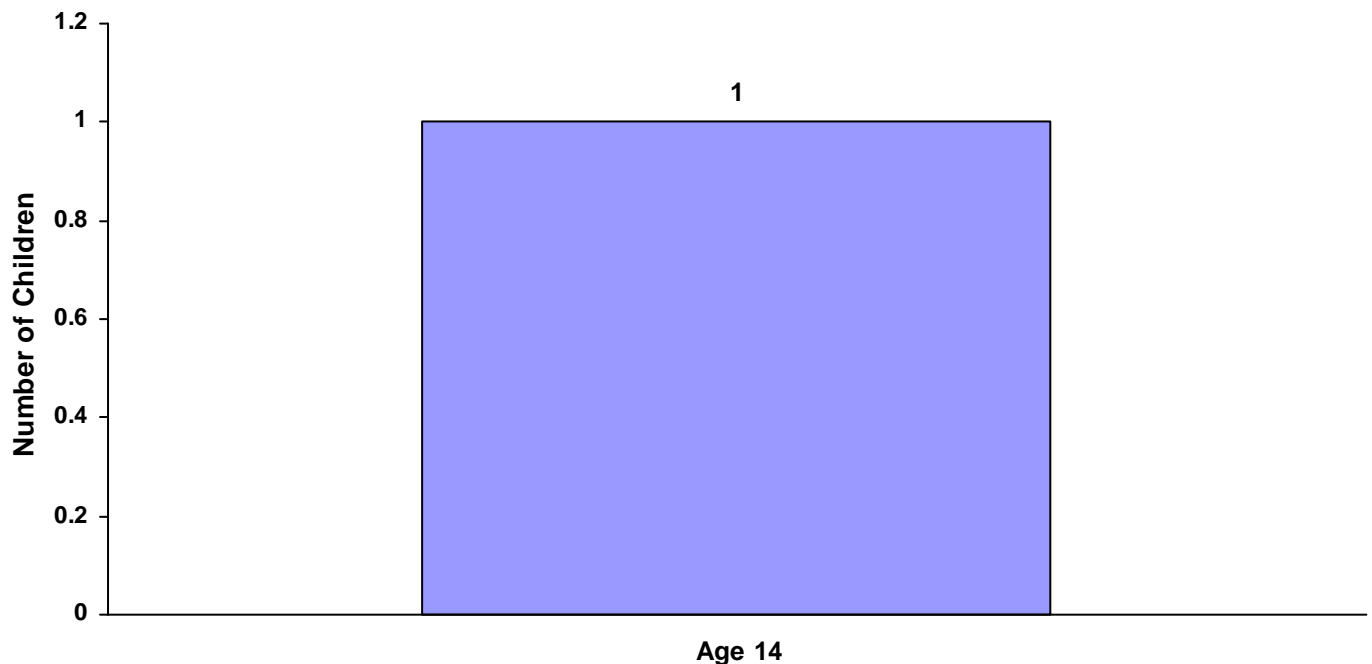

Total Children Referred for Unlawfully Carrying/Possessing Weapons



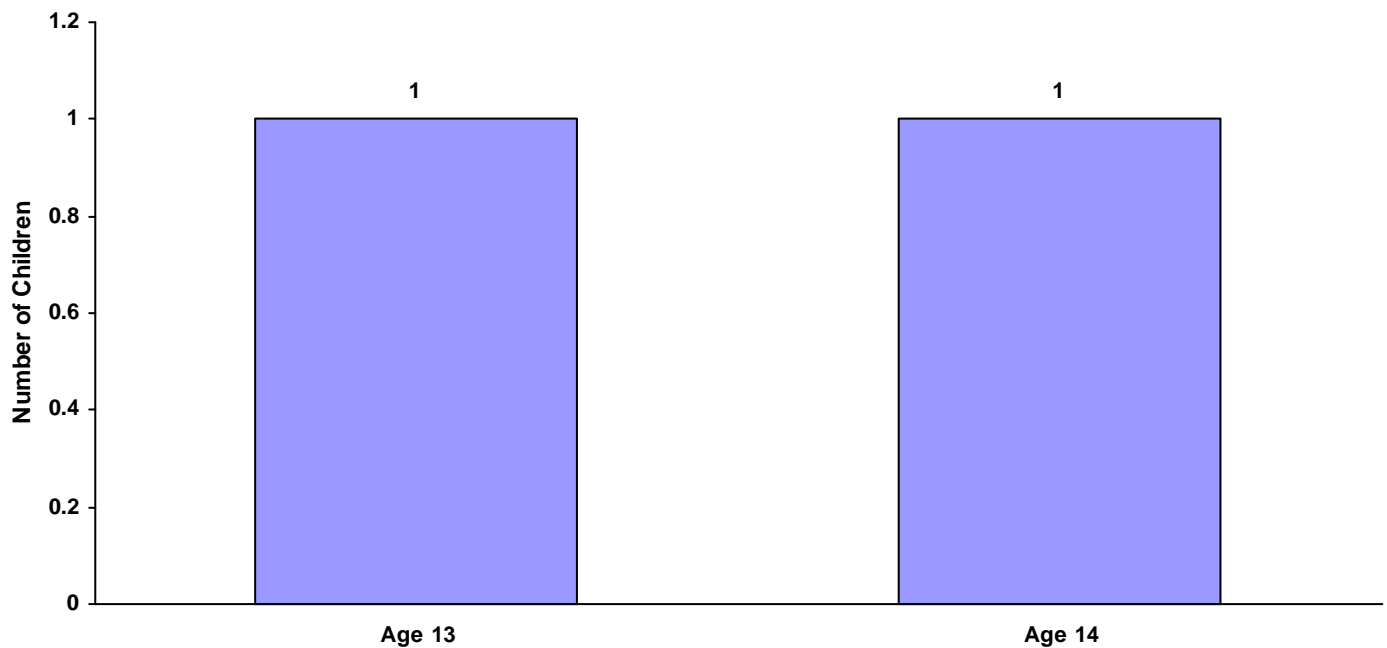

Total Children Referred for Carrying Weapons on School Property

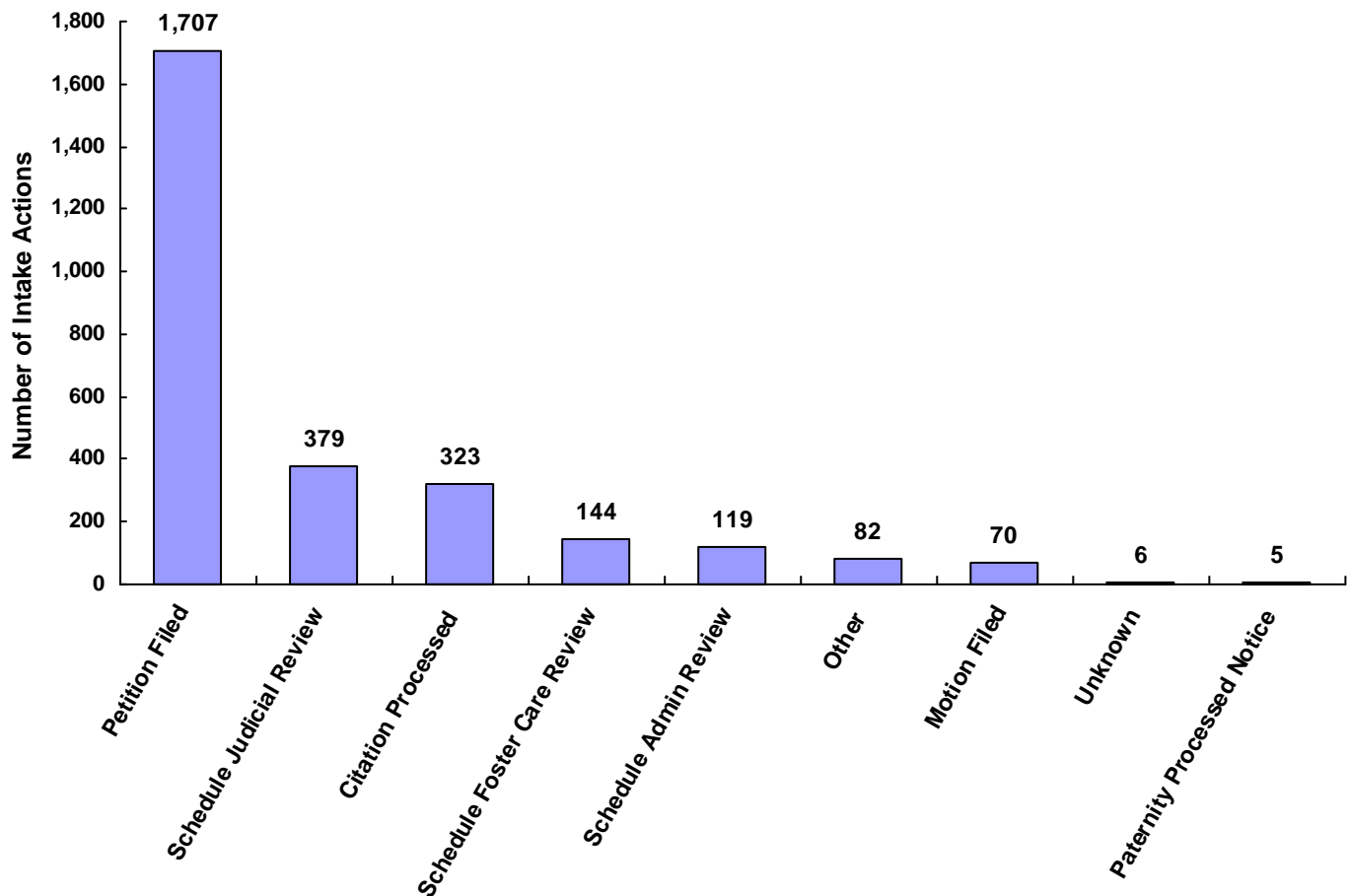

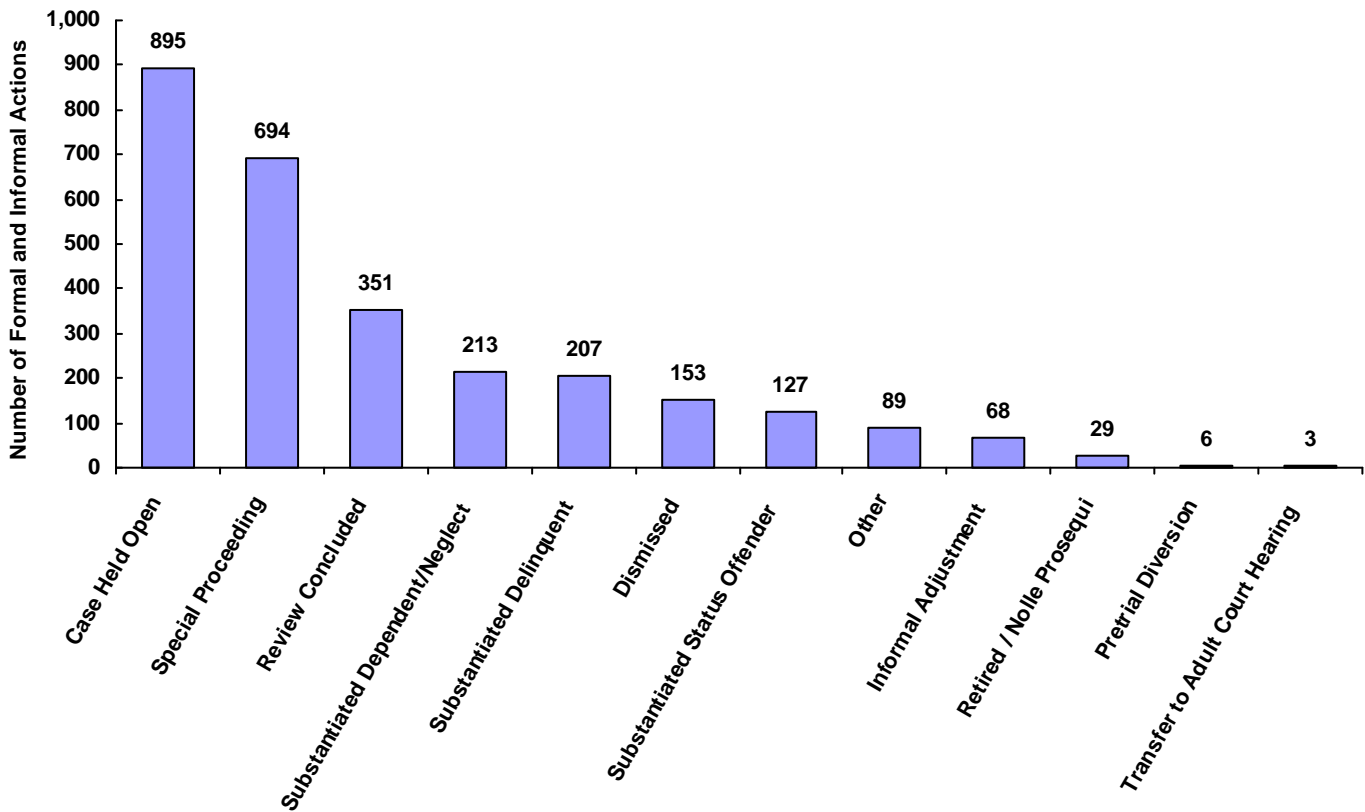

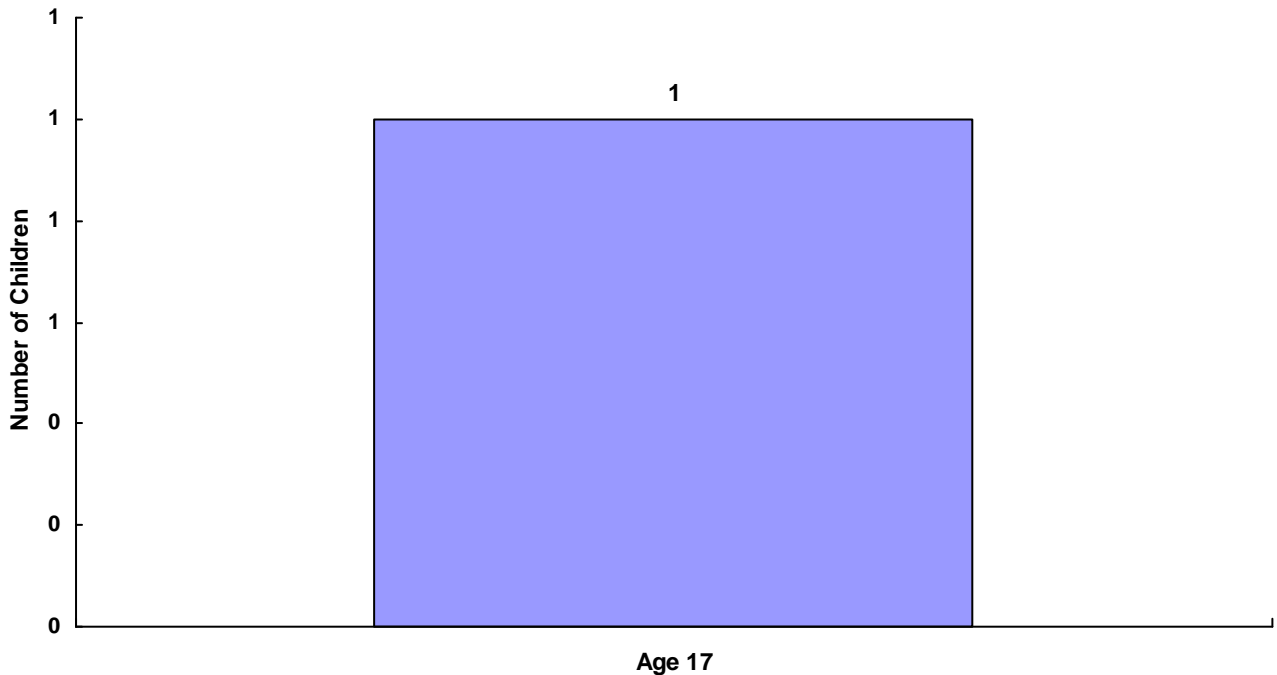

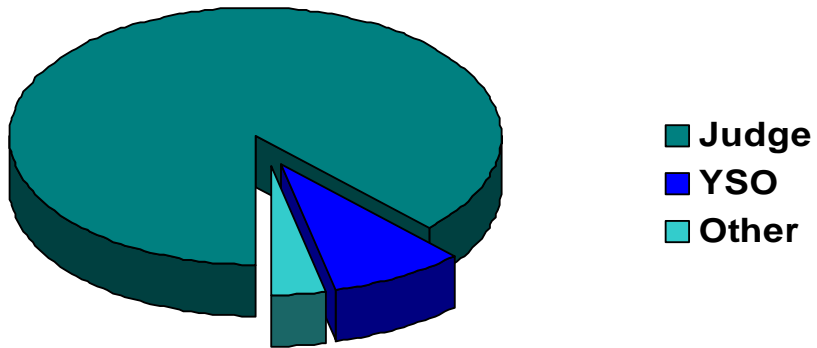
