Report to the Redistricting Task Force on the status of the Tennessee District Attorney Generals Conference efforts at redistricting and allocation of resources recommendations to date; including report of its Executive Committee Resolution --- (for the August 19, 2019 Meeting)

The Tennessee District Attorney General's Conference (DAGs), in response to a request from the Redistricting Task Force, formed a Redistricting Working Group at our annual business meeting in June whose chairman and members were appointed by the President at that time, Lisa Zavogiannis (31st McMinnville). She appointed Neal Pinkston (11th – Chattanooga) as chairman and three or more DAGs from each Grand Division, including DAGs Davidson, Helper and Johnson were included, along with other DAGs deemed to be in districts that may be perceived as under scrutiny for redistricting.

DAGs Davidson, Helper and Johnson made a group presentation on redistricting at the annual June meeting to the entire Conference. This presentation focused on the areas where we felt were at issue, including the "32nd/21st" District and we also explained the mandate to study allocation of DAG staff resource as part of this effort.

After sharing information gathered from within the DAG Conference Office, information provided by each individual DAG and information from the Task Force resources, the working group met in Nashville on Wednesday, July 31 for approximately six hours. We went over Chairman Forgety's areas of focus for each of the three grand divisions. The working group met again on Friday, August 9 and presented its findings and recommendation to the TNDAGC Executive Committee.

The working group could find no consensus of opinion on the need for changes in any area other than the conclusion that Williamson County should become a single county district given its exponential growth as a suburb county of Nashville and the apparent disconnect between Williamson County and the three other counties of the 21st District: Perry, Lewis and Hickman Counties. This disconnect (according to the testimony received by the Task Force at its public hearings, from legislators and legal and political leaders within the 'outlier' counties that Perry, Lewis and Hickman) exists because of cultural, geographical and political differences. Now that the three counties have their own 'designated trial judge', there appears to be no turning back from this arrangement coupled with the Senate already having unanimously passed a bill creating this 44,000 person, three county district – which will become the smallest district population-wise in the State. Therefore, Perry, Lewis and Hickman Counties should become the 32nd District and Williamson should remain as the 21st District.

The working group went further to recommend that the 21st district, because of its burgeoning growth, should keep its same resources, including all ADAs, VWCs, CIs, office manager and other support staff positions assigned to it, regardless of where those positions may be presently located. The working group set up positions for the new 32nd District as follows: 1 elected DAG, 3 ADAs, 2 VWCs, and office manager, a CI and two secretaries. The TNDAGC is working on a revised 'fiscal note' for the annual cost of these positions. This is in keeping with the size of the DAG office in the 29th District which also has approximately 44,000.

The working group noted that all three counties within the new 32nd District are projected to either lose or stay constant in their population

over the next decade or more. There was some concern about the district having only one trial judge do to conflicts with this judge hearing both domestic and criminal cases where parties may end up in both arenas, but assumed that the Legislature would make provision for the 21st judges to liberally interchange on conflict cases.

Having made the decision to create the three county, 44,000 person 32nd District the working group found that it would be counter-intuitive to work any further to create larger districts by combining smaller districts or moving counties out of larger districts to smaller districts. There is no benefit from a judicial economy standpoint or even for fiscal reasons. The disruption involved would be overwhelming to DAG offices, DTFs, child support offices, CACs, and victims whose cases are pending in courts, not to mention the citizenry and communities that have become used to the current arrangement of districts.

The working group also approved of Chairman Forgety's issue item for the 4th and 5th Judicial Districts to remove jurisdiction for the Chancellor from covering the 5th Judicial District and to move those Chancery Courty equity functions into the Circuit Courts of the 5th District for more judicial efficiency and to help alleviate somewhat the 'under judged' statistics in the 4th District. The working group noted that this move has no effect on the criminal justice system in either district.

The working group's proposal was passed unanimously by the TNDAGC Executive Committee later that day on August 9, 2019.

The aspect of allocation of DAG staff resources (outside of the recommendation for the staff in the 21st and 32nd) was left for a later

meeting until the Allocation Committee meets to develop numbers for each district based on the material developed through the redistricting process. The TNDAGC picked up two ADA positions after this legislative session that have not yet been assigned, as well as seven support staff positions. The Allocation Committee is in the process of taking 'applications' from the individual DAGs based on their individual office needs in order to determine how the positions will be assigned. The Allocation Committee will then go forward with recommending for the Task Force how many other positions are need statewide, after this review.

Dear Comptroller Wilson:

The District Attorneys continue to fulfill, to the best of their abilities, their Constitutional obligations to prosecute criminal offenses and provide basic services to victims. I am writing to provide information concerning the increasing caseload carried by Tennessee prosecutors. While TCA §16-2-513 may not require it, I am providing the best data we have in an effort to continue a meaningful discussion about our staffing needs.

We realize your office and other judicial agencies continue to search for reliable means to count and report case statistics, and that, since at least 1999, efforts have been underway to accomplish that goal. We are also painfully aware that District Attorneys' caseloads have steadily increased as the volume of filings has increased. While the data we have collected for general sessions courts is not as precise as we all want it to be, it clearly shows a very significant increase in the total number of cases. In 2000-2001, general sessions filings were reported at 686,397. The most recent data we have available, for 2017-2018, shows 1,147,719 filings, which is an increase of 461,322 or 67% and an increase of 68,350 or 6.3% over the previous year.

The Administrative Office of the Courts collects criminal filings and dispositions. In 2000-2001 there were 133,781 filings. The most recent data shows 155,311 filings, which is an increase of 21,530 or 16% and a decrease of 9% from the previous year. The increasing complexity of cases, the development of new technologies, and the increases in sentences mean that nearly all matters handled in criminal proceedings require more time and resources. An even bigger issue, that we have discussed, is these 155,311 matters represent only 12% of the criminal filings statewide, with the other 88% being handled in the general sessions courts.

The District Attorneys continue to seek help in addressing their ever-increasing caseload and continue to make progress in addressing dire prosecutor understaffing in many areas. We respectfully offer this information as our best effort to quantify the problem.

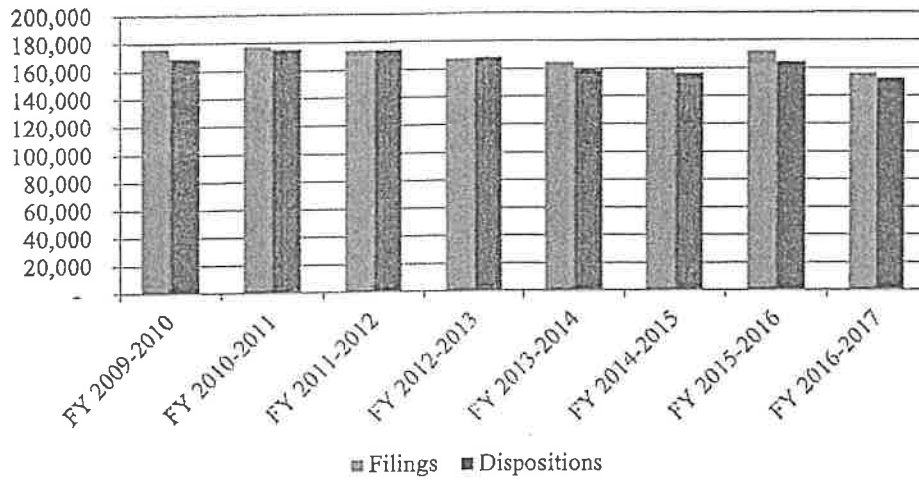
