## **ORDER**

Public Chapters 425, 426 and 461 of the Acts of 2013 amend Tennessee Code Annotated section 40-35-501 relative to the release eligibility percentages for persons convicted of certain offenses. It is necessary for the Court to amend the uniform judgment document attached to Tenn. Sup. Ct. R. 17 to reflect these statutory changes, which become effective on July 1, 2013.
